#### **MANAGER'S REPORT**

- In September I reported to you that the Township would be forced to discontinue electronic pickup for our residents due to the high cost of disposal of those items. Mr. Brevogel continued to push the County for a remedy to the expected doubling of the cost in 2016. The County has now provided a vendor that will take our electronic waste at no cost to the Township. We can therefore continue our electronic pick-up program.
- The Police Department is working with the clergy in the area to start a "Police Chaplin Program". Seven members of the clergy met with our Police Department to volunteer their services for the program. The clergy members will attend a training class and once completed will be available to our Police and citizens to assist with traumatic events. Events such as assisting family members when a fatally occurs, or counseling police officers when the officer request help. This program will benefit the Police Department as well as our citizens.
- Public Works has started a new process of crack sealing to extend the life of the roads in Town
  and to protect them from additional damage during the winter. This is a pilot program started in
  Buckingham Park.



#### **Public Comment**

Pat Lindsey-Harvey--Henderson Lane.

Ms. Harvey asked how many of the administrators on the salary ordinance are Willingboro residents. Ms. Harvey asked if the two individuals mentioned in the two ordinances read today are Willingboro residents. She also asked where the Township was in hiring head hunting firms that are supposed to come before the public in reference to the search for a new qualified Township Manager.

Martin Nock-- Windsor Lane.

Mr. Nock said that he was glad Council tabled the resolution 2015-137. He said that he does not think that outgoing administration should do anything until the new administration comes in. Mr. Nock said that since the Township is going forward in hiring a new Township Manager, he or she should go forward in hiring their own staff to some degree. Mr. Nock stated that if one is needed before the other, then it should be the responsibility of the Township Council to do the hiring. Mr. Nock said that he totally disagrees with resolution 2015-137 of appointing or hiring anybody. Mr. Nock said he has no problem at all with council hiring an interim person or acting person. He also mentioned that since he will be sitting on Council in January, he definitely wants to stay in this situation.

#### Harry Walker, Jr.--Eastgate Lane.

Mr. Walker congratulated the candidates for winning the election. He said that he was proud to see how the candidates handled the campaign on the last day. He said he was proud to see the candidates throughout the Township. Mr. Walker said that he also sees what the candidates for council deal with. He said that his phone has been ringing and he has been getting emails about things that Council has to deal with, and he does have a newfound respect for the position. Mr. Walker said that some of the things that he has been talking about, he still wants to see done. Mr. Walker said that regardless of whether he is on the dais or on the floor he still believes that there needs to be transparency. Mr. Walker said that some of the comments that Councilman Walker was responding to were when he asked about money that was being spent and where. He said that the community needs to know what is going on. Mr. Walker said that he is not trying to personally attack on Deputy Mayor Anderson because he is past the personal issues. He said that the community needs to know what is going on and it is not fair that they do not know what is happening, only rumors flowing in the background.

Mr. Walker said that his campaign was for the youth. He said that he did have a chance to speak with the Deputy Mayor whom he said told him that they would get together and figure out a way to get his ideas done. Mr. Walker said he wanted to offer his support and thanked Council and the public for listening to him and not taking anything personal and he looks forward to moving forward in a positive direction to make Willingboro the great town that it should be.

#### Jacqueline Mack--Maplewood Lane.

Ms. Mack said she wanted to follow up with what Mr. Walker said about making Willingboro beautiful. Ms. Mack thanked the Code Enforcement department for getting rid of a white

school bus that somebody had parked in their driveway that people thought they could live inside. She said she mentioned the situation at the Mayor's Forum. She said that they now have mowed the lawn, they moved the trash cans to the back of the house and they pick up the trash outside now.

Ms. Mack also mentioned a great effort at 81 Middlebury Lane and 1 Mayapple, both vacant properties where code enforcement and public works did a great job. She said that in looking at the house that she thought somebody might like that house because it looks pretty nice, and then when you walk around the block there is another house that still has trash there since June when the people were forced out of their home after six years of not paying a penny. Ms. Mack said that if the public would report more homes like this in the community to Mr. Brevogel of Public Works it would help a lot.

#### **Council Comment**

Councilwoman Jennings: I was not trying to shush anything up. I just think that when somebody throws out an accusation, it should be looked into. It is out of place, so I was not trying to quiet anything. I have asked that the solicitor handle it and look into it and it is going to be brought back. Nobody is trying to quiet anything down. But I also remember, I am sorry Mr. Walker (Councilman Walker) left, that he was supposed to sponsor the bowling party at the Jazz Festival and I do not think that a check came from Mr. Walker either. Incidentally I did one for the children's place at the Jazz Festival and there was a check from my election fund, so I think all of that should be looked into. I appreciate all of you coming out and I appreciate your support. Some of you, Mrs. Mack, you have been here ever since I have been here for every single meeting. I know you have missed a few, but it just seems like you have not. You are a staple, you, Mr. Johnson and other people. My friend Rita Owens has always been here. So, I just want to say we appreciate you continued support. Mr. Walker, I said good luck to you yesterday and that was your right to run. It is anybody's right to run, so thank you for what you have said is going to be your support.

Councilman Holley: I would like to thank everybody for the support. I look forward to my first full term here on Council. Over the next 4 years, I know that there is a lot of work that has to be done. I am definitely up for the challenge and I look forward to working with you all. I just appreciate the opportunity, once again, I have said Willingboro is my home born and raised. I am not going anywhere. I realize the challenge and the obstacles that we face and I look forward to trying my best to tackle them.

Deputy Mayor Anderson: I would like to thank everyone for coming out. As Councilwoman Jennings echoed, I would like to thank Mr. Walker for stirring up somewhat of a race coming out with his ideals of what he wanted to do. It was absolutely heard by us and it has been some time since there has been someone running against Council members. So I do appreciate what you came to Council with, you stood by. By putting your name in as a write in. I do know that you got about 130 votes on the write in, so I applaud you for that write in effort within two weeks. So we do appreciate that. I would like to congratulate the winning candidates, Councilwoman Jennings, Councilman Darvis Holley, and Councilman Elect Martin Nock. We know the Assembly candidates are Herb Conway and Troy Singleton retained their seats, but unfortunately we lost the two democratic freeholder seats. So, next year being the presidential (election) I believe there is one seat up, so what we need to do is get back at it for this presidential (election). Also I would like to congratulate Mr. Darvis Holley. At our last Council Meeting I did not have a chance to read New Jersey Politiker, but he was identified as one of the 50 most powerful young Afro Americans within the young democrats. So I just want to applaud him for that.

#### (Applause from all)

We had an opportunity to participate in the Mayor's Forum last Thursday, so I appreciate everyone who took time out on a Thursday to come out. We had our directors there; we were able to get questions answered the night of and also give reports. So I just want to thank all the directors for their participation. I had the opportunity to attend Ms. Reva Foster's senior holiday party. She must have had at least three hundred people at that party. So, once again, applaud Ms. Reva Foster. This coming Saturday there will be a shredding event from 9 A.M. to 1 P.M. It is being put on by the Burlington County Resource Recovery, and it will be at the resource recovery complex which is 22000 Burlington—Columbus Road in Florence right off of exit 52A. Also, there our own homegrown Willingboro resident Gregory Pardlo who was the Pulitzer Prize winner will be at the library this Saturday at 2:00 P.M. Thank you.

Councilwoman Jennings: Mayor, may I add something else to my comment?

Mayor Campbell: Go ahead.

Councilwoman Jennings: I am sorry, I forgot to announce or present that our own Deputy Mayor Nathaniel Anderson has been awarded the designation of South Jersey Magazine's Man of the Year, one of them, for 2105. I will show you the cover with Hugh Jackman on it. Nat is inside, and I think he represents us very well. He has won a plethora of awards this year and I just think that we should consider just giving him a standing ovation.

#### (Applause from the public)

Councilman Walker: I have not spoken yet. I want to say congratulations to the candidates for their victory. To Council, looking forward to the new addition. It is kind of, I do not know what the word is... I cannot find the word, but anyway it is a little difficult with Martin

coming in and Mr. Campbell going out. I know it is a couple of months premature, but here is a man who gives his time to this community, and he is going on to relax a little bit. So bittersweet, that is what it is, bittersweet. You know, with Martin coming in and Mr. Campbell going out. I'm just looking forward to 2016 and moving Willingboro forward. Just an announcement, a couple of months ago we honored James Green. He was the wrestler from Willingboro who is at University of Nebraska for his achievements, I think being just the second 4-time All American at University of Nebraska. He actually made the World Team and competed in the world competition and won a bronze medal. So I know it is self-explanatory, but I just want to break it down. The third best in the world, not just America, in the world. He actually lost the match because he slipped and when he slipped there was a little controversy where the referee ruled it a takedown, so he lost by I think 1 point. But that is a major, major accomplishment and he will be home around Christmas and he mentioned to me that he will be coming to Council meetings just to say thank you, because he greatly appreciates Willingboro acknowledging him. That is it. I do not want to go into the other...

Councilwoman Jennings: I have to go back again because I did not intend to skip over Martin, but he has been talking with me and working with me and working with all of us on a little team for so long it is like he is already a part of the Council. But I do want to congratulate him. I am really, really looking forward to him bringing unique ideas and he has so much energy and I just really think that things are going to be a little bit different with Martin and I look forward to it. I am telling you, he is bright, he campaigned so hard, he knocked on doors and he did things that many of the rest of us did not do all the time. But, he was on it 24/7. And also to young Darvis Holley who has proven to be just an excellent Council person and I look forward to continuing to work with him on the Council also.

Councilman Darvis Holley: One last comment that I also skipped over as well? I skipped over my running mates. I would like to congratulate Councilwoman Jennings on another term here with us and also Councilman Elect Martin Nock. We pretty much have been in contact and have already expressed our feelings to each other, but I just wanted to acknowledge them publicly. Thank you for everything, I appreciate it, you guys have been a great supporting cast and I look forward to working with you. I look forward to working with one another.

Mayor Campbell: Thank you Council for all the great remarks. I really like to thank the Council for the remarks that they have made. They were very, very good remarks. I am a little bit disappointed by the turnout for the Mayor's Forum. We had hardly much more at the forum than we have here tonight. Maybe twice as many as we have here tonight. The one thing that they told me whenever we said we were disappointed is that they did not get the word. They told me that they did not read the newspapers, and they do not listen to the radio, I guess. I guess they do not look at T.V., but we did announce the Mayor's Forum over a three week period. So, they're not being there was very disappointing because the people who needed to be at the forum were the ones who stayed home. We glad to furnish any and all remarks that were made and tell you what, when and where and what far. But, these people did not show up, so I am certain

when the incoming Mayor holds his next Mayor's Forum in January, they will all be there. You are going to have to do some robo-calls to get everybody there.

#### (Laughter from all)

It went off very well. I was pleased with what was there, who was there and what we had to say. There was more that could have been said, but I think that we told the people that were there what they came to hear for. The remarks in the Mayor's Forum is something that we were allowed to talk to you straight forth without having to go back and forth and have me wait a month or so to get the answer. Those are the kind I know you like. I would like to thank the Council for having put up with me for the year or so that I have been here. I joined this Council in 1998 when my first wife died, she was on the Council, and in office when she died. She always told me before she died that you will never make a person that can handle politics. She said you will never be a politician. I said you are right.

#### (Laughter from all)

I appreciated that. I learned a lot from her over the 15 years that she sat here in the Council and on the chair here. I learned quite much and I am pleased. I never thought that a good old country boy like me would ever sit where I am sitting. I just did not think it was conceivable. So the people that are here that have been on the Council, the people that are on the Council now and those prior to being, I want to thank you for giving the good old country boy a lesson. Maybe I can do some good things somewhere when I go. Next month at the next meeting I would be prepared to conduct the meeting if I were you. I wanted to let you know this is probably my last meeting, and I thank you so much for putting me here. We will not have another meeting this month. Next month I think we have got one or two.

Sarah Wooding: Yes sir. The next scheduled meeting will be December 1<sup>st</sup> and then of course the 3<sup>rd</sup> week of December.

Mayor Campbell: We have to go to Atlantic City for the League of Municipalities so we will not be here for the next meeting. So sayonara.

# TOWNSHIP OF WILLINGBORO ENGINEERING & INSPECTION STATUS REPORT

#### **NOVEMBER 2015**

#### MATTERS FOR GENERAL DISCUSSION & FOLLOW UP

- 1. Our office is currently working to revise the Road Opening Permit process and Ordinance. A "Draft" of the Road Opening Permit process and ordinance was provided to the Department of Public Works for review and comment.
- 2. The Department of Public Works is in the process of crack sealing various streets within Buckingham Park.
- 3. Our office is currently working with the Department of Public Works to investigate the various stromwater management areas and facilities throughout the Township to prepare regular required maintenance schedules as per the New Jersey Department of Environmental Protection "Stormwater Best Management Practices Manual".
- 4. We have prepared and provided the Township with a construction timeline for Charles Van Sciver Parkway. The timeline outlines the various road improvements that have been performed on the roadway since 2011 and plans for future improvements along the roadway.
- 5. Representatives from our office and the Director of Public Works met with PSE&G to discuss the utility repairs within Crestview Lane. PSE&G (gas division) is performing a capital improvement to replace the existing gas line the entire length of Crestview Lane. Installation of the new gas line and temporary restoration of the roadway should be completed in November 2015. Our office will coordinate with PSE&G for final pavement restoration which will take place in the Spring of 2016.

6. Our office has prepared GIS Mapping of areas along the Township municipal boundary indicating the location of existing street light poles within the right-of-way of various roadways. The mapping will be used to determine if the Township or a neighboring municipality is responsible for costs associated with energy usage and maintenance of the street lights. Our office is currently coordinating with PSE&G (electrical division) to obtain their mapping and pole numbers to ensure the various costs associated with the street lights are being billed to the correct party(s).

#### "STORM SEWER SYSTEM INVENTORY MAPPING" FOR MS4 COMPLIANCE

The intent of the project is to create a GIS infrastructure Mapping Database for the storm sewer system within the Township in accordance with State guidelines. <u>Our office</u> is currently working on the mapping database for the storm sewer outfalls. The project is approximately 30% to 40% complete.

# 53 PLACID LANE UNDERGROUND STORAGE TANK (UST) REMOVAL & RESTORATION

An underground heating oil tank was previously removed from the property and a soil investigation report prepared by Hydroscience, Inc. indicated additional remediation of the soil was required. The report proposed extensive excavation to remove contaminated soils. The Township requested our Licensed Site Remediation Professional (LSRP) review the report and provide remediation recommendations.

Our office reviewed the investigation report and determined the report did not comply with the New Jersey Department of Environmental Protection (NJDEP) requirements and the soil samples were below the residential soil remediation standards. Additional sampling and analysis is required to provide site investigation data consistent with the NJDEP requirements. Our office is preparing a cost proposal to perform the required sampling and analysis required. If the additional soil results confirm that the heating oil compounds meet the residential standards, then remediation of the soils will not be required.

# <u>DEPARTMENT OF PUBLIC WORKS ELECTRICAL MODIFICATIONS FOR A "STAND BY" GENERATOR CONNECTION</u>

The scope of the project is to retrofit the existing electrical panel in the Department of Public Works building to connect and operate the building with a 175kw generator during power outages. Preliminary engineering design has been performed for the project. At the direction from the Director of Public Works the project has been put on hold.
