Officer Michener's Efforts:

Interim Manager, Brevogel shared with everyone the heroic actions of Officer Michener. It appeared that Officer Michener was dispatched to 46 Peachfield Lane to a women in labor, and the delivery of the baby was imminent. Officer Michener arrived on scene and noted that the baby had already been exposed and the umbilical cord was wrapped around the baby's neck. Officer Michener took quick and decisive action and cut the umbilical cord from around the baby's neck to overt the chances of strangulation. He and a member of the Willingboro Emergency Squad were successful in delivering the baby without any complications. Office Michener later visited the baby at Virtua Hospital and reported the baby was doing fine.

Officer Michener also was involved in helping to assisted the Westampton Police Department along with Director Rucker to help find the missing one and half year old child which had been missing since January 12, 2016 at the Hampton Inn. Officer Michener and his canine dog were

quick to respond to the location. Officer Michener was commended by the Westampton Police Department for his performance in handling a potentially serious situation, which resulted in a successful outcome of finding the child unharmed.

Interim Manager Brevogel said that he will ask Director Rucker if Officer Michener would come to the next Council meeting so that Council and the residents can personally meeting him and congratulate his efforts as one of Willingboro’s finest.

He said that at the last meeting Council talked about Resolution 2016-23, which reference the Avery and the Phase III, which I had abstained, because I he had questions about why it was being passed without bringing Avery back to ask them about the issue around the construction of the commercial area, and he said he believed it was said that there was a final agreement, which the solicitor's office sent me. He said that he felt that everyone dropped the ball on the matter. Public Comment:

Mayor Anderson: Yes, this is the time of the meeting where the community will have an opportunity to come up to the microphone and voice their concerns. What we are asking, based on a vote that had been taken by Council, is that you limit your comments to 4 minutes. Thank you.

Harry Walker Jr.: Eastgate Lane. I guess I will go first. I thought from the last meeting that there was supposed to be two public comments for four minutes a piece. I do not know what happened to that. So what I had on here was: Number one, we talked about unifying the Council on the 1st of January, on the 4th there is a lawsuit filed. It has clearly divided this community as well as the Council from the previous meetings. Can we please understand why that is not going to divide this community as well as the Council?

Number two, Martin Nock at the last meeting was asking questions, and at a couple of meetings ago, about the jazz festival. Everybody made it seem like it was a petty thing, but if we do not start being wise stewards of our dollars I do not care if it is two pennies, then all of our money is going to be wasted. So we talk about the bid things, let us talk about the small things first.

Number three, the professional appointments, I was not there that meeting but I heard that it had to be rescinded. Why was that rescinded? So my question was, when it comes to campaign funds who are you guys getting money from? So are we going to get any type of notifications, is there a way we can request where you all are getting your money from, so we know how you all are spending this money and who you are appointing to these positions?

Number four, the economic developments committee in 2012, I just want to know, and when I was the chair why was that disbanded? The \$25,000.00 that was spent, where did that go? So is there going to be another corporation that is coming under our wings and we do not know about it?

Number five, the MUA; we have doubled appointments from the Township Council and the MUA. One member said that they were going to step down; the other one said that they were not going to take the check. You guys get paid here, that is fine, and it is not a lot of money. You get paid there too. So where is it that accountability to the Council? Are you saying that there is nobody in this room that is qualified to be on both positions?

Number six, wait I was not even on number six.

Number seven, at the last meeting there was an employee that was up here that I felt like he was on trial and he was being interrogated for something that had nothing to do with him, but was Council business. Do not bring our public employees into your business. If you guys have

questions about what you are doing up there and it has come back to the cellphone with the IT director, do not put him on trial. Answer your own

questions, have him state the policies and the policy clearly stated that you cannot use your cellphones for public use. Now if you go down to read a little bit more, it is kind of ambiguous where it says what you can use it for as data. But do not put our employees on the scene for your personal business. I do not know if my time is up but that is all that I have to say, thank you so much for your time again.

Sarah Holley: 9 Tioga Lane. I want to take this opportunity to apologize to Mayor Anderson. At the last meeting I incorrectly stated that I had not received an email notification for the Economic Development Committee. I did not receive an email directly from Mayor Anderson, but I did receive an email from Ms. Davis, and when I went back and did the search of my emails, I searched for Anderson and it was not there. I should have done a search for Davis. It was sent on January the 8th and I am big enough to admit that I made a mistake and please accept my most humble apologies.

Mayor Anderson: Thank you.

Thomas Floyd: 8 Buckingham Drive. I am representing concerned citizens of Buckingham Park. This is the first that I have heard outside; we spoke about this before about a four minute time limit on public comment. I have to say that I do not think that is a good idea. I know that Mayor Campbell said that he did not think that it was great either to do that to the public here on this side of the street. The idea that you had a vote amongst yourselves without even asking the public to comment on it makes me think maybe you think it would not pass if you asked the public what they think about the idea. A community that is made up of people who support their communities should not be limited when they talk about their community. If the five of you who are sitting in these seats do not want to share these thoughts and ideas with the very people that you are supposed to be serving, you do a disservice to the community itself. I do not know how it would go if you asked the public, it is just like when you wanted to change the name of the school. You did not ask the people, and my son was a graduate from the school. He had to find it on social media that you wanted to do it and he was an alumnus. Nobody contacted him. I do not think that is right. Now, I think that is something that you might want to talk with the citizens about and see what their thoughts are on a four minute limit. As I used to say to the people on the School Board, if you do not have the time for the job why take it? Because the citizens come here with passion and I always said people who serve us should have just as much passion as the people who live in this town, and four minutes sometimes is not enough for them to share how they feel about the community that they live and work in.

What I really wanted to talk about was about the blizzard. I think Inspections and Public Works and most of our public operations did pretty good. For the first time since I have lived here,

every car on my street was off of the street. When I talked to some of my neighbors who never move their cars, why they moved them, it was the way the robo call came. It was different from other robo-calls. So I think that we need to look at how we give information to people because what that robo-call said made these people who never moved their cars before move their cars. It was an outstanding job.

Inspections, we see a lot of private contractors in Buckingham and Hawthorne. Shoveling abandoned houses, sidewalks and driveways. We know they had to make some contacts, I talked to a couple of them, they said whoever the bank or whoever called them and told them to get out there and do this. So, my hats off for the public sector there that really did an outstanding job in getting the job done on a very difficult situation. A problem that I noticed is the fire hydrants. This was a lot of snow. I know years ago the fire hydrants use to have little arrows in the middle of the street pointing to where the hydrants were. I know that I am going to bring it up at a meeting of the Concerned Citizens because I found three fire hydrants in Buckingham Park that were totally covered with snow. They were at the ends of the streets and when the plows come down they just plowed across the street, piled it up, and now the fire hydrants disappeared and we did have a major fire in Buckingham Park and I do not think that they had a problem finding the hydrant because there was not a hydrant in that general area, but that could be a problem. I think that if the group would let me, that is something that we may do. Go around and identify where the hydrants are and put indicators on them so that if they get covered we will know where they are. I think that we can work on something like that together if that is something that us and the water company and public works can do. But I will bring it up at one of our meetings at Concerned Citizens of Buckingham Park about doing these things. I am checking on the fire hydrants.

Sarah Wooding: I am sorry, Mr. Floyd your time is up.

Thomas Floyd: Alright. Thank you very much.

Joanne Carter: **21 Norman Lane.** I feel a little silly coming up here and asking the two questions that I am asking because there probably is another level that I am not aware of that maybe I should take these questions to. But until I find out, I am going to bring them to you guys. The first question that I have is about the Kennedy Center. I do not know what the new name is, but, Kennedy Center. I see Ms. Cyrus here tonight. I would like to know if there are any guidelines for community residents on who pays, who does not pay, who rents free, who does not rent free, what offices are being occupied, are there guidelines? The reason I am asking is for two reasons. I do not know when it was, but probably the solicitor could help me. When the School Board gave Kennedy to the Township for \$1.00, I was School Board President at the time and I caught so much grief from the School Board for even initiating that. Mr. Holley was on the board with me, and we got it passed to give it to the Township for \$1.00. However, one

of the reasons that we did that was because there was also an ad-hoc committee, Mr. Holley was on the committee again, as an ad-hoc committee to try to get a Recreation Center for the town. So, when we did this, the purpose of passing Kennedy along was to have a vehicle that some of our residents could use free of charge if they had a meeting for an hour or two hours. I am bringing this up because my husband belongs to Willingboro Rotary, which is a very, very good organization that hands eight to ten scholarships to our children every year. They were meeting there for-- I believe, an hour or two hours and then they started getting bills for the time that they were there. So, I guess I am asking once again, are there organizations that meet at Kennedy Center free of charge and how do you determine that? How is it chosen, how do you pick and choose and so forth and so on? I would like to get that information. Because I know the intent of giving this school to the Township, and I do not think that it is really being fulfilled.

The second item that I have, before I say anything about it, I want everyone in this room to know these are not negative comments. I see Ms. Foster back there, Ms. Waite is not here tonight, but these are not negative comments about this paper. I think that it is a very, very good job. We all got this at our homes and I am very proud of it. I just have a little critiques of the paper. One of the things is, I would like to see it be more inclusive of everyone in this community, everyone. Now, those of you that know me know that I have a Day Care Center. After the Iowa caucus last night, I am saying to my parents, wow, Bernie Sanders did well. Bernie Sanders, who is Bernie Sanders? Why would they know a new Mayor from Westampton that is in our paper? Why would they care about a new Mayor from Westampton that is in our paper? I would love to see this paper highlight the departments in the community and give an exclusive to different departments so these young parents with children that cannot come to these meetings will know where to go. For example, I know and all of you know too, a lot of these young parents are struggling. They are struggling to stay in Willingboro, so if they have an issue of losing their homes or paying an electric bill or something would it not be nice for them to be able to go to this paper and say: Hey I just read a consumer alert or whatever, I am just making that up, and maybe this is where I can go to get some help. Or, I just read about the Inspections Department, I see Mr. Wallace here. Maybe I need to call them if my neighbors have fourteen cars out there that are parked. But we do not know if we are reading, no disrespect because we all love him, but if we are reading Jim Ayer's column we do not know what is in our community.

Sarah Wooding: I am sorry Ms. Carter your time is up.

Joanne Carter: Thank you.

Kimberly Davis: 3 Middlebury Lane. I know I am supposed to talk to you (Council), but I want to talk to the people as well. I want to introduce myself. I am the 2016 Willingboro School Board President. One of the things you will see...

You will see me coming out to the meetings. Several of my Board members are present. My Vice President is here this evening as well, Ms. Felicia Hopson. Gary is in the back, Ms. Sarah Holley; we want you to know that we are involved in the community. One of the things that is unique is we are seeing more people at the Township Council. We want to also see you come out to the school board. Unless we are 08046 invested, we need you to come out and share. So a couple of highlights; I will be bringing information during the meeting and my four minutes, which is a great idea because I am very long-winded.

Number one, yesterday we just had our first budget workshop, so we are starting our budget time. If you do not understand, budget time is when we shape and formulate how we are going to move our district forward to improve academic achievement in our schools. Our regular Board meeting coming up is this Monday the 8th at 7:00 P.M. Please come out. I personally invite each and every one of you to come out and see and be a part of moving our children forward. It takes a village. Our next budget workshop is going to be Saturday, February 13th. We use a Saturday at 9:00 A.M. in the morning in case people have long evenings, come out again and be a part of the things that we are working on. I will say last night was dynamic. We shared a lot of information, a lot came out with the small numbers that were there, so we are going to be working diligently and let you know we are involved. We are not a stand-off type Board; you will see us in the community. We are every engaging and we are real passionate in advocating for our children.

With that said, I have a question about the Township. With the blizzard, it snowed Friday and Saturday, Monday our school district was closed as a result of the inclement weather to give time for cleaning. On Tuesday we wound up having a two hour delayed opening. My concern about that is I happen to live on a street that houses our sixth grade and my back was burning by Monday to make sure we got my sidewalk and property clean. But when I drive down the street, everyone's property is not clean and that is a street in which the kids need to access. We are a primary walking district, so we need to focus. Where my concern comes in is, I come to find out that the neighbors were given until Thursday, mind you we sent our kids back to school on Tuesday, they were given until Thursday to have their property cleaned prior to any citation issuance. I have a concern about that because we need better communication. I was in touch with my Superintendent who was in touch with facilities and I think there was a line of miscommunication there. For example, at the one corner of Millbrook and Middlebury there is a crossing guard station. The poor young man had to stand in a shoveled out driveway. None of the corners were cleaned, so that he could not even direct the child to go from one sidewalk to the next. He had to direct he children to go from one side of the street to the other side of the street to continue walking in the street. That is a safety concern, especially when we are a primary walking district. So what I am asking for is better communication. If you are deciding to give residents relief until Thursday, let us know because we may have to delay our openings

as a result of that if you are not holding our neighbors to trying to get these sidewalks clean in a timely manner. Thank you and God Bless. Oh, and our meetings are at Country Club.

Dr. Crawford: Country Club Road. Good evening. First and foremost I want to give honor to God that is first in my life. I want to recognize Mayor Anderson, congratulations. I have been a resident here in Willingboro since 1970. That is approximately 45 years. I have served in the State Senate and the State Assembly simultaneously. It was a historic event, but never got any advertisement on that. So I served rather quietly. My point for getting up right now is one for safety, and let me also commend the public officials here, thank you for doing the job for us people here in Willingboro. I appreciate your services. I am up number one, because I see in Willingboro a lot of dogs running loose. I used to work out here. I am the guy that wears the gloves. I used to be a fighter. I was in the ring, so I do my little shadowboxing. I am not able to do that now because there are a lot of dogs out there and nobody is paying attention to it and they just run rampant from Rottweilers with the invisible fences to your Pitt Bulls. So I can handle myself being an Army Veteran, however, it is a fearful moment and I am soon to be a 60 year old man. I am not walking in the park and I am not walking in the neighborhood. Why? Because the people feel it is okay to let their big dogs run around with no leash. I would ask that you only-- as my friend Harry Walker said, pay attention to these little situations. Little things add up to big things.

Number two, I am very appalled, and I know it is human nature that we do not agree all of the time. However, as an adult and considered somewhat a community leader but at a low level. Also, I want to thank soon to be candidate Fred Lavern, Congressman, for appointing me as your Ambassador. So this is not for me to publicly advertise myself, but I have been appointed as an ambassador for Burlington County and surrounding areas to address issues and report directly to Congressman Lavern. But in closing, work together. I mean, we are all men and we have ladies. Everybody got a pair of knuckles, everybody has been done wrong, everybody has agendas, but I challenge you now. Somebody said, "I see new faces out there". I have always been there, but in a quiet way. I challenge you to cut the muck. Stand up and work together. Yes, this is a public thrashing because it does not make sense. Work together. I should not have to go to Medford and you will get the message, to see how they work together. Okay? In Princeton, they work together. They may not like each other but they work together for the good of the community. I thank you for taking public office, I commend you. But I challenge you to work together, thank you.

Felicia Hopson: 5 Heath Lane. I just wanted to come up because my madam president forgot to mention our State of the District. We are having State of the District Wednesday, February 17th at 6:30 PM at the Willingboro High School. So I challenge all of you to come out and hear about our local schools and hear about how good our students are really doing, to forget about the negativity that we constantly hear, we have a lot of good students and our students are

working very hard and so is our staff. We invite you to the State of the District so you can see what we see, and we want you to care and be invested just as much as we are

Pat Lindsey Harvey: Henderson Lane. I just want to know where we stand on the Township Manager search. It brought a question to mind, I think it was at the last meeting. I think that it was mentioned that an RFQ was going out for the search firm, which I still think that we do not need, but anyway. My question is what was the point of bringing the three companies in if you are now just putting out an RFQ? Would not the RFQ go out first and then you bring companies in to see what they offer? I am kind of confused. It just seems kind of backwards to me. So if someone could answer that question and where we are in the whole search process at this point? Thank you.

Sean Palmieri: My name is Sean Palmieri, I am a server, and I have a service, a process that is addressed to Mr. Christopher Walker.

Mayor Anderson: Are there any other public comments?

Tony 145 Tyler Drive. I know on Woodlane Road where they had the farm road, they extended the road because somebody got hit and that town got sued. Well, I live on Tyler. Tyler is a highway. I live the third house in from Twin Hills Drive and Comcast must have come to my house like ten times to fix the box because they hit it all the time. They decide to take Tyler instead of Rancocas because there are no cops on Tyler. So you all need to either put a speed bump or a cop, because my kids could go outside and get hit, the dog on the leash could get hit, because Tyler is really a highway. That is one.

Number two, I do not know how you all are going to work together, but, I cannot even say you all should work together because I do not know. Because everybody has their own agendas and everybody has their own things and their own reasons and everybody is who they are. But men are men and if you all can find a way, bury the hatchet. If you cannot find a way, I do not know. But Tyler is a highway and could you all do something. I also want to know how kids walk to school, because Tyler is the only street that I know in Willingboro without a sidewalk. If the kids get hit by a car, how do you explain that? Neither side of the street has a sidewalk. So if you are on the left side, you have to walk in the street. If you are on the right side, you have to walk in the street. So when do we decide to put a sidewalk or do we have to go through what they went through in Westampton? Thank you.

Mayor Anderson: Are there any additional public comments?

Charlotte Froman: 14 Hawley Place. Resident of Willingboro since 1964. Good evening gentlemen of the Township Council and I hope Jackie (Jennings) feels better. I want to thank the Mayor for coming out to neighborhood watch. The membership was very, very impressed with

your presentation and very happy that you did not come in with a bunch of hyperbole, but stood there and had the members have at you. They asked some very good questions in my opinion. To Public Works, I think they did a fantastic job on the leaves this year. I think that Mother Nature also played a big hand in that. Thank your men please Mr. Brevogel.

The snow was another issue in that we are back on the cul-de-sac. The snow comes down and gets pushed around to the bottom of the cul-de-sac and we are usually in for the duration. I was very upset because the neighbors beside me two doors and across the street and at the corner were given notices about snow needed to be removed off of the sidewalk. But what you have to understand is that we get extra snow there because the plows come down the cul-de-sac and drop off the snow. So I just think that common sense has to avail. Poor Mr. Slater, nobody would know that he is 88 years old. There is no way that anybody delivering a notice would know that he is 88 years old. What he saw at the bottom of the notice is that if the snow was not removed in such and such a time that there would be a lien put on his house. God love him. So he was out there chopping the ice that had come down, because he is on a corner house, so the wind brought more snow onto his sidewalk. Fortunately a young man came down to help him. Our snow blower did not work in this because my husband usually goes out at 8AM and goes down the street and down the sidewalk with the snow blower. But it did not work this time. In fact, even the sledding down the hill; the kids could not sled because the snow was not appropriate. On a very, very different note, it is nice also to know that the code enforcement officers are doing their job, but I think a little consideration needs to be understood too.

I have noticed that when people come in to pay their taxes and they come in the back, that they come huffing and puffing down the sidewalk there. Do you think we could get a chair or two as you come in the door by the elevator across from it or beside it for people to rest just for a few minutes to get their bearings before they get the elevator.

From the Police Department, I would like to know just how many tickets were given to cars that were left on the street.

Director Rucker: 65.

Charlotte Froman: That is a nice number.

That is Mr. Rucker. I am just yanking his chain. 65? That is a half-decent number. I did notice that at the last snow there were 2 cars on Harrington Circle that were there for years, and at the last snow they were removed. They fire hydrants, an eagle scout came through a few years ago and he had a pole with a red flag on it to identify all the fireplugs. I have not seen them for a while, so they need to be replaced. Very quickly, for the jazz festival, I would like to see less money spent and that money that comes in, I would really like to see some of that money spent

to help people pay for their gas and electric and even for the use of possibility saving their homes.

Clerk: I am sorry Ms. Froman your time is up.

Charlotte Froman: Not a problem. Thank you.

Bill Carter: 21 Norma Lane. This is directed to Mr. Rucker. Whenever we have a situation that just happened is there a way instead of embarrassing an individual that this can be done in a back room downstairs in your area instead of having someone out of town come to deliver some type of notification, because right now it is embarrassing for the whole town, not just the individual who received this information, but for the whole town?

If we had someone from the news here this would be plastered all in the paper the next morning about how a city official was served papers. It makes no sense. We should be bigger than that to do this here where everyone does not know what is going on. This is a personal matter that could be handled in other ways. Again, as a resident of Willingboro we should not have to see this in the paper the next day or for the next week. Thank you.

Michael Armstrong (Township Solicitor) Let me just say this, that it was inappropriate and it was not the right place and time during public comment is for public comment. It is not to serve papers on anyone. So the individual clearly took advantage of the opportunity to come up. I had no idea that it was occurring.

Bill Carter: If that was the case, then why did you not stop him right then and there?

Michael Armstrong: I did not even know it until it was done. I do not think that anyone knew he was going to be served. Nobody knew who he was. In fact, my head was turned talking, I had no idea when I turned around what was going on until somebody explained it to me. I think that is the point, I think the point was to catch the person with the element of surprise and of guard so they can be served. But it was certainly an inappropriate time and if we would have been aware of it...you cannot use public comment as an opportunity. Now he is able to serve him in public, we cannot stop that. But this was an inappropriate time and place to do so. I mean, he is here, he could have caught him on the way out, did whatever he had to do. I agree with everyone that it was an inappropriate time and public comment is not used for that and it was clear to me that it was used for grandstanding more than anything else.

Thomas Floyd: Seeing how there is a lot of inappropriate going on, I would like to see how this public comment is going to work. With this vote on the 4 minutes, seeing how certain things happened tonight that should not happen in public comment. This is a community that needs to come together and things like this should not happen. So, I would like maybe, I do not know-- put it on the website or give everybody or every household information on how public comment

is going to go forth from this point on. Do you get a second time to come back up here? Is four minutes going to be limited to Council Members as well? We do not know anything about how this is going to be done. So please, we would like as a public to be able to understand exactly how public comment is going to go forth from this moment forward.

Councilman Nock: I was going to explain it when it came to my time.

Michael Armstrong: We will clarify it.

Councilman Nock: We will clarify.

Charlotte Froman: I have already had my four minutes, but let us say I needed four more minutes...

Councilman Nock: We will talk...

Charlotte Froman: But listen to what I have to say please, sir. Thank you. Can somebody give me their four minutes?

(Crosstalk)

Mayor Anderson: Can we please have order in the courtroom?

Sarah Holley: At the school board, every public speaker can come up. They have four minutes to speak. You can only come up once. Once you use your four minutes that is it. You cannot yield time to another speaker. That is it, four minutes and you are done. We have a timer. Once the timer buzzer goes off, that is it. Mr. Floyd knows how it works. We do not give more time because it extends the time of the meeting. So it kind of forces speakers when they come up, you can pretty much be prepared, write your notes down, four minutes. We do not allow yield time. But you (Mr. Floyd) know how it works.

Kimberly Davis: Can we advocate that one of the attractions this year be bringing back our Willingboro Jazz Band? Let me tell you something, we can be our worst negative. If we do not start advocating for our people, if we do not change our perception of who we are and who we are raising we are not going to have anybody to blame but ourselves. My children have graduated from Willingboro, my son is in his third year of college and my daughter is in high school now. Let me mark words, this year's president's daughter goes to Willingboro High School. This year's vice president is a son as a senior at Willingboro High School. How more invested can you get than the leadership, being passionate and we are invested. We put our money where our mouth is. Is it perfect? No. Is there room for growth? Yes there is. Can I say everything is paved in gold? Never will I say that. Okay? But whoever is perfect in here, you need to be sitting up high with him. Because no one in here is perfect including myself, but what I would like is to for us to embrace our people, embrace our children. We have a phenomenal

marching band that has gone down to Howard, has marched for the President's inaugural parade. We need to have them invited out there. Before we spend all the big monies to have everybody else, can we enjoy our children? We have an orchestra band as well. We need to sit here and invite our babies to come out and shine. That is all I want to ask. But I will be back to advocate for our children. Thank you.

Mayor Anderson: Last call for public comments.

Thomas Clarke: Express Lane. I just have one question. Mr. Walker, I apologize for what was said tonight towards you. I do not think it was meant for this venue. However, I do have a question for you. Back in November or October you indicated that you were going to relinquish your seat at the WMUA effective the end of the year. I would like to find out, did you do that and if not why not? Thank you.

Deputy Mayor Walker: Mr. Clark, I appreciate your comments. What I said in November 2015 is that in 2016 I would be stepping down off of the MUA. I did not say at the end of 2016. I did not say, because I got a call from Mr. Walker (Harry), no relation, who got up and asked the same question. He made a statement, he said to me that I said I would step down in January 2016 which I did not. I said in 2016. So, we are finishing some things, finalizing some things with the MUA and during the year of 2016 I will be stepping down from my position at the MUA.

Mayor Anderson: Public Comments are closed. Are there Council Comments?

Council Comments:

Councilman Nock: Yes. There are several things I want to say to everyone. First of all, I want to say it is good to see everyone come out. It is good because it is quite different that when I have attended some of these sessions and there have been about five or six people. I do not believe-- Charlotte and Mr. Floyd, you were here. I made a suggestion for a policy change to...over the last three or four months before I took office, I was visiting other towns and the township councils. As you know, I was really involved with Freeholders about the Centerton Bridge. I was sending out all the emails to everybody that was on my email list. I was thoroughly impressed with what some of the towns were doing. They had these two public comments. They had one public comment on agenda items only. So you would come up, because now we vote on things and at the end after the agendas were, and then you have public

comment; so some of the towns that I was visiting had two public comments. One was for agenda items and then a general public comment. I was informed and our law firm showed me that you cannot do that. Even though the other towns were sort of breaking the law, you could not do that. So, tonight it came up and I said well, since the first public comment is not on the agenda we will wait to the next meeting. The two public comments that I had proposed were four minutes each, so that kind of made everybody get eight minutes, if that is what you wanted. So, that is how that came about. But, we are going to talk about and figure out how we can work it out, because our law firm feels; and they are right, when I read the statute, that you cannot do it. I just do not know how these other towns are doing it. But they are doing it. So that is one item.

The other thing that I want to talk about is, that right now until February 11, 2016 if you are interested in any of the boards and commissions you still can put your name in. Last time I ran off the number of people that have applied for each of the boards and commissions which I think is good. Some of them have 7 or 8 people. So there is going to be a big decision we have to make on the twelfth, deciding who are on the boards and commissions. I am glad people are interested in doing that. On February 6th 2016 and I believe February 11, 2016 we are going to be doing interviews of our professionals, which is a change. It has not been done, I believe, since I have been here. It maybe has and I missed it, but that is a change. As to the MUA, and I have stated this to many people, I think that if Council people are going to sit on there....or Council people should not sit on there. But, we definitely need a liaison to the MUA. The MUA in my opinion is the one asset that we have that can really move forward within this community and bring people back in here. I have been working on a project for 18 month-- Smart Cities to do with our lighting, do something with our security and try to get this town free WIFI. I was doing this before I got on here. The best entity to do that is the MUA.

The second part of the MUA things that I am going to propose to them in couple of weeks is an appliance type of program that we are eligible for as a town. Why can we not, when we are trying to move these homes, when we are trying to get people to buy in here, why can we not have some incentives and perks for our residents to come into this town? So, I say all this to say that I am one of the people saying unless all Council people get off of the MUA, then there should not be pressure on just one person to get off of the MUA. We have 2 people now on MUA and if the decision is going to be made then the both should come off at the same time. That is my opinion, and I have told Mr. Walker I think you made a mistake saying that because we definitely need a liaison. You also know if you have been reading the paper that Evesham has been trying to dissolve its MUA which was created at the same time we had ours. I am not in favor of that because I think it is a great asset. But they have been trying to dissolve it and they are talking about how much money they are going to be saving through the back end of operations through dollars that they do not have to put out for bonds and everything else. I believe it is a great asset. On my own I have gone down to conferences about what water sewage

MUA's authorities can do for our town and ours is so underutilized. But before you do anything, we have got to get their business together. If you look at their audits it is shameful. Shameful, when you look at their audits and everything that is going on at the MUA; not keeping the books and all that kind of stuff properly. So all I am saying is, and this is public, I see Mr. Evans raised his hand, but this is public.

Webster Evans: Inaudible.

Mayor Anderson: Mr. Evans, Councilman Nock has the floor. Public Comments are now closed.

Councilman Nock: All you have to do is go pull the audits for the last 3 years and look at the audits for the MUA. I do not have to sit here and tell you, I pulled them and I read them. The bottom line is, things have improved, things have moved forward. That was prior. The leadership the last couple of years has been good. I am saying to you that the MUA is the one entity that we have to make a difference in this town that you can move and do things. I have stated that and I have stated that on the campaign trail. So I have not changed my opinion on it. If one Council person, all Council people should be off or you make it so at least one person is a liaison to that. I think that is probably all I am going to say this evening about that, but I appreciate everybody and people have come up and asked me questions and said things to me afterwards. I want you to know I made promises. My promises were I was going to look and read material given to me, I was going to make sure this stuff added up, I was going to make sure that I was an advocate for making sure the homes are not foreclosed on, try to lessen that and do whatever I can to make sure that Willingboro is or was like I moved here 30 years ago. That is the only agenda that I have. I am going to end there but I am going to tell you that I am working and, as you well know, for 18 months before I got on here trying to do something for this community.

Councilman Holley: Good evening, I would like to start off by thanking everyone for coming out tonight. In regards to Mr. Floyd, as Mr. Nock expressed, we did agree to have two timeslots for public comment which was a total of four minutes each which totals to eight.

I would like to also express gratitude to Mr. Brevogel and the Public Works Department for the hard work that they put in during the blizzard. That was a lot of snow. Trust me, I know. I helped shovel a few people out and you guys were very diligent and very efficient with the removal of the snow, so thank you for that.

To piggy back onto what Mr. Nock expressed, while the boards and commissions have open enrollment until February 12, 2016. As always, that is not closed after February 12, 2016, if you want to apply for a board and commission you can always do so. Whoever applies your names and applications are kept on file, so that is not just limited to any particular time period. You can

always apply. We are always looking for people to help serve on the committees. I'm looking forward to actually interviewing the professionals, this will be the first time in the two years that I am approaching on Council where we are interviewing the professionals, so, I look forward to that. I look forward to seeing what each professional can bring to our community and seeing who is the best fit for Willingboro. That is it that is all I have to say.

Once again, I have given the title of Martin Luther King of the Council by some of my colleagues, but, I am still challenging them to make sure we are doing what we are supposed to do to move things forward. You know, we do not have to be the best of friends but at the end of the day we do have to do what is right to make sure that we are doing what we are supposed to do for our residents. Like I said, as you know, I was born and raised in Willingboro so that is where my heart is; making sure that somebody is watching over the town and that is what we need to do.

Deputy Mayor Walker: I want to start off by thanking Mr. Carter for your comments. They are greatly appreciated. I want to make something clear though. I am not embarrassed at all. I was raised by a strong man who raised me to be strong and he told me that life would not be easy and I do not expect it to be easy. I know that at times we are going to face some challenges and the true test of a man is how you stand up and face those challenges. I run away from nothing. This is not an attack against anybody, do what you have to do; for whatever reason you feel like you need to do it. But I read the newspaper after someone called me and told me about it and I was like oh okay. It did not bother me until seven o'clock that evening when my daughter called me as she was bothered by it. But at the end of the conversation and after she said, "dad, don't quit, don't walk away". She said on this day that we are celebrating Dr. King; she said that you can go through this town and walk down a street that you were instrumental in changing in his honor. So it was meant to hit the paper that day. I am grateful that it hit that day because it reminded me of where my focus should be. That focus is about working for this community and I know I work hard. Not perfect. Without getting into details I will say this. It is all a lie. So I am not going to run away from it; just like I did not run away last year when this same room was stacked with about 25 people calling me out of my name. I said then you can call me what you want to a certain extent. You can say what you want but you do not know me. It is not true. Let the investigation be had, make it the most thorough and efficient investigation that has ever been conducted in Willingboro. I went and sat and spoke with the Safety Director, I said to him-- I am running from nothing. Make sure you put the best person on it and leave no stone unturned and let us see what happens. It cleared me. The judge told me I had grounds to file for damages. I chose not to, because I was not going to keep this thing going. Even when it happened I was not going to address it from here, because I was told before by a member of the public do not bring this into here. Yet, we can be ridiculed and everything and I guess it comes with the territory. You can get up to that microphone and say things that are not true, make false accusations and do whatever you do thinking that they are

going to stick and you know they are not true. It is okay. When I ended the conversation with my daughter the thing that got me and gave me a sense of calm, she sent me a text from 2 Corinthians: 1-7. It said he did not give you a spirit of fear he gave you a spirit of power and love. I do not fear anybody. I do not fear a processor, I do not fear what is in that envelope, I do not fear what is in the paper, and I do not fear what no one says. I do not fear people recording what I am saying to put it on social media thinking that I am going to be embarrassed then, I am a strong man. I was told by somebody out here that I was arrogant. I think you got that confused. I am confident and I am strong always in the face of anything. If you are bothered by me going into this long dissertation I will say what is not politically correct. I do not care. I appreciate those who support me. The number of calls of encouragement and support far outweighed the number of calls and recordings of criticism. They go hand in hand, but one greatly outweighs the other. There are individuals in this room right now who know me. Not Councilman Walker, not Deputy Mayor Walker, they know Chris Walker. They know my heart. They know my character. What I do know is when they see stuff like this it bothers them because they know that is not me and I am good with that. So again, I appreciate what you said Bill Carter, I really do. I am not embarrassed. The only way I could be embarrassed is if that was true and I should be embarrassed by my actions. I do not let a court or anybody determine who I am. They cannot judge me. So I will end it with this. Somewhere I read: No weapon formed against me shall prosper.

Harry Walker: Inaudible

Mayor Anderson: Mr. Harry Walker.

Deputy Walker: I am not even worried about that.

Harry Walker: Inaudible

Mayor Anderson: Mr. Harry Walker, as a resident please let us keep this courtroom in order. Deputy Mayor is speaking.

Deputy Mayor Walker: I am done.

Mayor Anderson: Alright, good evening everyone. As it has already been echoed it is a beautiful sight to see the courtroom filled. This is what we have been asking for, this is what we need and we want to continue to have new faces in this audience. I want to begin by thanking public works for an outstanding job that they did during the storm. Understanding the speed that the snow was coming down, it really doubled and tripled their work. With the manpower that they had, understanding that after so many hours they need to take a break. But during that break the snow did not take a break. So with everything, the challenges, it was a great, great job well done. We still had some concerns with cars still being parked on the street.

So we talk about it over and over and speaking with the Township Manager he was going to speak with the Safety Director. We have a tow truck company in place as you saw in tonight's resolution. We are really going to have to stand behind what we say on that robo-call because it impedes their work from getting done. So this is what we are going to do to enforce what is already on our books. I would like to also acknowledge Commander Larry Williams from the VFW Post 4914. Thank you for being here.

No matter what happens personally, and I like said I cannot talk about it because it is being handled. But, what happened this evening was absolutely unacceptable; and as a unified Council that I spoke about on the January 1, 2016, and as did Mr. Walker. I initiated this back in late October, November. So what happened is the papers just got held up in January, but it was already initiated. So that is all I can say to that. It just so happens, it went public on that date. So, the effort to have a unified Council, what goes on personal is personal. That is why it is being handled by the legal system. As far as Deputy Mayor Walker, myself, Councilman Holley, Councilman Nock and Councilwoman Jennings working together for the betterment of this community that is my commitment; and we saw that on Reorg Day. I supported his nomination for Deputy Mayor. So please do not get it confused, because you see a personal issue. It is not going to affect what we have to do here. From this day, it is about you the residents and I just wanted to be clear.

We do have a budget meeting on February 10, 2016 which will be held at 6:00 P.M., is that correct Clerk?

Sarah Wooding: It is "to be announced" right now.

Richard Brevogel: If I could interject, due the fact that the Council and the Mayor are going to go through the process of interviewing as well as soliciting additional quotes for the Auditor, the Auditor instrumental in helping us develop and put together the information required to develop the budget for this year. The State has also sent out an Local Finance Notice which has delayed the actual introduction date, so we have a window. But we will not be prepared on the 10th of February to have a conversation regarding the budget until the issue of who the auditor is going to be is resolved, because we need information from them to help us get all our information together to develop a skeleton budget to present to Council and the public. So, I would at this point say that that meeting is going to be cancelled, but again, I will speak with the Clerk and do what we need to do protocol wise to make people aware of that.

Sarah Wooding: Therefore, it is cancelled sir, and it will be advertised in the newspaper.

Mayor Anderson: Thank you. Thank you for the correction. Alright, in regards to some of the concerns that Ms. Davis spoke about, we actually communicated during the storm. In regards to the sidewalks, what I found out from the Township was that we have an abundance of

vacant properties which is no secret. So what happens is those sidewalks do not get cleared. So it is my understanding it is our job as municipalities to inform these banks. We call them and also have to send them mail that they have 48 hours from the time of receiving that mail to get those properties cleared. What happens then is if they do not respond within that timeframe the Township will go ahead and take care of it and place a lien on that property. The conversations that are currently being had to better prepare for next time is possibly looking at some additional vendors outside that we can bring in to help out. But that is the process, so now we notice that there are a lot of sidewalks that were not done. We are looking to work towards making sure that we are better prepared at what we do, but the standard process has been the banks that own those properties are allowed 48 hours from the time that they actually receive that communication at which time we take action.

So, as I said, based on the massive storm we had it was really something we could have gotten to if once the guys made a pass we were good to go. But they were making two and three passes and it was like nothing was done.

Another question that was addressed to me was Beverly Rancocas in regards to how come it was not all the way down to blacktop and so forth. Well, it is my understanding that once the roads are passed, we make sure we do all passes with the plows before we salt, because if not, all we are doing is pushing the salt to the side of the road. I got a lot of concerns about some of the side streets. It is my understanding that we salt the main streets and the secondary streets. There are about 400 plus streets in Willingboro. We cannot salt all 400 streets because now what happens is you have a salt budget, you got the manpower, plus we would need additional equipment. So we are looking closely at \$350,000.00 plus if we were to do that every storm, so that is some of the reasoning when you see that streets have not been plowed or you do not think that they have been plowed because you do not see the bottom. There is no salt applied, so then what we do there is do the best job we can with the plows that we have because we have to be mindful the way we use the salt, because we do not want to get into a situation like a couple of years ago, where we were not able to get salt, so we just have to be mindful. But, that is what was explained to me, so I just wanted to share that with you the residents.

In regards to Ms. Pat Lindsey Harvey, you asked about the three firms coming in. As we had discussions as to what our needs would be, some word got out that we were looking, they sent in some communication that they wanted to speak with us, but the purpose for them was to listen to what they had to say to see what they had to offer. It is something we would need to make a better decision whether to go out for search firms. So since that presentation there was a lot of relevant information that we thought would be useful. There ultimately, the decision was made to go out for an RFQ (Request for Qualifications). So that is why there was a delay. But an RFQ has gone out. That is it for me for Council Comments, once again, I would like to thank you for coming out, we did vote to go into executive session, I am not sure if we will be voting

on anything but please feel free to hang around or you may take the option and leave. Thank you.

Harry Walker Jr.: Excuse me; while everyone is here I would just like to apologize. That going back and forth with Councilman Walker, that was really unnecessary and was not beholding of what I stand for with Willingboro. But at the same time, I am not going to let somebody up there make me feel like they are above me or they can intimidate me or anything else like that and the rest of the community should not let them do that either.


Mayor Anderson: Mr. Walker, you cannot take the microphone like that.
