Ordinance 2017-2 (PUBLIC HEARING)

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A:4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A:4-45.15a provides that a municipality may, when authorized by ordinance appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations, in either of the next two succeeding years; and

WHEREAS, the Township Council of the Township of Willingboro in the County of Burlington finds it advisable and necessary to increase its CY 2008 budget by up to 3.5% over the previous year's final appropriation, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Willingboro Township Council hereby determines that a 1.0% increase in the budget for said year, amounting to \$1,160,120.15 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Willingboro Township Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Willingboro, in the County of Burlington, a majority of the full authorized membership of this governing body affirmatively concurring that, in the CY 2008 budget year, the final appropriation of the Township of Willingboro shall be in accordance with this ordinance and N.J.S.A 40A:4-45.14, be increased by 3.5%, amounting to \$1,160,120.15 and that the CY 2017 municipal budget for the Township of Willingboro be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED that a certified copy of this ordinance upon adoption, with the recorded vote included thereon; be filed with said Director within 5 days after such adoption.

First, I want to thank Rich for all his work that he has done over the last what —year and almost a half?

Almost.

Rich, you have a smile on your face so...you can get back to what you like to do, so congrats. I want to commend Council and their choice. The individual that they hired especially since it is someone with experience; and I am looking forward to the Township moving forward and I am going to give a brief update on the economic development committee. So we met last night and right now we are almost finished completing our strategic plan for the economic development and we are doing a community survey. So we are surveying residents, businesses and institutions and it would be great if we could get the link to the survey on the Township website because we want to survey as many people as possible. Some interesting things that we've discovered about the survey is that on average the age of people who are answering the survey are between 35 and 55 and residents who have been here 15 to 30 years – so that is really great. The other thing that we thought was interesting was that the sentiment of most of the people who have answered the survey, there is a tremendous pride in the town. So when the survey is finished we will come back and let you know all the results of the survey. Thank you.

I came here with quite a bit of stuff – more than four minutes to talk about. But, I hear in the news that we have picked a new Township Manager. I would have loved to have had some discussions with him before you picked him. I've been working a long time and I can tell you the answers you get from someone who already has a job is different from the answers you get from someone who is interviewing for a job who doesn't have it yet; and as I had told one of the members of the Council, we

are not looking for a meet and greet. We were looking to have an in-depth conversation with the individual that you all were going to pick. But I guess we forgot about the public in that part of it. So I am not going to spend the rest of the time talking about what I had to talk about. What I will spend the rest of my time on is talking about how wonderful it is for Mr. Brevogel. I always tell people in the last 15 to 20 days a lot of people have been stopping us and making my wife mad because we are trying to make a movie or we are going to dinner and people are running up "I heard that you all are going to do this" and "How are you doing in Buckingham Park, we want to do what you all do and how you do it and tell me something about it". One thing I will tell you, in spite of what you may think when I come to this microphone. As I told at least six or seven people, none of the things that we as the Concerned Citizens of Buckingham Park with the average age of almost 80 years old can do without the work and the cooperation of the Township. We can't accomplish anything. We have done our surveys, we have been with the state we have been with the county we have been with the sheriffs' department and I have been with the courts. Our schedule for the year is set -lined up. But nothing that we do is possible – and Mr. Brevogel, when he came to Public Works, our working relationship and our scheduling and how we do what we do on the weekends – over the top. And as I had said at one of the meetings, this man needs to go back to where he loves. I am a retired teamster and I always tell people I can take as good as I can give. I started working in the family business before I was old enough to go to school; so I am sixty six, I have worked over sixty years of my life and most of that time I had more than one job at the same time. I've seen how people work, I have worked people almost to death and I have worked myself almost to death over my sixty some years of working. The professionalism and the fact that I can actually have a conversation with this man and when he tells me something I believe it. A person

in this community doesn't put a thousand man hours working without one penny of pay unless he has confidence in someone who had talked to him about what we do. Mr. Brevogel always talked to me and when he tells me something is going to happen, it happens. When we trimmed 125 trees last year in Buckingham Park, I could not believe that we had all our drop points that we had talked about - those are our drop points – they were overwhelmed with all kinds of branches. Unbelievable, it took us all day to pile all that stuff up. Within a day it was gone. When I came back I just knew some of this stuff is going to be here for two or three days. Gone in a day. Seventy year old people can't do what we do without the help of the Township and the help of the Department of Public Works and I may get on Inspections, but they sometimes take our surveys and they do outstanding work as well. So in spite of what I come here and say, I love this community and I believe the survey. People that I run across...(Clock beeps) I am sorry. But just let me finish this. Thank you for your service, thank you so much for your dedication to this community and thank you and I don't know what is going to happen with the new Township Manager. I am going to get tough because this is a tough town; and if he can't take it then you picked the wrong guy.

Good evening to the panel and good evening to everyone here. I am Sister Aisamah Muhammad Muneera, and I am here this evening representing the community of WMEC (sic) the Willingboro Muslim Educational Circle. We are located over at the JFK Center in Room 126. One of the things that we would like to bring to your attention specifically is what we have now operating under is called the refuse to be a victim. Refuse to be a victim is a crime prevention and personal safety component that we are now introducing and we would like to introduce to the community of Willingboro. One particularly because I am an NRA certified instructor and I come with that information —

specifically I target specific community groups who obviously have community collaborative such as; your own; and I came to this area, I am originally from Philadelphia and I am now in the Burlington County Community and coming to the community I bring this outreach to you with due respect to the community policing component. I work collectively and I am also on the Philadelphia advisory council as well. The purpose of this through our entity, the WMEC is to build a collaborative support. We are all here collectively together, and with respect due, we would like to interact - coexist accordingly and we thought what a fine way to do that by bringing to our community crime prevention and personal safety component. We did outreach to our dear Mayor and other representatives in your community. We sent an outreach to the director of public safety, to the director of the senior center, as well as the director of the JFK Center. The purpose of this is to establish initial meetings so we can introduce to you this program. Currently we are establishing and we do have and is scheduled a seminar. It is a seminar of component. It is a safety expert seminar component which will be held Saturday, May 6th at the JFK Center, Senior Center and we do have flyers and we are outreaching and we welcome the community to be a part of this. Again, we have our room open at 126 each Saturday for preregistration process. Any questions you have, we welcome them. We are looking forward to our scheduled appointment and scheduling meeting with our dear Mayor and we are hoping it is with the other collective that we outreach to so that we can provide an impact to the whole group at one time. I want to thank you for the opportunity to speak before you this evening and I certainly look forward on behalf of WMEC as working collectively together as a family community family. Thank you.

Good evening I just wanted to remind everybody about our school board meeting. It is this Monday, the 27th at 7:00 P.M.

You're just amazing. When I was in the navy, the highest commendation you can give is a "well done" and you sir are very deserving of a "well done". On another matter, I remember not too many years ago before we had this clock, the reorganization took place on an early day in January and was done the same day. For some reason, the last two years we can't get the reorganization done before March and now we are going to step into April and it still isn't complete. We need to get a little better organized so that we can go back to a smooth flowing organization like we had a couple of years ago. Why it takes until April to get a reorganization done is beyond me. It needs to be done better. Thank you.

I'd just like to say, Mr. Brevogel, thanks a lot. You helped us all get through a very bad time here in town. Not necessarily with trees falling and all these other problems that we have; it has been comforting to know that somebody has been on the residents' side. So, I hope that Mr. Berry will be able to settle some of this. I knew him when he was here a Deputy Mayor and went to Burlington City and recall reading in the newspaper that he was instituting a program for code enforcement to handle inspection of rentals. It was that time, I don't know if it was ten or fifteen years ago when he left here—ten maybe. So, I called him up and asked if he could share some of that information with me and he gave me the Councilman in charge over there and we chatted and I brought the information back. I think I gave it to Mr. Mason, maybe it was Mr. Wallace; and so for that reason we do have an inspection of the rental properties

here in town. I think code enforcement does a good job with that, sometimes I question though they don't follow up on it. So, maybe we can get that in place and do it; and I don't know I know we still have your number at public works 1105, so we will be calling you. And thanks a lot.



Sampling done at home · Colonoscopy needed if abnormal Health care provider gives patient at-home kit. Stool DNA Test · No direct risk to the colon · May miss some polyps/cancers Looks for certain DNA changes from cancer or polyps · No bowel preparation · Done every 3 years · Colonoscopy needed if abnormal cells. Health care provider has kit sent to patient. · Sampling done at home

*For average-risk individuals with no symptoms, tesing should begin at age 50. If you are at increased risk or are experiencing symptoms, speak to your health care provider right away. Symptoms include: Rectal bleeding, blood in the stool, dark- or black-colored stools, change in shape of stool, lower stomach cramping, unnecessary urge to have a bowel movement, prolonged constipation or diarrhea, and unintentional weight loss
