#### Manager's Report

Eric Berry, Township Manager:

On May 18<sup>th</sup> I met with Mark Nessel, Executive Vice President and Chief Operation Officer for Lourdes Health System. We discussed possible ways to partner and work together. A follow up meeting will be scheduled to give Mr. Messel a tour of our Town and we will discuss how Lourdes can work within our Community

On May 17<sup>th</sup> Rich Brevogel and I had a meeting with Calkins media (Burlington County Times) Steven Todd General Manager (Mr. Berry had Mr. Brevogel to speak on the meeting that he and Mr. Berry attended with Burlington County Times).

Rich Brevogel:

Mayor and Council, good evening. I sent a plan over to you to basically layout tonight's capital ordinances for hearing and adoption. There's a list of all the infrastructure projects that we have outstanding including an identification of what is priority. As you can see, if you looked at it there's not enough funds to fund everything that we would like to do. But a lot of that would be based on pricing when we put the jobs out to bid. So, if you have any questions about that, you can get them to Mr. Berry or you can call me directly and I will answer them anyway I can. Or tonight during the public hearing if there is any questions I will answer those. Trash—we got a lot of trash complaints over the last several weeks. I'm sure all of you've gotten calls individually. I know Mr. Berry has gotten a few calls. We've had some pretty one on one, and pretty direct conversations with God Medal—they are here tonight. We did fine them for failure to collect. For our next bill we will be fining the \$1,500.00 for failure to collect, which is part of the specifications. However, we've had some pretty hard conversations about our expectations, my expectations as the Public Works Director, and it really is geared around quality of life. There is an expectation that the contract calls that they're out of here by a certain time, and they're working towards meeting that time, particularly during the summer, and, just basic things. If we're going to up our efforts on our end to educate the residents better—when they can put things out and how much they can put out, and were going to be more proactive in speaking with them directly when there are any issues. So, a lot if it is recycling cans that have trash in them, they are not allowed to pick that material up. So, I asked Mr. Coggins from Gold Medal to come up and just reaffirm the fact that he is committed to fulfilling this contract, and is concern about the quality of the issues as I am, and at the...what's the other thing you're going to talk about?

John Coggins:

Mayor, Deputy Mayor, my name is John Coggins. I reside at 12 Coventry Lane, Ocean View, NJ. I'm here tonight to represent Gold Medal Environmental, I want to address some of the issues that we've had, At Gold Medal it's to

provide excellent service and be a partner to your administration in proving good efficient sanitary service for your town. We have run into some issued here in Willingboro. And,, when we see we're having a problem there's a lot of things that we look at internally. The first thing we look at is personnel. Do we have the right personnel here? We start with the supervision. We do audits with our route supervisor who really runs the town is doing. Is he the right guy? Is he doing the right things? In communication with Mr. Brevogel and some of the other people in Public Works we found that we do have a very good and dedicated individual up here. The next thing we look at is, do we have the right amount of equipment here? Do we have right person in the right seat doing the job that we need to do? What we found is this, we went back to look at some of the facts and figures that we have. We keep very detailed records of what we do on a daily basis. And, to give some examples; the month of February we picked up 9,339 tons, the month of March we picked up 770 tons, the month of April was 1,074 tons. We started to have problems in May, we went back and looked at our tonnage reports, and we picked up 1,450 tons. So, it was the case where all of a sudden this is the first of May or the first spring that we have served your community. A spike such as this is something that we usually see in our beach communities. We don't really see this in a community that is a very stable environment where attributing a lot of that to spring cleanups to yard waste. But, I think what interest you more than anything is you know what we did, in order to corrected the problem or rectify the problem going forward, when we recognized that there was an increase in tonnage, we added a route up here, we put in additional crew in the day that we were having the most problems, which was Thursday. Thursday problems head into a problem on Friday. The extra crew has managed to get somethings done. We found that we had some personnel working in town who were not working as efficiently as we would have liked to have seen it. We subsequently appointed a lead driver up here. The lead driver is in communication daily with members of your Public Works Department, and is kind of condensing or compressing the

time that we have to react to certain issues up here to make re-dispatch our assesses. The other thing that we're going to be doing and we're going to be at the suggestion of your Public Works Department is that we're going to be supplying our drivers with smart phones. And, with the smart phones when we do get up to a location where there's sometimes a dispute, then what we will be able to do is, we'll be able to immediately email Public Works and let them make that decision. You know what we try to do with our people is, we give them a non-interpretive set of instructions. We don't want the men on the back of the truck to have to decide—well since this guy has seven trash cans out and three bulk items, does that really count as the ten items? Well not according to Public Works, that's not the way they want it done, but unfortunately sometime that creates—that presents some confusion for the individuals who are actually collecting. What we have found since we make these changes, and since our meetings with Public Works our days have gotten shorter. We are making the finish by the end of the specified time which is 5PM. We are managing to get t routes up with minimal complaints. Can I answer any questions for anyone? Thank you for your time.

I was asked or we had a discussion at the last meeting regarding a possible mobile concession stand. I forwarded some pictures so all of you should have gotten them. I'm giving you some high level feedback that I got from the Recreation Director at the Village of Ridgewood. The unit cost them approximately \$50,000.00. Now, it's a custom made unit; so you can basically tailor to what it is you feel you're going to use the unit for. They have soda machines on there, they sell bottled stuff—now they don't even use the soda machine. So, if they had to do it over they would do it a different way. They paid with a portion of it with raised funds from all the volunteer groups. The unit is used by all the recreation groups including their high school.

They use it during football games and things like that, so everyone, every volunteer group must have someone that is certified to be a food handler, so the Board of Health is going to require that person to have basically everything they need to understand that if they handle the food they need to handle it a certain way. They use it at all community events, they have standard forms, so if a volunteer organization wants to use it, they fill out forms there's licensing, there's insurances, thanks like that, and that's basically it. So, if this Council would like me to pursue it, I could, you know research it a little more, maybe if you could take a look at some of the pictures and see if it's something that you're interested I doing, just let me know and we'll go from there.

Mayor Walker:

I just looked at the price of that and that's way more than what we've—you know, what we discussed earlier—so, I get that it can service multiple needs, it's just far more than what we originally went into. When I spoke to the president...

Rich Brevogel:

He never got back to you.

Mayor Walker:

So, they just needed something basic. You know the manager and I spoke about just going over to the Market Place and the Amish they have the sheds over there and just retro fitting it. Because the sheds over there they are not so expensive—all of it he said, they just need a box with a window, a sink, a stove and it's simple.

Rich Brevogel:

Okay, Mayor, and in this \$50,000.00 represent like a fully

customized unit, it would be much less.

Mayor Walker:

Over \$50,000.00 that's my, I mean...

Rich Brevogel:

I understand.

Mayor Walker:

We...let's buy a house.

Rich Brevogel: So, if I were to get some pricing or some idea ust on a basic

unit that can hold maybe a smaller refrigerator or a sing and

things like that would you want me to research it?

Mayor Walker: It's just my opinion, I just like... I understand multiple...I

get that.

Rich Brevogel: Okay.

Mayor Walker: But, I'm talking about just for concession stand—just the

structure, I don't...when I say box I do't want to minimize

it.

Rich Brevogel: Okay.

Mayor Walker: It's just a cardboard box; but, just a structure to go into and

be able to prepare the food and keep it moving. You know

we don't need some elaborate...you know, so...

Manager Berry: Could we ... excuse me, could we get a list and a size of

what you want and then...

Mayor Walker: But, we gave that already, we've bee going back...

Manager Berry: No, what happened was...

Mayor Walker: We need a sink, a place to heat food...

Councilwoman Jennings: I think that—put something in writing. I know they have

them in different places, can we—can someone look at

other locations to?

Mayor Walker: If you look at the Amish, it's just what we spoke about, if

you go right to the...to the Amish place.

Councilwoman Jennings: They are small—they are small.

Mayor Walker: Nay, they have multiple sizes over there even on the lot

WHEREAS, the Township has requested and received authorization to participate in the State Local Cooperative Housing Inspection Program of the Department of Community Affairs to conduct the State mandated inspection of hotels and multiple dwellings within the Township; and

WHEREAS, the authorization to conduct the inspections is based upon the requirement that the inspections and their related activities be conducted in strict accordance with the Conditions of Authorization attached hereto.

WHEREAS, the State has allocated the sum of \$2,000.00 to conduct the inspections.

**WHEREAS**, the Township desires to authorize the mayor to execute the Conditions of Authorization to participate in this program.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council, assembled in open public session on this 7th day of June, 2017 that the Mayor is hereby authorized to execute the Conditions of Authorizations between the New Jersey Department of Community Affairs Bureau of Housing Inspection and the Township of Willingboro to participate in the State Local Cooperative Housing Inspection Program.

#### Discussion:

Mayor Walker:

Is there anyone that can explain exactly what this is?

Manager Berry:

Inspections.

Cedric Minter:

Good evening, Mayor and Council. In Willingboro we have a few multiple dwellings locations. It's the Millennium Walk beyond Acme. You also have the Avery and there's a motel along Route 130. We have the option of doing the inspections in towns with our own multiple dwelling inspectors or we have the option to let the State do those

inspections themselves. There is revenue

generated with the multiple dwelling inspections that stays directly within the Township if we decide we don't want to do it, it goes back to the State. I don't have the figure for you, but that's what the multiple dwelling is for. Should we do the inspections in house or should we send it back to the State?

Mayor Walker:

Any question?

Councilwoman Jennings:

Yes. I think we need to have an idea...

Mayor Walker:

You need to speak up.

Councilwoman Jennings:

I think we need to have a schedule or something of the amount of money

that we would be losing.

Deputy Mayor Holley:

It's in there.

Councilwoman Jennings:

Okay, I didn't see that. So, what is the bottom line?

Deputy Mayor Holley:

\$2,000.00.

Councilwoman Jennings:

\$2,000.00. That's it, that's all that income we get?

Cristal Holmes-Bowie:

This from the State.

Deputy Mayor Holley:

This from the State.

Mayor Walker:

They get...

Cristal Holmes-Bowie:

For conducting services that the State could otherwise do.

Councilwoman Jennings:

Okay, but, I thought you said there will be income lost if the State did it.

Cedric Minter:

We would pay the State to do our multiple dwelling inspections and it's

only done once every 5 years.

Councilwoman Jennings:

But, I'm asking are we generating \$2,000.00—is that all w we're generating is \$2,000? That's my question based on your comment. Am

I missing something?

Mayor Walker:

Here's the thing—if we do it ourselves they will give us \$2,000.00 to do

it.

Manager Berry:

Right.

Mayor Walker:

If they had to do it, it will cost us more than \$2,000.00

Cedric Minter:

No.

Mayor Walker:

Okay.

Councilwoman Jennings: Okay, so let's repeat that so that we make sure that's...

Mayor Walker: So, if they—if we do it in house they give us \$2,000.00 to do it

in house? If they do it we have to pay them, but it won't cost us

more than \$2,000.00

Cedric Minter: That's correct, sir.

Councilwoman Jennings: Is that what that says in here? I really, want to know is that

what...

Councilman Nock: Do we have the ability to do it? That's the question.

Mayor Walker: Well, that was the question I was going to...go ahead.

Cedric Minter: What we currently have on staff—4—multiple dwelling

inspectors...

Councilman Nock: I'm sorry...

Mayor Walker: Because we have to decide whether we want to accept the money

from them or not...we have to make that decision, because that's revenue that would be coming in, so, we have to decide whether

we're going to take the option.

Councilman Nock: Okay, alright, I understand now.

Councilwoman Jennings: My mind...

Cedric Minter: The benefit of doing it in house is that it gives our—some of our

inspectors the opportunity to get inside the buildings to learn other aspects of inspecting apartments and hotels. It's also a training vehicle for new inspectors to familiarize themselves with that, so they could be better code enforcement officers and

or other type of inspectors within the township.

Mayor Walker: Here's my question, for them to give us \$2,000.00 for us to do it

ourselves the man hours that would go into doing this will that

exceed \$2,000.00?

Cedric Minter: Yes sir. It's a daunting task of...

Mayor Walker: That—well, I mean when you look at it the man hours are going

to exceed \$2,000.00, and there are not really doing anything for us. But, the benefit is to your point is that our inspectors get that experience. They are able to get inside those buildings to know

that's going on?

Cedric Minter:

Yes.

Councilwoman Jennings:

I think we would have to consider that...

Mayor Walker:

Well, I mean, here's the thing, I mean that's your area of expertise. Is it that you're recommending that we take that

option as oppose of going out?

Cedric Minter:

If you look again at the dollar amount it doesn't generate a lot of income, it is a training vehicle. My recommendation considering

the man hours that are involved in it would be more cost

effective to allow the State to do that.

Councilwoman Jennings:

How often would they do it? Is it a once a year thing?

Cedric Minter:

The inspections are done once every 5 years.

Councilwoman Jennings:

How often would we do it—is it the same?

Cedric Minter:

The same. Every multiple dwelling has to be inspected once

every 5 years.

Councilwoman Jennings:

Would there be an opportunity for maybe one or more of our inspectors to shadow them if you're saying a new inspector—so

that they can see how this is done or not?

Cedric Minter:

I'm going to...I'm not sure if the State...there is no history of

that happening—I'm going to say no.

Councilwoman Jennings:

So, did you give us a recommendation—did he give us a

recommendation?

Mayor Walker:

He just said that he would.

Cedric Minter:

If you look at in terms of dollars, it's not costs effective.

Councilwoman Jennings:

So, is that your recommendation? I heard you say that, but I

didn't hear you say I recommend this or this.

Cedric Minter:

I would recommend that we abandon the multiple dwelling

inspections.

Councilwoman Jennings:

Okay.

Councilman Nock:

So, this has to be re-done?

Mayor Walker:

No, you say—it's still—it still comes to our vote to make that decision, I just—I mean, because I just strongly feel like in certain things we take the recommendation of the experts. It's not—that's not our area of expertise, so that's why I asked...

WHEREAS, The Township of Willingboro Council, of Burlington County, of the Township of Willingboro, partnered with the U.S. Department of Justice is committed to improving officer safety and has undertaken research to review and analyze violent encounters and law enforcement officer deaths and injuries.

WHEREAS, The Township of Willingboro Council, of Burlington, County, of the Township of Willingboro, partnered with the U.S. Department of Justice, and recognizes, due to the increase in the

number of law enforcement officer deaths, coupled with our renewed efforts to improve officer safety, beginning with FY 2011, in order to receive BVP funds, jurisdictions must certify, during the application process, that all law enforcement agencies benefitting from the BVP Program have a written "mandatory wear" policy in effect.

WHEREAS, the sum of \$13,417.04 for the Bullet Proof Vest Grant, which is available and received in 2017 the purchase of Police Bullet Proof Vest Grant from the reprocess submission of 2015 Grant release from the Department of Justice Office of Justice Programs for Body Armor Safety Initiative Program under 2013-BU-BX-13065754 (V313003030).

## A RESOLUTION AUTHORIZING DEED OF SIGHT TRIANGLE EASEMENT TO THE TOWNSHIP OF WILLINGBORO TO CLEAR SIGHT LINE ACROSS A PORTION OF LANDS KNOWN AS LOT 23, BLOCK 232 AND LOT 45 BLOCK 501

WHEREAS, Township of Willingboro (hereinafter the "Township") is desirous of establishing a Sight Triangle Easement upon a portion of lands known as Lot 23, Block 232 (Mill Creek Drainage Corridor) and Lot 45 Block 501, to comply with plans for the Township's Fire and EMS facility; and

Cristal Holmes-Bowie, Esq.: It is the second one. However, it is actually an easement, a deed of easement to Burlington County that allows them to have access to a small area near the intersection of Charleston Road and JFK.

Cristal Holmes-Bowie, Esq.: To the county, it's a very small area allowing them to have access

there.

And, so what's the necessity of that, and why haven't they had

access?

WHEREAS, The Township of Willingboro wishes to purchase, construct and install a fabric equipment storage structure for the temporary storage of its Fire and EMS equipment, through Clear Span Fabric Structures International ("Clear Span"), located at 1395 John Fitch Blvd., South Windsor, CT 06074; and

WHEREAS, Clear Span is a participating vendor with the National Joint Powers Alliance (NJPA) a national government purchasing cooperative; and

WHEREAS, the Township has researched vendors that would be able to supply the equipment and services it requires and has determined that the sought after equipment and services may be procured through a nationally recognized and accepted cooperative purchasing contract in effect between the NJPA and Clear Span;

WHEREAS, pursuant to N.J.S.A. 52:34-6.2b(3) and N.J.S.A. 40A:11-11, the Township may purchase goods and services without public bidding under the Local Public Contract Law through the use of a nationally-recognized and accepted cooperative purchasing contract that has been developed utilizing a competitive bidding or contracting process by another contracting unit within the State of New Jersey or another state; and

WHEREAS, NJPA is a national organization of governments engaged in cooperative purchasing agreements of which the State of New Jersey is also a member organization; and

WHEREAS, the Township of Willingboro is a member in good standing with the National Joint Powers Alliance, pursuant to resolution 2017 -78; and

I looked, and perhaps I didn't find it, but it appears to be that this last Memorial Day this Township had no service. At least I was unaware of one or where it was held; which is very disturbing to me since I have served, that we can't find a little time for a ceremony somewhere to honor the fallen. This ceremony started back in the Civil War, decorating the graves of the fallen and later became known as Decoration Day and then was further expanded to cover all veterans and those deceased and called Memorial Day. When we used to have parades, the Parade Director was very emphatic informing all people in the parade that this was a solemn ceremony. They weren't to toss candy or trinkets or other things out of the vehicles as they did in the Fourth of July or other parades. It was a solemn event. We have a lot of veterans in out Township. Some of them have served with quite distinction and we have a little ceremony - we have a little area down in Millcreek Park celebrating those who gave all in their service to their country. I would really appreciate it if this Township could find the wherewithal to ensure that there is a Memorial Day service somewhere in the Township each Memorial Day. They deserve our respect and honor and our remembrance. I also point out that yesterday, Election Day, and congratulation to those that won, but that was an anniversary of D-Day, the sixth of June. I was going to read something, but with this lousy clock I don't think I will try. It was written by a very well-known and regarded war correspondent of the Second World War by the name of Ernie Pyle, who wrote it under the pressure of deadline in a time when people got most of their news by reading. It is a very eloquent article, the man was very eloquent. My father and his people that served with him talked about him so often that when my ship stopped into Pearl Harbor I made a special pilgrimage out to punchbowl crater to visit his grave. I think we can do our veterans a better service in remembering those who sacrificed everything they had so that we could be here

today and enjoy what we have and I would hope that we would not go another year without a service. Thank you.

Mayor Walker: Mr. Johnson, I will say that typically or most years the

article? because I remember Ernie Pyle.

Mayor Walker: One of the things in January we decided, we are not going

to be sharing and passing...

Just read it. Why don't you read it?

Wait a minute, okay if you want to read it that's fine. But we determined in January because it was a fiasco last year with the passing of the times.

Jacqueline Mack, Maplewood Lane. This is ridiculous, the clock and everything else, "Along the thin line of personal anguish Normandy Beachhead, June 17th 1944. In the preceding column we told about the D-Day wreckage among our machines of war that were expended in taking one of the Normandy beaches. But there is another and more human litter. It extends in a thin little line just like the high water mark for miles along the beach. This is the strewn personal gear, gear that will never be needed again, of those who fought and died to give us our entrance into Europe. Here in a jumbled row for mile on mile are soldiers' packs. Here are socks and shoe polish, sewing kits, diaries, bibles and hand grenades. Here are the latest letters from home with the address on each one neatly razored about. One of the security precautions enforced before the boys embarked. Here are toothbrushes and razors and snapshots of families back home staring up at you from the sand. Here are pocketbooks, metal mirrors, extra trousers, and bloody abandoned shoes. Here are broken-handled shovels and portable radios smashed almost beyond recognition and mine detectors twisted and ruined. Here are torn pistol belts and canvas water buckets, first aid kits and jumbled heaps of lifebelts. I picked up a pocket bible with the soldier's name in it and put it in my jacket. I carried it half a mile or so and put it back on the beach. I don't know why I picked it up or why I put it down. Soldiers carry strange things to shore with them; and in the invasion you'll find at least one soldier hitting the beach at H-hour with a banjo slung over his shoulder. The most ironic piece of equipment making our beach, this beach of first despair then victory is the tennis racquet that some soldier had brought along. It lays lonesomely on the sand, clamped in its rack, not a string broken. Two of the most dominant items in the beach refuge are cigarettes and writing paper. Each soldier was issued a carton of cigarettes just before he started. Today these cartons by the thousand, water soaked and spilled out, marked blind of our first savage blow. Writing paper and inter-mail envelopes

come second. The boys had intended to do a lot of writing in France, letters that would have filled those blank and abandoned pages. Always there are dogs in every invasion. There is a dog still on the beach today, still, pitifully looking for his masters. He stays at the water's edge near a boat that lies twisted and half sunk at the line. He barks appealingly to every soldier who approaches; trots eagerly along with him for a few feet, and then sensing himself unwanted in all this haste, runs back to wait in vain for his own people at his own empty boat. Over and around this long thin line of personal anguish, fresh men today are rushing past supplies to keep our armies pushing on into France. Other squads of men pick amidst the wreckage to salvage ammunition and equipment that are still useable. Men worked and slept on the beach for days before the last D-Day victim was taken away for burial. I stepped over the form of one youngster whom I thought dead, but when I looked down I saw he was only sleeping. He was very young and very tired. He lay on one elbow, his hands suspended in the air about six inches from the ground and in the palm of his hand he held a large smooth rock. I stood and looked at him for a long time. He seemed in a sense to (inaudible) that rock lovingly as though it were his last link with the vanishing world. I have no idea at all why he went to sleep with one rock in his hand, or what kept him from dropping it once he was asleep. It was just one of those little things without explanation that a person remembers for a long time. The strong swirling tides of the Normandy coastline shift the contours of the sandy beach as they move in and out. They carry soldiers' bodies out to sea and later they return them. They collapse, they cover the corpses of heroes with sand and then in their whims they uncover them. As I plowed out over the wet sand of the beach on that first day ashore, I walked around what seemed to be a couple of pieces of driftwood sticking out of the sand. But they weren't driftwood. They were a soldier's two feet. He was completely covered by the shifting sands except for his feet. The toes of his G.I. shoes pointed toward the land he had come so far to see and which he saw so briefly. And I happen to know someone who was there that day, he just died two weeks ago, at 96, and he lived in Burlington Township. And he always went to the services no matter where they were". Thank you.

I felt I needed to say something related to not only the memorial, the event, but the fact that we also at the senior center and with the veterans have lost guite a number of the seniors that were at Normandy; and Ron was one of the gentleman is named Bygie (sic) and Bygie (sic) Kauffman is one on the ship that was there the night before the actual raid was made onto the beaches of Normandy; and he was in the ship that went out to detect if there were any land mines there before the other ships were able to come in and let the men go in. We are really dedicated to all of our veterans. Unfortunately, on Memorial Day we did miss quite a few of the seniors that normally make it, but we had over two hundred seniors and veterans there. We had veterans there that represented all of the different militaries and were able to not only give them certificates, but we gave them quilts that are in our quilting class had made that depicted each of the armed services. The email was sent out and we did have some Council people there. We did put it on the "Willing board" at the Kennedy Area and we apologize for anyone that didn't get the notice, but I think next year what we'll do is we'll send out a robo-call to all the homes. But unfortunately we generally give a little luncheon along with the events that we have and this year we had over two hundred. But we'll make it more accommodating and I will discuss it with the Township Manager, so no one will feel that they were not appreciated; if they are a member of a veteran's family or a veteran themselves. Apologies go to each and every one of you who was not able to make it.

Mayor Walker:

Take up a quarrel with the foe, to you with falling hands we throw; the torch be yours to hold it high, if you break faith with us you die, we shall not sleep, though poppies grow in Flanders Fields."

Mayor Walker:

The Basketball game. NBA Finals. LeBron.

Councilwoman Jennings:

Oh really?

Executive Session began at 8:26PM

Executive Session ended at

Motion to come out of executive session was done by Councilman Nock and seconded by Councilwoman Jennings. All in favor and none opposed.

Clerk:

I need a motion to adjourn.

Councilman Anderson:

No, we have something to vote on, the contract.

Deputy Mayor Holley:

What contract?

Councilman Anderson:

Aren't we voting on...

Deputy Mayor Holley:

That's already been voted on.

Councilman Anderson:

Do we need to do it officially?

Cristal Bowie:

To authorize like the execution?

Deputy Mayor Holley:

It has already been done.

Councilwoman Jennings:

So, why are we even discussing it tonight if it is done?

Cristal Holmes-Bowie, Esq.:

It is because I would not sign and the Mayor would not sign it. If, the Mayor is unable to act, the Deputy Mayor can act

in his place.

Councilwoman Jennings: Let's be real here. So if the Mayor doesn't want to sign it,

then the Deputy Mayor may sign it? Is that what we are

saying?

Cristal Holmes-Bowie, Esq.:

The Mayor is indicating...

Councilman Nock:

(inaudible) is that?

Cristal Holmes-Bowie, Esq.

If he is indicating he cannot act...

Mayor Walker:

I didn't say I can't.

Cristal Bowie:

He said he would not.

Councilman Nock:

He isn't incapacitated.

Cristal Bowie:

Well, he is saying he will not sign it.

Councilman Nock:

Then...okay.

Cristal Holmes-Bowie, Esq.:

And, if it is the will of Council, he can't forestall the will of

Council.

Mayor Walker:

I am not forestalling the will of Council. What I did was I

said I wasn't signing because I wasn't clear with...

Councilwoman Jennings:

So, can we move that the contract be signed? Is that...

Councilman Nock:

But, he is the one that signs on behalf of the Township.

Councilwoman Jennings:

But, if we won't sign, Martin, we can't be held hostage

because a person

Councilman Nock:

But we are being held hostage by this ordinance that

doesn't make sense.

Councilwoman Jennings:

We need to see what the motion has to be so the contract

can be signed. This is ridiculous.

Cristal Holmes-Bowie, Esq.:

You have a motion to authorize the execution of the

solicitor's contract.

Councilman Anderson:

So moved.

Councilwoman Jennings:

Second.

Deputy Mayor Holley:

Alright, but we already know what the procedure is. We've

already agreed to it.

It was agreed by Councilman Anderson, Deputy Mayor Holley and Councilwoman Jennings that Township Solicitor's contract be signed. It was voted no by Mayor Walker and Councilman

Nock that contract should not be signed (3 yes votes - 2 no votes). Motion carried to approve Township Solicitor's contract.

So moved.
