WHEREAS, on January 12, 2017 by Resolution 2017-3 the Township Council of the Township of Willingboro authorized a contract with Ogren Construction, Inc., pursuant to the Local Public Contracts Law, N.J.S.A. 40:11-1, et seq.; and

WHEREAS, the original contract amount was awarded for \$10,110,970.28; and

WHEREAS, the Township Engineer has recommended various Change Order Requests as more specifically identified in his letter of June 14, 2018 to the Acting Township Manager; and

WHEREAS, the recommended change order requests are primarily due to unforeseen conditions or unanticipated loss time and/or delays requiring time extensions:

- COR#2: Removal of unsuitable soils encountered at footing subgrade, \$13,935.69.
- COR#3: Removal of unsuitable Soils encountered below existing basement, \$5,261.00.
- COR#4R: Removal of asphalt layer encountered below EMS portion of existing building, \$4,818.00.
- COR#5: Increase in size of Roof top Unit #6, \$3,316.00.
- COR#6R: Removal of unsuitable soils encountered at footing subgrade, \$754.86.
- COR#7: Installation of Grease trap, \$8,708.61.
- COR#10: Credit for the deletion of a proposed fire pole, -\$45,158.00.
- COR#11R: Delay claims \$267,610.95 resulting from an amended "notice to proceed," due to the time required to procure and install the temporary storage structure.
- COR#11R1: Request for Time Extension.

WHEREAS, the total Change Order amount as recommended is \$259,247.11.

WHEREAS, the total Amended Contract Amount will then be 10,370,217.39.

WHEREAS, Township Council has reviewed the Engineer's recommendation letter for the Change Order #1, and has found that it is in the best interest of the Township to amend the contract amount pursuant to the Change Order #1 to Ten Million Three Hundred Seventy Thousand Two Hundred Seventeen Dollars and 39/100 cents (\$10,370,217.39); and



MANAGER'S REPORT

- JFK: The front of the JFK building construction to replace sidewalks and add some handicap Removal of Contractor due to lack of performance
- Presentation of checks for Inter-Local Service Agreement for CPWM
 - \$20,000 for services (consulting and licensing use) while new CPWM candidate for the Borough of Medford Lakes was taking classes and eventually the state test.
- S&P Global Ratings assigned the township a Bond Rating of AA- for the 2018 issue of General Improvement Bonds for the EMS / Firehouse and several other consolidated prior year capital
 - \$12.2 million dollars in bonds were offered and the rate we received was 3.34%. This is an excellent rate. The expected finance rate was 4%. At 4% the estimated financing costs would have been an additional \$1.2 million dollars over the 27 year life of the bond.
 - This rate was achieved by the groundwork started by previous manager Joanne Diggs and continued by the current CFO Eusebia Diggs and the support of the Council. The township is viewed as fiscally sound and managed well. There are some recommendations for improvement but for a local government the rate

Pat Lindsay-Harvey:

Mayor Holley: Alright. At this time we will now open the floor for public

comment. As you approach the microphone please give your name and address prior to making your comment. You have a total of

four minutes for public comment.

Pat Lindsey-Harvey: Pat Lindsey-Harvey, Henderson Lane. I have a question for

Resolution 118. What streets were resurfaced?

Tim: Tim, my name is Tim.

Clerk: And do you want to give your address?

Tim: I wanted to express some concern about some of the gunfire that

has been reported in our township and things. Check, check, is this thing on? Oh, okay. I was saying my name is Tim, I am from Garfield North and I came to express some concern about some of the gunfire that has been reported in our town as of late and over the last couple of years and if it is okay to ask the Council, I don't know if it is a question that should go to the police department or the Council. I wonder if it is something that is on the Council's radar or if it is something that, I mean is there awareness that some of this or a lot of this gunfire is related or is at all completely

unrelated and it is just growing in our town; because I have a concern, I spoke with a lot of other residents who have similar concerns, but I think a lot of us, a lot of our fellow residents are really not aware. It really was a lot of what is going on in our town, so I wanted to ask is that something that the Council could respond to at this time or again is this a type of question that could be relayed to the police department or something like that.

Mayor Holley:

I will answer that one. So, typically the way public comment works is that you have four uninterrupted minutes to make your comment. Typically, after the public is finished speaking, we have Council Comment, where if we have answers to some of your questions tonight we will try to address those questions and if we do not have that question tonight, then we write down the question and we have a response to it at our next meeting. However, I am also a resident that is concerned and I am fully aware of what is going on. We have looked into some preventative measures such as cameras in town, shot spotters, things of that nature to help combat some of these issues. But it is something that is definitely on our radar and it is something that we are definitely in the process of taking action for. We actually passed a resolution to set up cameras in town and also mobile-trailers, however, there is some discussion right now with the vendor for that, so, that is what slowed down the process. But that is something that we are in the process of working on.

Tim:

Well thank you for letting me know. Is it okay if I ask a question about something you said you are talking about? I think you called it shot spotters or additional cameras. I know that there is a number of cameras at some of these intersections. Are you talking about those or different additional cameras? Are you able to say where those cameras will be or is that something you could talk about later?

Mayor Holley:

That is probably a discussion for later. I don't even know where every last camera is going to be placed at. I think the police have kind of kept that for their own purpose of being able to look into these things and so people don't try to avoid the cameras. That is information that they have.

Richard Brevogel:

I don't know if you want me to comment now, Mayor, or after we are done. I am sorry that I am into your four minutes, but there is a number of things that the police department have been doing over

the last couple of years; and again, I know this is not the way we do it, but I figure, do it this way now. As far as what is unrelated or related, that is really not information that we can...sometimes we don't even share that with the Council. Sometimes the police department does not even share that with me. I ask the question; they tell me what they can and cannot tell me. I can tell you that they are very diligently looking into those types of issues. Are they related when we have an incident in the community; is it related to another incident, trust me that is the first thing that they are doing. The other thing that we are doing is that Willingboro's police department is extremely, extremely progressive. We are one of the first communities in the JIF that went to body cameras over five years ago or it is six years ago. I think the other... there is three other towns in our Joint Municipal Insurance fund that are now moving in that direction and they are still not there. But, the other part of that is the police department. When we actually roll out the camera system and the Council is authorized, we want people to know that they are there. It is going to be basically a full blown media blast--there are cameras in the town; we are watching what is going on; we are going to catch you, we don't want you coming here. And its for lack or better terms you want people to fear that when you come into the community they are going to get caught. I can tell you that the Director of Public Safety and his staff that is their primary objective when there is an incident in their community. So, they are very, very very aware of it. The next step is, the department hired an analyst and the analyst is part of the twenty first century policing and that analyst is actually looking at all the data. Now, I know they have looked at the last three years, we get a uniform crime report, which we give to Council that gets vetted out. Crime was at its lowest numbers last year and Greg, correct me if I say anything out of line here, and was at the lowest that it has been since 1985. We just had that discussion today about the types of crimes and how we combat that crime. But, more importantly the twenty first century is going to allow the analyst to work with the police department to strategically deploy their resources. So, they will know traditionally when things are going to happen, what time of year, what time of night, you would be amazed if you saw the actual data analysis. It tells you a story of when things are going to happen; robberies, carjacking, shootings, things like that gives you story. So, yes, they are very aggressively looking at that. This Council supported that in the camera initiative. As the Mayor

indicated, we have got some logistical issues and administratively we have to work through to get them implemented and once it is implemented you are going to know. Because we are going to have it on Channel 6, we are going to have it...we want people to know when you come into this town we are going to catch you. Alright? I am sorry that I went on so long.

Tim:

That is fine. Thank you.

Mayor Holley:

No, that is fine. I hope we answered your questions and I did kind of deviate from the format, but I did feel that that is something that I knew was going to come up tonight. I share the same concerns because I am a resident and you know these are obvious things that nobody wants to take place in the community.

Tim:

Thank you.

William Weston:

William Weston, 44 Bosworth Lane. First, thank you for making a comment about the cameras. I wasn't sure where that was at. I don't know why the sidewalk project was terminated with the JFK; I don't know if that was actually the reason was stated. Also, I heard litigation but I am not sure what the litigation was for executive session. I just...you know...some clarity with that. But I do thank you for making the comment about the cameras. Thank you.

Mayor Holley:

The Kennedy project is in contract negotiations. We stated that we were going to discuss that in executive session and then come back out and take a vote and go through that dialogue. And the litigation was with the Berry matter? The Berry vs. Willingboro matter.

John Polk:

My name is John Polk, I live at 146 Niagara Lane. I have been a township resident I guess about forty five years and I have some concerns about my sidewalk. It has been cracked up for the last four years. This is the fifth year and I have been calling and nothing has been done about it. So could you address that? Richard Brevogel:

What is the address?

We have the address and we will have someone find out what is going on. Any other comments? Alright, hearing none, seeing none, at this time public comment is now closed. We will open the flood for Council Comment.

working with you for the rest of this year.

Councilman Anderson: I just want to thank everyone for coming out this evening. I want

to thank my Council colleagues for supporting the initiative of the new logo in an effort to rebrand. Once again, it was a suggestion that one of my neighbors made who has been a resident here for over sixty years. So, I am just glad that we have taken a minimum

cost first step to continue to head in the right direction. Thank you.

I don't have much to say other than to say, Jill, great Jazz Fest and I hope it was a good summer and actually I thought that it was a quieter summer than last summer with our incidents. So, I look

forward to continue working this fall.

Mayor Holley: I might need a little time. I, too, would like to thank everyone for

concrete work, yes.

That is what I am talking about. So I am right, I wanted to give a reason why. That is what everyone wanted to know.

Cristal Holmes-Bowie, Esq.:

And, the reason for that is they have not been compliant with the contract. Basically, the repairs were supposed to be done by August 22nd, the work has not been completed. They have not been compliant with the contract since the contract started, basically. And the engineer laid out the reasons, he has issued them a letter of intention to terminate the contract August 15th he subsequently issued a letter notifying them that he is required to give them seven days notice under their contract and that was done August 16th; and they were supposed to complete the work by August 22nd. Their schedule to complete the work that they provided to the township engineer would be completing the work by October. They have been informed that that wasn't acceptable and that is why the contract is being terminated, among others.

Whereas the law firm Zeller & Wieliczko, LLP was appointed as an attorney to the Township of Willingboro in various matters including the tax, foreclosure and planning board, January 1, 2017.

By resolution I believe that was 36,

Cristal Holmes-Bowie:

The appointment was probably 6, 2018-6, the initial appointment.

Clerk:

Yes, but not to exceed was the 36.

Cristal Holmes-Bowie:

Yes, the 36th.

Clerk:

Whereas, the Township of Willingboro requires the services of Zeller & Wieliczko, LLP as special counsel with the respect to a matter that is presently active and pending, Berry vs. Willingboro Township, docket number BRL2152-17 and whereas the Township finds that it is in the best interest of the Township to appoint Zeller & Wieliczko, LLP to represent the Township as special counsel in this matter; and

Whereas, the services to be performed are professional services relegated by law and the persons appointed are practicing recognized professions, and where as a local public contract law NJSA 40A:11-5 1A authorizes the award of the contract for professional services without competitive bid.

Now, therefore, be it resolved by the Township Council of the Township of Willingboro assembled in open public session this 4th day of September, 2018 here by authorizes the Mayor and Clerk to

execute an agreement with Zeller & Wieliczko, LLP law firm to represent the Township of Willingboro in the matter of Berry vs. Willingboro Township, docket number BURL21525-17 as Special Counsel to the Township of Willingboro.

Be it further resolved that this contract is awarded without competitive bidding as professional services in accordance with NJSA: 40A:11-5 1A of the local public contract law because the services are to be performed by a person authorized by law to practice a recognized profession. This contract shall be for the term of September 1, 2018 to September 30, 2019.

Cristal Holmes-Bowie:

That is a typo. 2019.

Clerk:

Okay.

Cristal Holmes-Bowie:

Yes, it should be one year.

Clerk:

I will change that for you to 2019.

Cristal Holmes-Bowie:

Thank you.

Clerk:

Notice of this action shall be printed once in the Burlington County Times. A copy of this resolution shall be provided to Zeller & Wieliczko, LLP for its information and attention.

Councilwoman Jennings:

I kind of have a problem with this resolution and I don't know if we need to discuss it in executive session, but that is not what I got in there. So, first of all, I don't know-- I have a problem with the term, because it seems to be that...

Cristal Holmes-Bowie, Esq.: Well you can determine what the term is.

Councilwoman Jennings:

It seems to me that there should be until after the litigation and the

other thing is, it is supposed to be specifically for...

Cristal Holmes-Bowie:

I don't know that that can go into the resolution.

Councilwoman Jennings:

But, I think that we can say something that it is for a specific

matter.

Cristal Holmes-Bowie:

I think the resolution identifies the litigation, but I don't think that the resolution can identify more than that or the purposes of it.

Councilwoman Jennings:

Are we sure?

Councilman Anderson:

Can we justify it until litigation is complete?

Cristal Holmes-Bowie:

Sure, yes.

Councilwoman Jennings:

Because this just doesn't sound like what we discussed in there and

for a specific reason, so I have a problem.

Cristal Holmes-Bowie:

Well, why don't you make it six months then?

Mayor Holley:

You can always revisit it.

Deputy Mayor Nock:

So, in other words you can't single her out rationale for...

Cristal Holmes-Bowie, Esq.: No.

Councilwoman Jennings:

And, I am not asking for that, but, I am asking for it to say something to the regard that it is for a specific purpose. Because we have special counsel, we have had this discussion.

Cristal Holmes-Bowie, Esq.: We did. And that issue would be privileged and that would not go into a resolution. What is required in the resolution is to identify the litigation itself and the term of the contract; and you can also, obviously, in the resolution you can indicate whatever you're not to exceed is going to be as well, not to exceed amount which we did not discuss. So that is up to you. But no, you wouldn't...we have had other appointments of special counsel. In fact we did one with Cooper Levenson, maybe about three years ago. All that is identified is the case, we don't say anything about what the litigation is that they are working on this, and Council has appointed them. We have appointed Surenian's office before they were COAH to act as special counsel, we identified the litigation.

Councilwoman Jennings:

It was very specific what they were being identified for. So you all

can call for the vote, because I am...

Councilman Anderson:

For me, if we can go six months and then if it goes longer we

revisit.

Deputy Mayor Nock:

What was her objection? Your objection is the time limit?

Councilwoman Jennings:

That was my first one. My other was that I thought that it should say, because we have a special counsel, so I thought that this should say that we are hiring them as a special counsel to handle a specific case matter, period. So it is not everything that a special

counsel...

Deputy Mayor Nock:

It does say that. It says "Berry".

Councilwoman Jennings:

What?

Deputy Mayor Nock:

It says "Berry vs. the Township". That is a specific thing.

Cristal Holmes-Bowie, Esq.: It is nothing else that special counsel does.

Councilwoman Jennings: Alright, it's okay, I don't think that I can really discuss that out

here, so I am not going to.

Councilman Anderson: What about the time limit? Do you want to six months and then

we revisit it.

Clerk: So you want to change it to six months?

Cristal Holmes-Bowie: Whatever six month time period is.

Mayor Holley: So, that would put you in March.

Richard Brevogel: March.

Councilman Anderson: Is it going to be any longer than that?

Mayor Holley: We are not even going to be finished the depositions by March at

MANAGER'S REPORT

- JFK: The front of the JFK building construction to replace sidewalks and add some handicap parking has been put on hold.
 - o Removal of Contractor due to lack of performance
 - o Rebid
- Presentation of checks for Inter-Local Service Agreement for CPWM
 - \$20,000 for services (consulting and licensing use) while new CPWM candidate for the Borough of Medford Lakes was taking classes and eventually the state test.
- S&P Global Ratings assigned the township a Bond Rating of AA- for the 2018 issue of General Improvement Bonds for the EMS / Firehouse and several other consolidated prior year capital improvement authorizations.
 - \$12.2 million dollars in bonds were offered and the rate we received was 3.34%. This is an excellent rate. The expected finance rate was 4%. At 4% the estimated financing costs would have been an additional \$1.2 million dollars over the 27 year life of the bond.
 - This rate was achieved by the groundwork started by previous manager Joanne Diggs and continued by the current CFO Eusebia Diggs and the support of the Council. The township is viewed as fiscally sound and managed well. There are some recommendations for improvement but for a local government the rate achieved should be applauded.
- Request that the Council set a meeting sometime this month or October to discuss the capital debt position of the municipality and establish a council 5 year plan for Capital spending.
- The 8th Annual Del Payne Memorial 5k Run/Walk will be held on September 22 2018 in Millcreek Park. The event will begin at 8am. Additional information is available on the library website at www.willingboro.org.
- On August 29th I met with Schneider Electric to look at possibilities within the Municipality to save energy costs. I will be receiving information from them regarding ESIP and will look to move this forward within the township.
- On September 8th there will be a "Movie in the Park" night at Millcreek Park. The movie will begin at dusk (approximately 8pm). Information is available on the Township Facebook page.
