Manager's Report (See attached):

Presentation: David Wyche, Manager of the Burlington County Bridge Commission

Mayor Nock:

I appreciate you coming to us and presenting. And, once we put it on the website your will probably get some more hits; folk will give you a call. I am very glad to see the Bridge Commission in Willingboro-Manager of Burlington County Bridge Commission: We are very grateful for the partnership we have with the municipalities and things we have been able to do and hope to continue to do. We are really busy right now.

Mayor Nock:

Something I did think of; are you involved at all with the Trump Opportunity Zone?

David Wyche:

You should have gotten ads of what we did (inaudible). So, when the opportunity zones were created our GIS Department actually did an overlay of the blocks and lots that are in those Opportunity Zones. Did you get a copy of that map?

Rich Brevogel:

Yes

David Wyche:

There are only five in Burlington County. We have nothing to do with that. We...

Mayor Nock:

Some of the towns, like ourselves, could probably use some developing kind of things to advertise and things of that nature, and the benefits. It is unique; really an opportunity with people with money. It would be great if we had some help in doing that.

David Wyche:

The last I knew about these opportunities, they are still finalizing all the regulations and rules, and determinations. And, I believe it was about two weeks ago there was a big conference that is going to be down in Baltimore. We will not go down to that. The federal government will have to get everything together and give some guidance and once we get the guidance we will be happy to help our five municipalities with that. And, again, it is going to be a private investment in the Opportunity Zones.

Mayor Nock:

The five are who?

David Wyche:

Willingboro, Riverside, Pemberton, Burlington City and (inaudible). The key is going to be getting the private investors, and they still don't have... Nobody is going to invest until they know what they are—how that's going to work. That's what needs to be determined and again that is a federal program. As we learn things; what we would like to do we will have a forum or meeting with our five municipalities and bring in some experts to sit down and talk about that and again what we can do in the long term and to look and help promoting those opportunities.

Mayor Nock:

I certainly think that makes sense to do that brought all five towns together; you have to find a way to help the towns out. How to make it happen or it won't happen and based on the dynamics of that particular program the towns are going to need some help.

Manager of Burlington County Bridge Commission:

Another segway, is an example Maryland has created state incentives to go with the Opportunity Zones. Again, I am not that familiar with all the rules and regulations but I would like to see NJ do something similar and take a lead in that regard and once they do we would be happy to jump in and help you through the process.

Mayor Nock:

Councilman Holley:

May I add, I want to make one recommendation to Council if the information provided in addition to being posted on the website be shared out from the Communication Department Newsletter. I think that will help to get it in the hands of our residents and local businesses as well.

Rich Brevogel:

Regarding the budget, you were all sent four scenarios for your review and comparison and that information is contain on the cover memo in which Ms. Eusebia Diggs from the Finance Department forwarded to Sarah and she forwarded it to you. We sent the salary and wage information comparison by budget year, by employee title. 2016, 17, 18 including 2019 introduced. Based on the feedback we got on the last meeting I am recommending that you look at scenario 3 which is an additional reduction on the Health Insurance budget amount in an amount of hundred thousand to two hundred and fifty thousand. The cost per household would be 3.74 percent or \$ 54.49 per year in assessed homes. We are still compiling the revenue vs expense information; best I can for Council. We do sort through all the POs to charge the proper buildings that they were attributed to; and we are going to use an established utility cost for water, sewer, and electric per square foot for all the buildings; so it will be on a square ft. basis for all utility cost.

And, we have had some conversations with the director's staff. We are going to generate like we did back in '09 when we had the budget We are going to generate spreadsheets that tie each PO to a specific building so we can give you utility cost by building. working on that now, and we will try to do that as a regular course of business for 19. The problem again is the modify base of accounting. We are not cost accounting. And, for us to do that it entailed a little more work, but if that's what the Council would like to see then that's what we will do. I recommend, if Council approves tabling the public hearing and adoption of the budget, and an introduction of an amended budget on April 16th and representing Scenario 3. The Township was notices on March 29th that we have received a Phase 2 grant for the repaving or Garfield Drive in the amount of \$3,063,409 this amount added to the amount received in 2018 will allow for the complete repair of Garfield Drive-we will be able to do that this year, correct. In your packet is an update of the Council's Action List. The information is 2016 year to date, so it will show you all the items you guys completed and the opening of items year to date.

The week of April 8 – April 13 is National Library Week and there is information on the activities that the Library will be hosting available on their web page. On April 10 Virtua will be holding a community meeting at JFK Center from 10 AM to 12 Noon. The township will be doing a robo call to remind the residents of that meeting. Spring Cleanup Week will take place April 15 – April 19, flyers attached. That information is currently available on the website. I have no additional items and I have nothing for Executive Session.

Right, so what I am recommending-- you have on your agenda tonight the public hearing and adoption of the introduced budget from the last meeting. I am recommending that you table that adoption, you allow us to amend the budget, reintroduce on the 16th. If Council concurs with the information provided, and then we will check with DLGS (Division of Local Government Services) to find out if they will allow us to adopt the budget. We were pass the deadline at the first meeting in March. If they do not allow us to do that, I will inform you on April 16th that we will need to hold a special meeting regarding the budget, which will be a public hearing and the adoption.

So, I do have deep questions about the budget. And, if I have multiple questions— and I hope I receive the responses. And, if it is a take-a-way, no matter how long it takes to provide the information I am asking; so, if I ask the questions now or if I ask the questions now and ask more questions in the next agenda, and ask more questions during the time of our budget hearing, I will ask the question.

I don't think that is the topic or issue.

So, it is not a part of the salary and wages that you presented in Scenario 3. So, where would I find the Finance Department with regards to salary and wages? Where is that?

I sent you comparative budget expenditures with the introduced budget, it is in the document that has every job title listed. It gives you the salary and wages for each position in that department by year including what was introduced.

Can you describe Collective Bargaining Agreement?

It's the negotiated agreement with AFSCME, FOP, LESA Public Works Association, Public Works Supervisors Association; I believe that covers all unions.

So, they come up with a figure of how much to pay per employee?

They negotiate a figure with the Township,

Rich Brevogel:	You will have the opportunity to when it is recommended by the Manager what the Collective Bargaining Agreement is as supported by Labor Counsel you will be given that information and you can either choose to approve or not approve that Collective Bargaining Agreement, which means if you do not approve it then we go back to the table. Everything that we negotiate is contingent upon Council approval relatively to the bargaining
	agreement.
Councilman Holley:	We discussed part of that in our last meeting about having some help with the negotiating process and you brought that to us too.
Mayor Nock:	A big part of it is Health Care Chapter 78.
Rich Brevogel:	
	Chapter 78 has been incorporated over the last eight years. From June 2011 Chapter 78-because it went into effect, some Collective Bargaining Agreement were either up for negotiation or were—some individuals were not in Collective Bargaining Agreement that went right to whatever the established contributions to their Health Care premium were at the time. The FOP, as we discussed last time, is in Tier 4 effective July 1 of 2019; which means they are

at the highest tier of contribution. So, they are the last union over the last eight years that are now going to be contributing their full share of Health Care under that law this year. Those were the numbers I was talking about. Relative to be able to cut our Health Insurance by \$250,000, because we are getting contributions toward the premiums from the employee. Collective Bargaining Agreement actual dollar amounts is based on whatever the negotiated schedule are or in some cases steps for those individual contracts.

So, out of our eight unions, quote, unquote, the FOP was the very last one to contribute. Is that a good summary? And, that is why that number—ok. Does that make sense?

Yes, thank you. So, now you presented four Scenarios, all four scenarios are tax increases. You have not presented a scenario where there is no tax increase.

The only way I cannot do a tax increase is lay people off.

Now that goes back to the salary. So, we just went over how we established percent increase and decrease. So, if we have already voted on that before I was here; therefore, when we are operating and we have our revenue from our revenue sources such as JFK Center etc.; how is we are laying people off if we have already decided a few years ago how much we would pay the people we currently have?

You are not laying people off.

Right, so if you present a budget that is the same as far as no increase. We raise the taxes last year?

We raised the taxes and stated why and we had all these documents. So, why is it that we need to raise it again, if we have not hired any new people? We have already established how much we are going to pay them, as we stated about three years ago.

Rich Brevogel:

Yes Ma'am.

Deputy Mayor Perrone:

Why is it that there are no scenarios that are presented where the taxes stay the same?

Rich Brevogel:

Because \$31.00 of the \$54.00 that I am proposing is tied to salary and wage increases that are negotiated contacts. \$31.00 increase is tied to your police and fire; \$486,000 is anticipated as a Collective Bargaining Agreement in the Police Department.

Deputy Mayor Perrone:

Right, but the way I understand it is, we just discussed now--we have already established the increase for our Fire Department and our necessary police officers. We have already decided how much it cost to pay them, and their increases for the next three years, therefore, there should not be a situation where we have to lay them off or pay them less because we have already voted on salary. So, understand my concern. Salary according to what we describe here is not an issue because it has already been voted on.

Mayor Nock:

Each year it goes up.

Deputy Mayor Perrone:

We have already voted for it to go up.

Councilman Holley:

My experience in labor negotiations, you are not necessarily approving a salary you are approving a percent an increase percent of that increase depending on those employee and how long they have been here. How much they are already making. If an employee is making \$90,000 and they get a 3.5% increase, so to speak, then, it is based on the amount of money that they are already making. So you can't really necessarily—people are going to leave, people are going to retire, people are going to come so there is no way to actually account or have that foresight for you to plan for. There is going to be wiggle room.

Deputy Mayor Perrone:

Yes, but it seems; thanks for adding that information because it helps for my understanding. The reason why it is voted on, my understanding, three years ago so we are prepared to staff, to financially staff the individuals that we need to run the town; therefore, we are aware that we plan three years ahead of economic increases and cost of living and we have incorporated that. I image you would have incorporated that when you decide how much to increase a person's salary, because they would have worked here for X amount of years. They would have had seniority or whatever, as your described Councilman Holley. So, what I don't understand is salary should not be an issue as far as body count, if we don't hire any new people. If we have already voted on how much to pay them, if we have already calculations with the professionals as far as how much Mr. Brown will be paid in three years with an increment of 2.7, we already know how much we are going to pay this individual. Therefore, when we get to that time period that individual would have worked already-- let's just say three years, we know how much we are going to pay him. So, why is it that we now look at laying people off in order to raise taxes?

I am not saying that.

That should never be on the table, as far as raising taxes or we lay people off. I feel that should never be compared

What you ask for was why he didn't present a zero increase in taxes and he said in order to do that he would have to lay folk off. There is no one being laid off in this budget. I still want to bring to your attention; this is a \$57.00 increase on approximately \$160,000 house. Last year our tax was--over three years we did not make (inaudible) and we couldn't continue to do that. First year was like \$.23 the next year was-and last year... the bottom line is you can't continue—it was \$14 one year on a \$160,000 assessed house. I remember it being \$23 one year on a \$160,000 assessed house and last year it was \$40. That means in four years we basically have increased the taxes on the residents to about \$1.10 per thousand on a \$160,000 house; which is really, really, good. So, it is not outside of the street that causes the taxes, if that's what you are getting at, in the town, because if you have raised it a dollar for years, at

some point the Collective Bargaining Agreement will catch up with you, because you negotiate them four and three and five years and what percent of our budget is salary wages and everything else that might help you out a little bit.

Deputy Mayor Perrone:

Comparison to our revenue why we are not looking at how much we are receiving to determine how much we can actually have in operating expenses.

Mayor Nock:

Well, that's a good question. We have been asking him. The big revenue generator is fees, permits, and will be the JFK Building. And the political aspect of that, if you are raising a lot of rates-- inside the JFK building there will certainly be push back from the community. Not saying that shouldn't be looked at and that's what they are compiling now for us and he said he is going to use square footage of organizations that use it; so that could be a significant increase for organizations that use base on the square footage; if the governing body decide to go that directions. You get revenue from taxes, you get revenue from permits and fees, you get revenue from the rental of our space and once the Avery dropped and all the permits associated with them there was a drop of permits and fees. Do we get monies from the Police Department giving tickets?

Rich Brevogel:

We do, but most of that goes to the municipal court.

Mayor Nock:

All that goes to the courts? Ok. So, I want her questions answered and I also want her to be comfortable. And I just say to you, to do one on one with Mr. Brevogel and go through this. Most of us-- at least it is my third budget process; everybody is ten years or more. I apology, I clarify he doesn't have ten, but the bottom line is this is a process we kind of go through and that's why this time we raise a lot of questions in those Collective Barraging Agreement was up, because we were asking questions about it. Somebody, I even answer a question in terms of to some point they were generous on some, but it was also the first and second year. The employees begin to tribute to their own health care and I hate to say it, but the FOP is the last one to do that and so they have been operating without no contribution at all and unfair too. So at the end of the day is there anything significant you can ask one on one?

Deputy Mayor Perrone:

I would like for you to present by the time of our budget hearing or before them, obviously, the comparison for operating expenses vs our revenue and what does that look like after we have paid our salary and wages and of course expense for operating expenses. What do we have left over-- like that comparison? Is that something you will be able to do?

Rich Brevogel:

That's what's contained...you have several sources of revenue which I provided for you on that revenue sheet. That revenue contributes the rest of the revenue as an indication comes from the tax payers. So we are taking conservative fiscal responsible attitude relative to our annual revenues. We are taking averages and those are reflexed; it's a complex thing-- where I can tell you how much revenue you bring in from source A, source B and source C. And the rest of the revenue comes in from the tax payers and then we have a percentage of revenue that comes in that we put on the tax payers, relative to people who don't pay their taxes. We still have to operate. We have to give 100% of the school budget their money. It doesn't matter if we only get 10% we have to give them 100% and at the end of the day it is revenue equal appropriations. Now we have, developed a healthy fund balance, hat healthy fund balance as well as the physical management that the Finance Department has had over the last ten years, primarily over the last three years has put us in a position where we have a double A minus bond rating, which saves us hundreds of thousands of dollars on financing capital, so it not just that I can say, this is how much we are spending and how much we are spending in expenses. I can give you those numbers, but they are not going to be relative to individual components of what we do, because it is modified accrual accounting. It is not (inaudible) accounting that say-Ok, this is exactly the amount I spent in Recreation and Parks, this is exactly what I spent in Public Works.

Deputy Mayor Perrone:

When it comes to-- as I described earlier, our Building and Maintenance, and we are approved to spend close to half a million dollars to clean the same building that we have had for years, but you say we can't decrease that. We will have to lay people off.

Rich Brevogel:

That is not what I said.

Deputy Mayor Perrone:

You are saying; when I say what we can do to keep the budget at the same. You never once stated that we could look at other areas that we have a high expense such as maintenance. The building and grounds, other building and grounds, we went over those in detail.

Rich Brevogel:

Yes.

Deputy Mayor Perrone:

You did a better job this year in describing what the different between more maintenance versus maintenance; however, these areas are never a concern to look at where we can put things off to fix these maintenances the next year, instead of constantly saying we lay people off--which is the community; these are the people who work here or we will increase the taxes which is only... we are going to pay you this amount of money this year-plus by the way, you have to now pay higher taxes. So, I think we are doing our community a disservice by never trying to look at the budget where we can look at other areas that we are spending a lot on.

Rich Brevogel:

May I, mayor, May I... Let's go to scenario 3. Almost forty and a half percent of salary and wages; almost forty and a half percent of this 45 million or whatever the number is—is salary and wages. Statutory cost, it is our insurance, it is our utilities, our trash disposal, and it is our contract to pick up trash. So statutory expenses; it's our pensions, it our state and federal grants, other operating functions. It is capital improvements, its debt service, which is a huge number, 5.2 million dollars, it is deferred charges which is basically judgements and reserved for uncollectible taxes 3.2 million dollars. That's 47 percent of the budget, so between salary and wages and operating expenses are just statutory numbers that's 88 percent of the budget.

Deputy Mayor Perrone:

What about Support Services, eight hundred and 90 million dollars. What's support Services?

Mayor Nock:

Ms. Perrone.

Rich Brevogel:

Inspection and uniform inspection code.

Deputy Mayor Perrone:

That's uniform?

Mayor Nock:

Ms. Perrone, I am going to really highly suggest that you just take some time with Mr. Brevogel and just go over it, because we go over the same thing. We have three (3) bids on trash and they are all much higher than before to the fact that we had exercise our option which was lower than putting it out to bid. So, I am going to move on.

Deputy Mayor Perrone:

We can move on, but just to response... Mayor, my job here is to speak to you and the rest of Council. We are not allowed to meet outside of this setting, so, my questions have already been asked to Mr. Brevogel. My questions and concerns is communication between (inaudible) and rest of Council, because, either-- if I don't support the budget, I want to know that the rest of Council has made an education decision. And, based on what they have received; this is why they support it or not support. So my questions will be asked in this setting in this forum.

Mayor Nock:

Ok, thank you. Let us move on. Can I have a motion to table the budget? I am sorry, are you done Mr. Brevogel?

Rich Brevogel:

Yes I am sir.

Mayor Nock:

We are still working on this experiment of having public comments on agenda items prior to us getting to the agenda items, so I am going to open for public comments. I assume one of the resolutions will be questions asked about it. And at this point, council, will you make a statement about 74. Because I am going to assume that's where folk are going to go, unless you want to wait until that point.

Cristal Holmes-Bowie:

Whatever is your pleasure Mayor?

Mayor Nock:

I think a statement now so we can get that out of the way.

Cristal Holmes-Bowie:

This is with regards to Resolution 2019-74 and this is a resolution of the Township Council authorizing settlement in the Berry versus Willingboro Matter. And this is the only statement that council will be making in regard to this matter, at this time. After though deliberation township council and it's insurance carrier have opted to settle the litigated matter of Berry versus Willingboro Township, and you have the docket number that's in

the resolution. The Township Council authorized a contribution toward the settlement, which will resolve existing claims as to all parties. The Township and the individually named council members steadfastly deny all liabilities in this matter and anticipated success or motion for summary judgement or at trial. The cost and expense to defend the litigation associated with the desire for closure of the matter has led to the determination to settle. Settlement in our opinion and that of our legal counsel represents the most efficient path forth to migrate the financial burden of protracted litigation and is in the best interest of the tax payers and the Township. Thank you

Mayor Nock:

And at this point...

Township Clerk Wooding:

Are we saying we are going to make a motion on this?

Cristal Holmes-Bowie:

Mayor Nock:

No, we are not saying that

Cristal Holmes-Bowie:

Public comment...

Mayor Nock:

It is just going to be public comment and were also saying at this point, it has not been...

Cristal Holmes-Bowie,:

Nothing more.

Mayor Nock:

Nothing more. At this point we have two minutes to speak on the resolution and ask you to come forward if not you can wait until the second public comment and then speak on what you would like to speak on. So is there anybody? It must be on the resolution, sir.

Steven Craig-- Belmont Lane:

So, I am looking here at this budget, ok. Last year you guys salary was \$82 thousand 545. You had other expenses of 71 thousand 800 dollars. This year you guys are projecting your salaries to be 848 with other expenses of 955. What other expenses? Can anybody tell me what that is? What you 'all spent 82 thousand dollars of 71 thousand last year on above and beyond the salaries. What is that? Anybody, anybody?

Mayor Nock:

Mr. Brevogel will answer that question at the point and time.

Steven Craig:

Ok, let's move on. Moving on to Code Enforcement, Ok, salary and wages combined with instruction code and other expenses is like 1.1 million dollars. Is Code Enforcement bringing in that kind of money to justify this? We only ask you guys to do your job and you guys should be looking at these numbers seriously before you just start approving these things. And, then going further, since I got but 40 seconds left here, information technology is going to spend 90 thousand dollars on computers and network system, ok, I understand networking that makes sense, but then we go back to the Inspection Department they are asking for 150 thousand dollars for software. What is software? What type of software? Usually in this type of setting you are license to software, okay; 150 thousand dollars that is a whole lot of money for software and we don't have a clue of what kind of software it is. Now you can answer.

Mayor Nock:

I am not going to answer, at this point because I am not the expert on this and our Township Manager and staff and CFO... I will say to you that we will have a hearing just on the budget were you can get detailed answers. We already had almost three hour meeting on the budget. It was only about the budget; prior and it was well advertised; so is there anything you can help him along with or wait for the CFO to be here Mr. Brevogel? Because the budget seem to be the topic, I want all your questions answered I really do. When I was sitting out there... but again the budget takes up a lot, and that's why we have separate hearing in separate meetings, special meetings on the budget and so forth.

Cristal Holmes-Bowie, Esq.:

It appears that the gentleman was referring to the bond ordinance. It looks like his questions relates to the bond ordinance.

Mayor Nock:

That's got to wait until the Public Hearing. It is a little bit on the agenda. Wait until we get to that part of the agenda, Mr. Craig.

Pat Lindsay-Harvey- 12 Hadley Lane:

JFK Center said roofing repairing. Is that a new part of roofing that needs repair or is this underneath the solar panels that going to be repaired? And it says room renovations. What rooms are being renovated?

Mayor Nock:

Mr. Brevogel has noted that, ok.

Pat Lindsay-Harvey:

The other question I know that we are not going to get an answer to, but it says the solicitor said that Council is making contribution to the settlement or we going to find out how much we are going to be on the hook for this.

Cristal Holmes-Bowie, Esq.:

It is in the settlement agreement.

Pat Lindsay-Harvey:

Which we don't have a copy.

Cristal Holmes-Bowie, Esq.:

Because it hasn't been finalized.

Pat Lindsay Harvey:

thank you.

Shirley Dilworth-New port Lane:

Now is this the part...

Mayor Nock:

Just on the resolution before you not the other...

Shirley Dilworth:

ORDINANCE 2019-1

BOND ORDINANCE PROVIDING FOR VARIOUS CAPITAL IMPROVEMENTS IN AND BY THE TOWNSHIP OF WILLINGBORO, IN THE COUNTY OF BURLINGTON, NEW JERSEY, APPROPRIATING \$2,951,500 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$2,803,925 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WILLINGBORO, IN THE COUNTY OF BURLINGTON, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance are hereby respectively authorized to be undertaken by the Township of Willingboro, in the County of Burlington, New Jersey (the "Township") as general improvements. For the several improvements or purposes described in Section 3, there are hereby appropriated the respective sums of money therein stated as the appropriation made for each improvement or purpose, such sums amounting in the aggregate to \$2,951,500, and further including the aggregate sum of \$147,575 as the several down payments for the improvements or purposes required by the Local Bond Law. The down payments have been made available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the several improvements or purposes not covered by application of the several down payments, negotiable bonds are hereby authorized to be issued in the principal amount of \$2,803,925 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. The several improvements hereby authorized and the several purposes for which the bonds are to be issued, the estimated cost of each improvement and the appropriation therefor, the estimated maximum amount of bonds or notes to be issued for each improvement and the period of usefulness of each improvement are as follows:

The excess of the appropriation made for each of the improvements or purposes aforesaid over the estimated maximum amount of bonds or notes to be issued therefor, as above stated, is the amount of the down payment for each purpose.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no bond anticipation note shall mature later than one year from its date, unless such bond anticipation notes are permitted to mature at such later date in accordance with applicable law. The bond anticipation notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with bond anticipation notes issued pursuant to this bond ordinance, and the chief financial officer's signature upon the bond anticipation notes shall be conclusive evidence as to all such determinations. All bond anticipation notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law or other applicable law. The chief financial officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes pursuant to this bond ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 5. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this bond ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvements or purposes described in Section 3 of this bond ordinance are not current expenses. They are all improvements or purposes that the Township may lawfully undertake as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.
- (b) The average period of usefulness, computed on the basis of the respective amounts of obligations authorized for each purpose and the reasonable life thereof within the limitations of the Local Bond Law, is 14.58 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance

by \$2,803,925, and the obligations authorized herein will be within all debt limitations prescribed by that Law.

(d) An aggregate amount not exceeding \$445,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purposes or improvements.

Section 7. The Township hereby declares the intent of the Township to issue bonds or bond anticipation notes in the amount authorized in Section 2 of this bond ordinance and to use the proceeds to pay or reimburse expenditures for the costs of the purposes or improvements described in Section 3 of this bond ordinance. This Section 7 is a declaration of intent within the meaning and for purposes of Treasury Regulations.

Section 8. Any grant moneys received for the purposes or improvements described in Section 3 hereof shall be applied either to direct payment of the cost of the improvements or to payment of the obligations issued pursuant to this bond ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 9. The chief financial officer of the Township is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Township and to execute such disclosure document on behalf of the Township. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Township pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Township and to amend such undertaking from time to time in

connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Township fails to comply with its undertaking, the Township shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 10. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy *ad valorem* taxes upon all the taxable real property within the Township for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 11. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

Mayor Nock:

Rich Brevogel:

Now is this the one that Mr. Craig spoke to. Is there any answer for Mr. Craig at this Public Hearing?

Regarding the... I believe Mr. Craig was referring to two documents. As far as the 150 thousand dollar software purchases that is the second payment on a system that will consolidate three systems that we currently use. Our annual maintenance will be equivalent if not less than the cost of those three systems and it will allow for integration of those three systems. So, we will be able to provide information to our residents. We will be able to generate letters that are now manually generated for rental inspections, annual rent inspections, COs thing of that nature. So it is the consolidation of three systems into one system.

I believe he asked about Code Enforcement salary and wages. The majority of the department itself generates a little over a million dollars in fees and permits. The majority of that is (inaudible) instructions fees and permits. So they do cover most of their cost, but Code Enforcement is a normal part of these fees; I believe it was 2 hundred and 12 thousand dollars in fees. So, they... actual we get more complaints that they need more and the residents complain that we need more Code Enforcement officers out there making sure residents are being maintained. I don't know if that answers the question, but...

Ms. Harvey asked about the JFK Center roofing repair. We had a leak in the emergency management area. But there are several areas of the Kennedy Center that are not associated with the solar that I have asked the engineer to evaluate for repairs, but we are doing a full evaluation of that building. And, I think you We put an extra 9 hundred ask about room renovations. thousand dollars into the capital budget this year of 4 hundred and 75 thousand dollars will be addressed tonight in the agenda relative to notice of violations from the Fire Marshall. We had to put fire doors in each egresses into the Kennedy Center based on the change of use several years ago, probably five or six years ago. And, then, as far as room renovations the Council asked me to take a look at spacing. We are going to be modifying the elevator to make it assessable; it is currently a freight elevator we are going to make it assessable like a normal elevator to go to the second floor. And then we are in the process of identifying

who occupies what rooms and then I will had a conversation with the governing body about the future of the Center and those room renovations is basely to make those rooms usable and bring them up to code for whatever entities that would like to bring into that facility.

Mayor Nock:

Hopefully that answers everyone questions-- council anything about the Public Hearing? Need a motion.

ORDINANCE NO. 2019--2

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

(N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Township Council of the Township of Willingboro in the County of Burlington finds it advisable and necessary to increase its CY 2011 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Township Council hereby determines that a 1.0% increase in the budget for said year, amounting to \$ 396,167.82 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Township Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years;

At the last Council meeting I discussed with Council what the game plan would be. After we identify what the problems are. So, we are paying an independent professional to evaluate, and the engineering firm to make sure what they did was correct and protect the Township interest.

So, I just want the people to know.

Public Comments (Second part):

Shirley Dilworth, Newport Lane:

I have a few things that I am concerned about that I would like to share with Council. One is potholes repairs. We have a... is there a schedule, calendar for repairing potholes? There are two very bad potholes on Van Sciver Parkway near Hampton Drive. The second issue of concern is my inability to contact and leave a message for the Code Enforcement person, the Code Enforcement person for Garfield Park North. I have contacted Code Enforcement person four times and I have not been able to leave a message on the answering machine, because it constantly savs it's full. The other issue of concern is properties on Newport Lane. Now, in my estimation these are properties that need to be watched: 48 Newport Lane, 6 Newport Lane and 31. Two of the properties are being restored. There are dumpsters on one of the driveways and the dumpster has been there for about two months. At 31 Newport Lane, it's difficult to tell whether the house is being occupied, but there are three trash containers, filled with trash on the front of the property that has not been put out for weeks. The other issue of concern is the Public Works Department, two week ago I called with a concern about broken glass at the intersection of Van Scriver Parkway and Levitt Parkway and the employee told me that is a County

road, Ok, and he did not say that he would go out there to take care of it or he would pass the information on to the appropriate county department. It doesn't make a different, to me whether it is a county road or township road. If you have broken glass at that intersection it affects residents of Willingboro. It's also a crosswalk for children passing and you know; if we have employees who are unwilling to do their job then perhaps they should not be employed by the Township of Willingboro. The last thing that I am concern is about on Van Sciver Parkway there is a down street light and it has been down for at least three I finally contacted PSE&G today to give them the location of the light pole. I didn't have the exact number of the poles because it is on Van Sciver Parkway and it is very difficult to stop there, to find out what the pole number is. This pole is between Hazelwood Circle and Hawthorne Lane, Ok, after I talked to PSE&G today to find out -- so PSE&G told me that typically, this is something that would be reported by the Police Department. I am just disappointed that the Police Department has not reported that down street light in three weeks. I am sure that someone has noticed it besides me. Thank you so much

James Hall, Tiffany Lane:

I came here tonight to share with you some of my concerns; I am with the Police Athletic League. And we have a hand full of volunteers who go out and serve the kids in the community. They donate their time, talent and their expertise. Sometimes we donate our money, but our services are provided for free for the kids of the community. But unfortunately I hate to always kind of show up when there is something negative to say. You all are doing a great job. I am serious, I mean that, but I am here tonight to articulate a frustration. Some would say I am being overly diplomatic; it is extremely difficult to get things done in Willingboro. Volunteer organization and I just wanted to share with you a few of the things we have experienced within the last two weeks. It is baseball--softball season right now, so in the past we use to managing our own fields. This guy right here, pretty much the point guy for our fields. The reason is because when the Township comes out to manage the fields they go over our bases. They destroy our bases which incurs cost for the program. This has happen twice in the last month. We have shacks where we store our stuff: supplies, equipment, lines for the field so on and so forth. One of our shacks tonight... we show up, we have practice with my daughters, and the shacks are locked. The locks are changed, no notification, no notice, we

can't get in there. We have our equipment and supplies we need for practice in there. We have no idea why the locks were changed. The locks have been there for two years. No notice, no heads up, no nothing. Season starts generally toward the end of March it is kind of cold, it gets dark early, so usually by April 1st we are out there on the fields practicing getting ready for your games. We were told by the Rec Department that we can't turn on the water to wet the fields down because that soften the soil and ground and don't want the kids to get hurt when they are out there practicing or playing until the end of April, our game starts April 13th so we had these hard fields which are an inquiry risk for the kids. So, these are just a few of the examples that I could sort of share about the experience of trying to be a volunteer organization in this town. And so, what I would like to do is just sort of remind folk that the community needs people to serve and we want to serve. Please do not make it difficult for us to serve. It is very difficult to get volunteers. It is so difficult to get volunteers that kids are going to other communities. Where they don't have problems with volunteerism and what we are trying to do is stand up a program independently as a good model for how to do business and restore your community. I am going to give you my goals so you will understand I am not just here grapping. What we would really like is to know how best to move ahead to prevent these problems and who is the point person that will be the person that has the power to do. Not just somebody to talk to, but to somebody to say OK I got this; we are going to do this. If you could give me those things we are willing to move ahead and let those thing be gone, but you guys should know this kind of stuff is happening and I am not casting... I am just saying we are volunteers, we are here, and we are trying to get it done. We need your help. Thank you.

Harry Colely (sic) from Sewell, NJ:

I am a contractor. I got a call on December 4th from Chuck from the MUA about a broken sewer line on North Pond Road. We met with them out there we gave them all our work orders, all our rates and everything under the supervision of Willingboro. We worked out there we gave our bill, turn our bill in December 7th. The reason I am coming to you because I gave them the bill-the MUA. They said make it out to Willingboro MUA, now you are the mayor that's why I am here. We haven't been paid. 120 days when I call there now they tell us, it above their pay grade call the solicitor. I have called the solicitor four times.

Cristal Holmes-Bowie, Esq.:

Hold on. I know he has time. I can response to some of this. First, the Willingboro Municipal Utility Authority is a completely separate legal entity from the Township. So the Willingboro MUA has their revenues, they have their expenses, they have their vendors, they pay them etc. and apart from... So, I just want to clarify, you have not been calling my Office. I am the solicitor for Willingboro Township. There is a solicitor Reilly and Reilly exactly. A different firm, I just want to clarify.

Harry Colely (sic):

I am not picking on you. I am just saying it has been 120 days I am going to need a little help.

Mayor Nock:

Let me say this, at least one commissioner in here. three commissioner in here as well as the chairman and I suggest...

This is a lot of money above and beyond salaries for part-time employees. So where is this money being spent? What is it being spent for and who is spending it? So maybe you can be prepared a report for what each Council member spent with this other expenses of \$71,800 from last year. I keep saying this we have to be accountable for what it is. If it is something that is justified that's really needed Ok, but you guys are projecting that this year you are going to spend \$95,500; that's \$12,000 more than your salaries and it is other expenses. What kind of other expenses is this? This is one hell of an expense account for you guys to be spending and talk about raising taxes on residents. That's it.

Mayor Nock:

Mr. Craig Stevens, I appreciate (inaudible), but I have not seen that kind of number. We will wait for it. I will get it through the Township Manager and we will talk about it, OK.

Good evening everybody my name is Nematullah:

I really hope if there are any parents out there who are interested in knowing a little bit about Special Ed for all of them or any other resource please be there for the Fair, it is on May 8th in the evening at the Country Club Administration Building, 444 Beverly Rancocas Road. If you have any questions please feel free to reach out to me. I have my practice right by the Willingboro High I also tried to get in touch with the High School athletic trainer to be able to participate in the concussion injuries, the strain inquiries, the muscle tear pathologies, to be able to put our children back to be able to go to sports. Prevent re injuries and to keep them healthy for on season and off season sports. I also will be hosting a Westampton Senior Talk tomorrow, and I have been trying to host a similar Senior Talk in our town, in our neighborhood, but I am not finding the right person to contact with, I am working on that. But, if you guys have any resources or any feedback, please let know I am in the community. I am ready to help. I just don't have the resources. I don't know the people. Again, this is my practice for Physical Therapy and Occupational Therapy. We take all insurances and every condition, (inaudible), Parkinson,

stroke, (inaudible), stroke, dizziness, sporty girl. Lot of my patients are looking me up on the internet on google through their health insurance plan and they are reaching out to me. I would appreciate any feedback anybody has or if anybody have any questions about physical therapy, for Special Ed services in the school district. I know children do get Special Ed during their school time. There are providers that are actually treating in school, but there are some things that are beyond their scope and children will benefit from outpatient services. WILLINGBORO TOWNSHIP CAPITAL PLAN DISCUSSION April 16, 2019

Storm Water Infrastructure

The township MS4 system repairs was being allocated less than \$400,000 dollars until 2017. Currently there is \$500,000 allocated in the 2019 budget. Future years could expect to spend \$4 to \$6 million dollars on the repairs listed. This does not include any new issues that may arise.

\$6,000,000

PAVEMENT MANAGEMENT

The township pavement management was being allocated \$1.25 million dollars until 2017. Currently there is \$475,000 allocated in the 2019 budget. Future years should include a minimum of \$1,000,000 dollars to attempt to get on a 25 year cycle. The engineer's recommendation 10 years ago was to allocate \$3,000,000 per year.

\$6,000,000 (based on \$1.5 million per yr.)

BUILDINGS/GROUNDS

A strategic plan for the use of the JFK Center needs to be adopted and followed. Random room assignments and utilization need to be ceased and planned out. The "known" list of requests / wishes are estimated to be in the area of \$6 to \$7 million dollars*.

\$7,000,000

*Includes Performing Arts Center (\$2.2 million), Athletic Turf Fields (\$1.7 million), and \$1.0 million in Parks/Pools/Playgrounds

MAJOR EQUIPMENT 2020 -2023

Major equipment replacements can be evaluated year to year. The 5 year request plan includes an estimated \$6,115,000.

Total over 5 year Plan

\$25,115,000.00

The township just issued a general obligation bond in the amount of \$12.2 million dollars. The debt service (principal and interest is \$657,000 per year for 22 years).

In 2023 the debt service for the township will decrease by approximately \$1.5 million in 2023 and another \$1.0 million in 2024.

This dip in the debt service will allow the township to strategically plan expenditures using BAN's (Bond Anticipation Notes) in the next few years to fill in the gaps in future years while doing the improvements over the next several years.

The information above is worst case scenario and does not include stretching out priorities and equipment purchases based on the equipment conditions or shifting priorities at that point in time.

 - ii. Need to perform field visit with DPW to assess.
 - Funding?

The township MS4 system repairs was being allocated less than \$400,000 dollars until 2017. Currently there is \$500,000 allocated in the 2019 budget. Future years could expect to spend \$4 to \$6 million dollars on the repairs listed above. This does not include any new issues that may arise.
