PUBLIC COMMENTS ON AGENDA ITEMS

Mayor Nock: We will come back to that because I think it is critical for the public to know that piece. So let's do any public comments on the ordinances that are before us and we will come back to the presentation. Any comments on ordinances or resolutions?

Pat Lindsay-Harvey, 12 Hadley Lane— Resolution 113, 114, 115, 116 we already had an increase on legal \$200,000 from 2018-2019, now we have an additional \$50,000, \$85,000 and \$25,000. We are almost \$400,000 more for legal. How is that going to impact taxes, that additional money that was not in the budget before?

Mayor Nock: Anyone else. Mr. Brevogel you have an immediate answer to that.

Rich Brevogel: I can tell you that the not to exceed value for all of the professionals within the municipality is less than 50 percent spent and at the end of the year we will do transfers like we always do in November to fund these, but these are tied to litigations.

Mayor Nock: The budget is already set so there is not an increase in taxes. This is just moving money around and increasing certain contracts. I want to remind you, residents that about a year or two ago of the contracts were reduced when a former mayor reduced, got the Council to reduce of the normal standard amount that we had given them. We reduced it by 15 or 20 percent; 15 percent and that was to me artificially low at that point, so it is not an increase in taxes. We are just moving dollars around and we still have employee litigations to do. So are we ready...?

ORDINANCES

ORDINANCE NO. 2019-4 --(FIRST READING)--TABLED

AN ORDINANCE SUPPLEMENTING AND AMENDING CHAPTER 150 OF THE TOWNSHIP CODE OF THE TOWNSHIP OF WILLINGBORO ENTITLED "FEES" TO ALLOW FOR THE COLLECTION OF A FEE FOR THE MAYOR TO SOLEMNIZE MARRIAGE OR CIVIL UNIONS TO BE KNOWN AS CHAPTER 150 SECTION 17.

WHEREAS, pursuant to N.J.S.A. 37:1-13, “any mayor or deputy mayor when authorized by the mayor... [is]... authorized to solemnize marriage or civil union between such persons as may lawfully enter into the matrimonial relation or civil union” ; and

WHEREAS, any fee collected by a mayor or designee of the Mayor, as authorized by statute, for the performance of a marriage or civil union ceremony must be authorized by ordinance and deposited into the municipal current fund; and

WHEREAS, the Township may establish a fixed fee for the service performed by the mayor or reimburse the Mayor for out-of pocket expenses for performing marriage or civil union ceremonies provided the township has adopted a fee ordinance in accordance with N.J.S.A. 40:48-1(4); and

WHEREAS, the fee for performing marriage or civil union ceremonies must be deposited into the current fund, payable to the municipality; and

NOW THEREFORE, BE IT ORDAINED by the Township Council of the Township of Willingboro in the County of Burlington:

1. The Township of Willingboro hereby authorizes the collection of a fee for the performance of a marriage or civil ceremony by the mayor or his/her designee, as authorized by statute; and
2. The amount of the fee for the performance of a marriage or civil ceremony shall be \$75.00.
3. The mayor or his designee, as authorized by statute, shall be reimbursed for directly related out of pocket expenses for performing the marriage or civil ceremony; the authorization for the provision of reimbursement shall be in accordance with an established schedule for mileage, and direct cost reimbursement for other expenses documented by receipts; the reimbursement will be provided by voucher with appropriate documentation, authorization, and expenditure from the appropriate budget line item.
4. All fees must be made payable to the municipality, may be collected by the mayor, and shall be deposited in the municipal current fund.
5. Any increase in the fee may be set by resolution by township council.
6. The mayor may suggest to a party that a voluntary contribution be made directly to a charitable organization in lieu of payment of the fee. However, the mayor may not require a contribution to a charity or require any specific charity. The mayor may require proof of payment of the voluntary charitable contribution before conducting the ceremony.
7. If any section of provision of this Ordinance shall be held invalid in any Court of competent jurisdiction, the same shall not affect the other sections or provisions of this Ordinance.
8. All Ordinances or parts of ordinances which are inconsistent herewith are hereby repealed to the extent of such inconsistency.
9. This ordinance shall take effect immediately after the final passage and publication as provided by law.

Discussion:

- Mayor Nock: At this point when we are talking to the solicitor—we had said this would probably would not be on the agenda for discussion. I am just curious.
- Cristal Holmes-Bowie, Esq.: The ordinance was basically forwarded to the Clerk. And it is up to Council whether they wish to table it as oppose to having the first reading; with the first reading, Council can make any changes or any recommendation with regards to the ordinance. The reason it is presented is, it is an ordinance we don't have any ordinance in place with regards to this and, basically the State; if there are fees that are collected the State has a particular process that they want municipalities to abide by; and in order to collect fees there should be an ordinance in place; that's basically the reason for it. The language in it is up to Council or public to tweak that language.
- Councilwoman Jennings: (Inaudible), municipality?
- Cristal Holmes-Bowie, Esq.: Yes, these fees will be going to the municipality. There is an option in the ordinance that allows the Mayor or Deputy Mayor to offer the participant the ability to make a charitable contribution, but, it would be a contribution to a charity of their choice; in lieu of paying the fee, so that's the only addition to this.
- Councilwoman Jennings: (Inaudible)...
- Cristal Holmes-Bowie, Esq.: No, the fee in here is \$75.00, which is most of them. This is making it a fee...
- Mayor Nock: But, you have the option of donations and so forth. You explained it there is still a possibility of a donation.
- Cristal Holmes-Bowie, Esq.: An individual or the parties would be able to make a donation. The Mayor could allow them to make a charitable donation; however, the party is the one who chooses the charity.
- Councilwoman Jennings: Now, I ask how that is going to work with them doing a charitable donation. It seems like that's a little more paperwork. Maybe I am wrong but, how—so we ascertain the donation was made, to whom it was made. Do we have to have relationship with these people?

Cristal Holmes-Bowie, Esq.: The State allows this little area, so people can make contributions instead to charity. We really don't lay out a whole lot of detail in terms of that process; however, you know typically, when you make a contribution to a charity you do get some kind of receipt, that's the only things a Mayor or Council person could request, but it is up to the Mayor to do that.

Councilwoman Jennings: I think we need to do more research on that because it seems to me—are we marrying them and they are doing the donation and then they are bringing the receipt.

Cristal Holmes-Bowie, Esq.: That's not that the ordinance is not necessarily laying out the whole process. The process, I think would be maybe more particularly setup by Finance in terms of what comes in and what kind of requirements; similar to for example your reimbursements. One of the things it allow for a Mayor or Deputy Mayor to be reimbursed out of pocket expenses; so I am not going to lay out what that process is because that's a process you already have and already follow,. Finance already has that process for you and I think this is a similar process. I don't have a problem with it being tabled for there to be additional research. I have not a whole lot of information out there about that. I will be glad to go back and look at it.

ORDINANCE OF THE TOWNSHIP OF WILLINGBORO, IN THE COUNTY OF BURLINGTON, NEW JERSEY PROVIDING FOR THE RE-APPROPRIATION OF \$48,308.00 IN UNUSED

DEBT AUTHORIZATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSES IN ORDER TO PROVIDE FOR AUDIO AND VISUAL EQUIPMENT FOR COUNCIL CHAMBERS/COURT ROOM AND VARIOUS TECHNOLOGY AND NETWORKING EQUIPMENT.

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WILLINGBORO, IN THE COUNTY OF BURLINGTON, NEW JERSEY (not less than Two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. Pursuant to N.J.S.A. 40A:2-39 , it is hereby determined that certain debt authorizations in the aggregate amount of \$48,308.00 provided for in the various ordinances listed below are no longer needed for the purposes referenced therein. A RESOLUTION AUTHORIZING THE EXECUTION OF CONDITIONS OF AUTHORIZATION WITH STATE OF NEW JERSEY DEPARTMENT OF COMMUNITY AFFAIRS TO CONDUCT INSPECTIONS OF HOTELS AND MULTIPLE DWELLINGS

WHEREAS, the Township has requested and received authorization to participate in the State Local Cooperative Housing Inspection Program of the Department of Community Affairs to conduct the State mandated inspection of hotels and multiple dwellings within the Township; and

WHEREAS, the authorization to conduct the inspections is based upon the requirement that the inspections and their related activities be conducted in strict accordance with the Conditions of Authorization attached hereto.

WHEREAS, the State has allocated the sum of \$500.00 to conduct the inspections.

Councilwoman Jennings: I thought it was important for the residents to know that this was one of our original neighborhoods renovation properties. We had ten; we got 2.5 million from the State to do it. This was the last property and we are not going to rehab this; however, it's going to be for a single family use. It will not be used for group homes.

Mayor Nock: New Business, old business...

Councilman Anderson: I just wanted to touch bases to see if we have an update on the certificate of occupancy ordinance?

Cristal Holmes-Bowie, Esq.: I do not. I am sorry.

Councilman Anderson: Is there an update on BTSA ordinance?

Cristal Holmes-Bowie, Esq.: There were a number of changes that were recommended. The last time I had conversation with council and also with the Inspections Department; the question was whether they can implement their pilot program using the ordinances that are in place. BTSA indicated that would be problematic for them; however, I did research other municipalities and the significant changes that they requested were not necessarily put into the ordinances in those municipalities. I think that we can go back to them and ask that they implement their contract and

the pilot involving the ten properties using the township ordinances as they are in place.

Councilman Anderson: Is there an update on the concrete seal? I know we were going to do concrete work out front where we are going to implement the new seal—is there an update?

Rich Brevogel: I just got information from the engineer today and we are evaluating that with the replacement of the steps going into the Police Department as well as the walkway out here.

Councilman Anderson: Thank you.

NEW BUSINESS

Councilman Anderson: In light of the shooting in Virginia Beach at the municipal building. I would like to recommend we start using the metal detector in our municipal building. I know I had spoken to you about it, but I just want to go on record for whatever we need to do. I think we need to be proactive. There was a shooting the other day where a sniper was picking off folk at the municipal building, but I think if we have these devices... We need to see what needs to happen and we can implement it whether it is a plan-- the best way to utilize for the safety of the residents. Also, I had a conversation with Mr. James Hall from Pal Baseball he indicated he got the keys to the Concession Stand and so forth, but when they went to water the field the water meter had been removed. So, they just wanted to know... He said they were informed that the water meter had been removed and they want to know what it will take to have it put back, so this way they can work on watering the fields themselves. I know we had a discussion about putting together a capital budget meeting so we can discuss some of the upcoming projects such as the auditorium, the turf field and whatever else you wanted to discuss, so, wanted to know if we can actually get a date together so we can sit down.

Deputy Mayor Perrone: New business—I met with the Library, I had a tour there and some concerns that they don't have a representative from Council. I wanted to know who was assigned the liaison. They would like to have a meeting or have some frequent presence as far as meeting with them, so they can bring back information. And they did leave

me with some concerns that they have and I guess I can talk to you about them off line.

Councilman Anderson: I am the liaison for the library.

OLD BUSINESS UPDATE

Deputy Mayor Perrone: Do we have an date on the completion of the meeting room for the buffalo soldiers?

Rich Brevogel: We have had to engage the municipal engineer in evaluating the whole lower level of the JFK Center to make sure that all the MEP electrical HVAC. So we have to make sure that we take the upgrades we are going to make based on that being an office area and tie into the electrical system for the LRC area that's being renovated for the changes you want to make for accommodating that area. Once that is done we are going to start modifying; so it is going to be another month or month and a half before we start.

Deputy Mayor Perrone: And when you start do you have a rough idea how long it will take?

Rich Brevogel: Once we know what we need to do electrically, we can start doing the actual renovation of the room and the electrical portion of it can be incorporated in that. We can do the painting, floors, and ceilings. We are looking at slip level units in terms of HVAC air conditioning for each individual room and we are trying to get price structure to figure out how many rooms we will be able to do with the money allocated.

Deputy Mayor Perrone: Did we have any updates on the Andy Kim coming over?

Mayor Nock: He is here. I think Open House is next month, the beginning of next month.

Rich Brevogel: If I may elaborate on Councilman Anderson's comments regarding metal detectors and that whole security level. I think it is going to be cumbrance upon the Council and the residents to understand that those changes may be inconvenient but they are necessary and unfortunately we have met a lot of resistance particularly at the Kennedy Center with individuals coming in and feeling they don't need to sign in. We are going to set the standard in how you enter and egress the building to meet the concerns in light of what happening and particularly of what happen in Virginia. So, once

we start that process we might have some difficult bumps in the road, but it is meant to keep everyone safe. In case you hear anything be prepared.

Deputy Mayor Nock:

I have a statement I would like to read in moving forward. On January 25th the Council received a letter from our Acting Township Manager, Rich Brevogel on his intent to step down from the Acting Township Manager position. We then received another email saying he will be stepping down on May 7th after the budget process. After several conversations with Mr. Brevogel we were able to convince Rich to stay on as we were concluding our interviewing of potential candidates. So for the past several month Council has been conducting interviews for Township Manager. We were able to reduce the pool of candidates first to five finalist and then to three and now one, I am pleased to announce that I am asking for a motion to announce Dr. Sharon Rogers of Willingboro to be our new Township Manager beginning July 1 depending upon satisfactory completion of all clearance and execution of contract with the Township. Can I have a motion?

Councilman Holley:

So moved.

Councilman Anderson:

Second.

Mayor Nock:

Hold on—discussion.

Deputy Mayor Perrone:

So, we are in discussion, I want to be clear. Yes, I do have discussion, to the public and to my fellow colleagues I take my job very seriously, I don't take it lightly and we have had several meeting as Council and we discussed verbatim of what type of candidate we are looking for, and we, all five of us we are looking for someone with a business administration background, someone who has a finance background, someone who probably has a public administration background. Just to read off some of the... not to mention their names of some of the candidates. One of the candidates has a master's in public administration, another candidate has a director of finance of three years, another candidate has a budget analysis of five years, another candidate is an attorney, another candidate is a HR Director, five years; another candidate business administrator for five years. None of these qualifications does Sharon Rogers have. So, what I am asking Council... I have a question and a direct question to each Council--

I want to be able to vote for this person, so I want you to help me identify some of the qualities and qualifications that we have discussed for this position. My first question is to Councilman Holley; please identify one category of qualification that Sharon Rogers exhibits.

Mayor Nock: I don't know if that...

Deputy Mayor Perrone: That's a question, a direct question and that is allowed according to Robert's Rule of Order, it is allowed and I have the floor now and that's the question to Darvis Holley.

Darvis Holley: I don't feel comfortable in answering that question.

Deputy Mayor Perrone: Ok, then, Jackie Jennings. Councilwoman Jackie Jennings, the question is to you.

Darvis Holley: I didn't finish answering my question.

Deputy Mayor Perrone: You said you didn't feel comfortable. I am sorry.

Darvis Holley: I don't feel comfortable, but I am going to finish my statement.

Deputy Mayor Perrone: Ok, go ahead.

Darvis Holley: I don't feel comfortable answering that question publicly, as this was conducted as a personnel matter and I am going to just leave it at that. I am not going to get into specifics. I believe the candidate is highly qualified for the position.

Deputy Mayor Perrone: Councilman Jennings, can you identify an attribute of a category that we discussed as far as qualities acceptable for Township Manager that this candidate has?

Councilwoman Jennings: I am going to have the same response, because I...

Deputy Mayor Perrone: This person is not hired. By the way this person is not an employee...

Councilwoman Jennings: I think the person that was chosen was the most qualified person; although many of the other candidates had the attributes that you listed. They did not make the final list because of one reason or another, and so, I think what I was personally looking for was some of the qualities that you said, but what was most important to me was the person who was going to be the best for Willingboro

Township. I think that's what Dr. Rogers bring to the table. Beside her PhD she is not simply going to be a Township Manager, and this I saw from her very first interview, which I clearly said previously this is not the first time I am sharing this with my fellow Council members. She is going to, I believe, put Willingboro on the map and that's what I am looking for more than a person who has been administrator, more than a person who has been a finance manager, because I believe that she brings all of that. I did not feel that she was unqualified in those fields and so I am comfortable in the decision that I thought was unanimous frankly, and I am sorry to hear that that is not the case, but I feel very comfortable in choosing Dr. Rogers for this position.

Deputy Mayor Perrone: Nathaniel Anderson, Councilman Anderson did you identify any finance background on this candidate?

Councilman Anderson: Once again, as Councilman Holley said, for me it is a personnel issue but what I will say is I do support Dr. Sharon Rogers.

Deputy Mayor Perrone: Mayor Nock do you identify any business administration or finance background or public administration experience on this candidate?

Mayor Nock: Well, my answer to that Deputy Mayor, is one she does have budgetary experience from her previous position, but A, B we have a Chief Finance Officer and I have also spoken to Mr. Brevogel to make sure that aspect that you are concerned about that she will certainly be fine with it. We do have a Chief Finance Officer whose responsibility is the finance of the Township. B, in your remarks, yes all those things are great but that was not sentiment on Council as polling Council members that we would bring somebody from the outside. It was not enough votes for some of these candidates who did not live here. So, when you have to add all of the stuff up, in my option, Dr. Rogers is the best, as I have told you privately several times, that is the best candidate for this. I told you several times as I spoke to each person, individually, except for one person who i did not have a conversation with, but when you add all the stuff up... All these folk are great, but they did not live in Willingboro and there were not votes to waive the Willingboro residency; especially when we had folk in Willingboro. So, I do understand your sentiment, because we have gone back and forth, but at the end of the day... We have started

this process. Mr. Brevogel has certainly given us notice to go. Dr. Rogers is qualified, if not we will do everything we can to make sure she is an outstanding Township Manager. I will do my part and this is the result that we all agreed on when we got down to finalize that we had and that's all I am going to say about it.

Deputy Mayor Perrone: Thank you. And, just for the public I ask them that directly because they are all aware she is not qualified for this position. We have a 77 million dollar...and this is my option and I can voice my option. I understand she is not an employee. She does not need to be Riced. She is somebody we are considering to vote on until we vote. So, yes I can voice my option, ok, and she is not qualified and we did discuss what we are looking for; for a person to manage this town, Ok. She has spent her entire career working at BCC as an Assistant Dean, not as an administrator of budgeting; therefore, for the record I am not in support of this candidate and for that reason I am voting no, ok and we are at will state, at will, will; therefore if I am not satisfied definitely believe I am putting Willingboro first and if you are not doing a good job you will-- at no reason I have to give you, but I am letting you know now. The reason would be because I feel you are not qualified for this job. Thank you





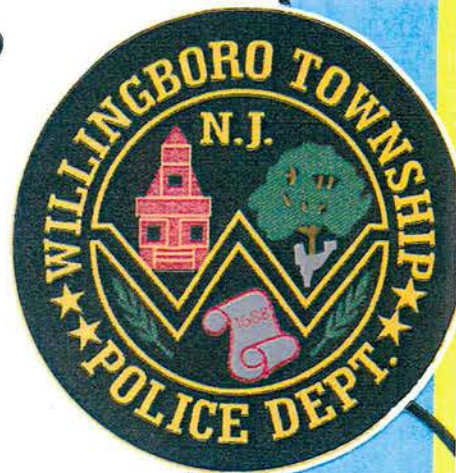
