RESOLUTION 2019- 8

TOWNSHIP OF WILLINGBORO PLANNING BOARD RESOLUTION MEMORIALIZING PLANNING BOARD'S FORMAL REQUEST FOR ALLOCATION OF FUNDS FOR TOWNSHIP MASTER PLAN

WHEREAS, the Township of Willingboro Planning Board is a land use board tasked with, inter alia, review of applications for development for site plan and subdivision approval, make recommendations to the Township Council on any proposed changes to the land use ordinance, and grant conditional use or bulk variances in association with subdivision and site plan applications; and

WHEREAS, the Township of Willingboro Planning Board is also responsible for the creation and adoption of the Master Plan for the Township of Willingboro; and

WHEREAS, the Township of Willingboro last completed a full Township Master Plan in 1990; and

WHEREAS, the 1990 Township Master Plan was amended three times, specifically in 1997, 2008 and 2015; and

WHEREAS, the principle goals of the 1997 Master Plan amendment were to: (1) set up the possibility for the Route 130 Redevelopment Plan; (2) discuss senior housing and the Township's need; and (3) address issues regarding underutilized school facilities; and

WHEREAS, the 2008 and 2015 amendments were strictly updates to the Township's Housing Element as a direct result of changes in New Jersey's affordable housing process; and

WHEREAS, pursuant to the requirements of Section 89 of the Municipal Land Use Law, N.J.S.A. 40:55D-1, et seq., the Planning Board conducted a reexamination of the Township Master Plan and development regulations, prepared a report on the findings of the reexamination, titled, "General Reexamination of the Master Plan, Willingboro Township, Burlington County, New Jersey," which was duly adopted on March 29, 2018 ("2018 Master Plan Reexamination"); and

WHEREAS, the 2018 Master Plan Reexamination concluded the following:

This reexamination report concludes that while the 1997 Master Plan and 2006 Reexamination remain viable documents for the advancement of planning policy necessary for the future arrangement of land within the Township, the Township should consider the preparation of a new comprehensive master plan to revise and consolidate the goals and objectives, and to create a unified document containing multiple elements which would help to guide the Township's future development. Elements for consideration in the new master plan should include: Goals and Objectives, Circulation Plan, Housing Plan, Land Use Plan,

Recreation and Community Facilities Plan, Conservation Plan, and Green Building and Environmental Sustainability Plan. Additionally, while not critical, based on the 2006 Reexamination's reaffirming of goals, consideration should be taken towards the future inclusion of a Historic Preservation Plan.

WHEREAS, based on the foregoing, the Willingboro Planning Board desires to update the Township Master Plan in accordance with N.J.S.A. 40:55D-28 and as recommended by the 2018 Master Plan Reexamination; and

WHEREAS, the preparation of a new Township Master Plan will include, but will not be limited to, public hearings, committee meetings and consultation with a planning consultant and licensed professional planner; and

WHEREAS, since 2017, the Willingboro Planning Board has made ongoing requests to the Township Council for the necessary funding to prepare a new Township Master Plan; and

WHEREAS, the Willingboro Planning Board will seek to utilize resources to assist in the preparation of the new Township Master Plan, including, but not limited to, resources provided by the Burlington County Economic Development Office, Edward J. Bloustein School of Planning and Public Policy School at Rutgers University (or other similar university), and the Delaware Valley Regional Planning Commission, in order to limit/reduce costs incurred by the Township; and

WHEREAS, notwithstanding, the Willingboro Planning Board recognizes that there will be expenses incurred in the creation and finalization of the Township Master Plan, including but not limited to, the execution of the Township Master Plan by a licensed professional planner and other professional services; and

WHEREAS, this Resolution memorializes the budgetary needs for such services; and

WHEREAS, the Willingboro Planning Board formally requests an allocation of funds up to \$125,000, in order to prepare the Township Master Plan; and

WHEREAS, the Willingboro Planning Board reserves the right to request any additional monies from the Township of Willingboro and agree to return any surplus monies that are not requested

NOW, THEREFORE BE IT RESOLVED, that the Planning Board of the Township of Willingboro, County of Burlington, and State of New Jersey, on October 21, 2019, hereby requests that the Township Council of the Township of Willingboro, authorize the allocation of funds up to \$125,000, for the preparation of a Township Master Plan.
