A RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WILLINGBORO PROVIDING FOR THE APPOINTMENT OF CONFLICT MUNICIPAL PROSECUTOR, CONSULTING ENGINEER, FAIR SHARE HOUSING SPECIAL COUNSEL, HEARING OFFICER, MUNICIPAL ATTORNEY, MUNICIPAL AUDITOR, MUNICIPAL BOND COUNSEL, MUNICIPAL ENGINEER, MUNICIPAL FORECLOSURE COUNSEL, MUNICIPAL JUDGE, MUNICIPAL LABOR COUNSEL, MUNICIPAL PLANNER, MUNICIPAL PUBLIC DEFENDER, MUNICIPAL PROSECUTOR, MUNICIPAL TAX ATTORNEY, SPECIAL COUNSEL, AND SUBSTITUTE MUNICIPAL PROSECUTOR

WHEREAS, the TERMS OF THE Office of CONFLICT MUNICIPAL PROSECUTOR, CONSULTING ENGINEER, FAIR SHARE HOUSING SPECIAL COUNSEL, HEARING OFFICER, MUNICIPAL ATTORNEY, MUNICIPAL AUDITOR, MUNICIPAL BOND COUNSEL, MUNICIPAL ENGINEER, MUNICIPAL FORECLOSURE COUNSEL, MUNICIPAL JUDGE, MUNICIPAL LABOR COUNSEL, MUNICIPAL PLANNER, MUNICIPAL PUBLIC DEFENDER, MUNICIPAL PROSECUTOR, MUNICIPAL TAX ATTORNEY, SPECIAL COUNSEL, AND SUBSTITUTE MUNICIPAL PROSECUTOR have expired; and

WHEREAS, the services to be performed in such officers are regulated by law and the persons to be appointed are practicing recognized professions; and

WHEREAS, the Township of Willingboro has determined that it is appropriate to implement a fair and open process for the awarding of this contract; and

WHEREAS, the Township requested and received statements of qualifications in a manner that fostered a fair and open process, utilizing the criteria and specific minimum requirement to meet the requirements of the Township; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Willingboro, assembled in Public Session this 1st day of January 2021 that the following appointments are made pursuant to N.J.S.A.-2B:12-27 for a term expiring December 31, 2021 unless otherwise indicated.


