WHEREAS, the Township Council finds that the services are being performed in an effective and efficient manner; and

WHEREAS, the term of the contract, as extended, shall not exceed five years; and

WHEREAS, any price change included as part of the extension shall be based upon the price of the original contract as cumulatively adjusted, and shall not exceed the change in the index rate for 12 months preceding the most recent quarterly calculation available at the time the contract is renewed; and

WHEREAS, the Township Council has determined that it is in the best interest of the Township to extend the contracts with Patriot Roofing, Roof Management, Inc., and M.D. Remodeling, LLC. for one year from March 18, 2015.

RESOLUTION -- 2015-145

RESOLUTION-OF THE COUNCIL OF THE TOWNSHIP OF WILLINGBORO ENDORSING AND SEEKING COURT APPROVAL OF A HOUSING ELEMENT AND FAIR SHARE PLAN ADOPTED BY PLANNING BOARD

WHEREAS, on November 9, 2015, the Planning Board of the Township of Willingboro, County of Burlington, State of New Jersey, adopted an amended "Housing Element and Fair Share Plan" of the Master Plan (hereinafter "2015 Housing Element and Fair Share Plan" or "plan") without prejudice to the right to adopt an amended plan, once the Court determines fair share and compliance standards (hereinafter collectively "Standards") with which the Township must comply; and

WHEREAS, a true copy of the resolution of the Planning Board adopting the 2015 Housing Element and Fair Share Plan without prejudice is attached hereto as Exhibit A; and

WHEREAS, the Township has filed a motion with the Court urging it to establish Standards before requiring the adoption, endorsement and filing of an affordable housing plan; and

WHEREAS, the Court has denied the motion, thereby warranting the adoption of a plan out of an excess of caution in the absence of Standards from the court so that the Township can increase the likelihood that it will be able to use the public's resources to comply and not have those resources wasted on exclusionary zoning litigation; and

WHEREAS, the Court will have to decide the Standards that will apply before it can evaluate the Township's ultimate plan; and

WHEREAS, accordingly, the Planning Board adopted the 2015 Housing Element and Fair Share Plan without prejudice and reserved all rights to amend the plan once the Court determines the Standards by which it will evaluate the Township's ultimate plan; and

WHEREAS, it makes no sense to require the adoption of a plan before the establishment of the Standards by which the Court will evaluate its plan, but the Township has no choice in this matter as a result of the ruling of the trial judge; and

WHEREAS, in light of the above, the Township of Willingboro wishes to endorse the 2015 Housing Element and Fair Share Plan without prejudice, and seek approval of the 2015 Housing Element and Fair Share Plan or an amended plan from the Court.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE TOWNSHIP OF WILLINGBORO:

- 1. That it hereby endorses the 2015 Housing Element and Fair Share Plan as adopted by the Willingboro Township Planning Board without prejudice to the right to adopt an amended plan following the establishment of Standards; and
- 2. That it authorizes and directs its representatives to file with Court (i) the 2015 Housing Element and Fair Share Plan, (ii) the resolutions of the Planning Board adopting and the Township Council endorsing the 2015 Housing Element and Fair Share Plan without prejudice and (iii) any additional documents the representatives deem necessary or desirable; and

- 3. That it reserves the right to amend the 2015 Housing Element and Fair Share Plan, once the Court determines the Standards with which the Township must comply; and
- 4. That it authorizes its representatives to seek Court approval of the 2015 Housing Element and Fair Share Plan, or any amended plan and to ensure that temporary immunity remains in place while the Court and the Court Master review the plan and so that the Township can respond to any concerns of the Court or its Master free from unnecessary lawsuits brought on the basis of the Mount Laurel doctrine.
