A RESOLUTION OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WILLINGBORO APPOINTING WILLINGBORO ASSOCIATES, LLC AS REDEVELOPER OF THE PROPERTY KNOWN AND DESIGNATED AS BLOCK 5.01, LOTS 13.01, 13.02, 13.03, 13.04 AND 13.05 ON THE CURRENT TAX MAP OF THE TOWNSHIP OF WILLINGBORO AND AUTHORIZING THE MAYOR AND TOWNSHIP CLERK TO EXECUTE A REDEVELOPMENT AGREEMENT WITH WILLINGBORO ASSOCIATES, LLC.

WHEREAS, on December 4, 2007, by Township Resolution 2007-174, December 2007, the Township entered into a Final Settlement Agreement in the case of <u>Atlantic Delta Corp. at Montgomery Inc. v. Township of Willingboro and Planning Board of Willingboro</u>, BUR-L-001593-05, a <u>Mount Laurel</u> case ("Settlement Agreement") (Exhibit "A-1"); and

WHEREAS, on June 18, 2008, after a Fairness Hearing, the Honorable John Sweeney, A.J.S.C., entered an Order approving the Atlantic Delta Settlement Agreement (A-2); and

WHEREAS, by Ordinance 2008-2, as amended by Ordinance 2008-6, the Township Council adopted an Amendment to the Redevelopment Plan ("Redevelopment Plan") which sets forth, inter alia, the plan for the redevelopment of the Redevelopment Area in accordance with the terms of the Settlement Agreement which established standards for the development of Atlantic Delta's site; and

WHEREAS, the stated purpose of the Amendment to the Redevelopment Plan was to clarify and expand the permitted uses within the redevelopment zone, to permit opportunity for the construction of an inclusionary mixed use development containing residential and commercial uses and to help satisfy a substantial portion of Willingboro's Mount Laurel obligation pursuant to the Settlement Agreement; and

WHEREAS, said Redevelopment Plan includes property owned by Willingboro Associates LLC, the successor to Atlantic Delta (hereinafter "Redeveloper"), as authorized by the Settlement Agreement known and designated as Block 5.01, Lots 13.01, 13.02, 13.03 and 13.04 on the current tax map of the Township of Willingboro, containing approximately 39 acres (hereinafter, "the Property"); and

WHEREAS, Redeveloper is engaged in the business of real estate development construction; and

WHEREAS, Redeveloper, as the applicant, submitted an application for Preliminary and Final Subdivision Approval and Preliminary Site Plan Approval of the Property to the Willingboro Planning Board, consistent with the uses and design parameters set forth in the Redevelopment plan approved by Township Council and with the Settlement Agreement; and

WHEREAS, the Planning Board determined that both the major subdivision application and the site plan application complied with the Redevelopment Plan as amended and the terms of the Settlement Agreement; and

WHEREAS, by two Resolution 4-2009, adopted on January 12, 2009, and Resolution 5-2009, adopted on January 12, 2009, the Planning Board granted major subdivision and site plan approval to Redeveloper after having determined that the application was in conformance with the permitted uses of the Redevelopment area, as amended, and that all requirements set forth in the Municipal Ordinance and Municipal Land Use Law for preliminary and final approval of a major subdivision were met by the Applicant subject to N.J.S.A. 40A:12A-1, et seq.; and

WHEREAS, pursuant to that certain Planning Board Resolution of memorialization dated January 12, 2009 in the matter entitled "Major Subdivision and Site Plan Application, Block 5.01, Lots 5 & 13, Rt. 130 & Pennypacker Drive and Rockland Drive" referencing application No. 5-2008, the planning board for the township of Willingboro required that certain easements and restrictions encumber the Property; and

WHEREAS, consistent with the requirements outlined in Resolution of January 12, 2009, the Developer has requests to enter into an agreement with the Township, entitled Declaration of Covenants, Conditions and Restrictions; and

WHEREAS, Resolutions Numbers 12-2008, 4-2008 and 4-2009 memorialize on September 8, 2008 by required the Developer to construct a storm water retention and conveyancing facilities to properly contained and direct surface water run-off; and

WHEREAS, the Resolutions also require Developer to be responsible for the proper maintenance, cleaning and repair of said storm water retention and conveyancing facilities to insure that they operate to their design specifications; and

WHEREAS, the Township wishes to enter into a Retention Basin Access and Maintenance Agreement to insure the proper maintenance, cleaning and repair of said retention and conveyancing facilities, in the event the Redeveloper fails to do so in the interest of environmental protection and to protect the public's health, welfare and safety.

WHEREAS, by two Resolutions duly adopted by the Planning Board on September 12, 2008, Redeveloper was granted Final Major Subdivision and Preliminary Site Plan Approval to build an inclusionary development consisting of 450 residential units, of which 70 will be low and moderate income units (Resolutions 11-2008 and 12-2008) (A-4 and A-5); and

WHEREAS, the Township desires that the Property be redeveloped by Redeveloper in accordance with the Concept Plan set forth in the Settlement Agreement, and the subdivision plan and the site plan approval by the Planning Board dated September 12, 2008 and the approval of December 8, 2008 granting final site plan approval and preliminary and final amended resubdivision approval, which approvals are consistent with the Concept Plan; and

WHEREAS, on December 9, 2008, in accordance with the terms of the Settlement Agreement, the Township designated Willingboro Associates LLC, as the Redeveloper of The Property by Resolution No. 2008-176, conditioned upon execution of a Redevelopment Agreement; and

WHEREAS, pursuant to the Redevelopment Law, the parties desire to enter into the attached Redeveloper's Agreement that sets forth the terms and conditions pursuant to which the Property is to be redeveloped in accordance with the Settlement Agreement and the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., Willingboro Associates, LLC is to be designated as the Redeveloper of the Property by the township of Willingboro; and

NOW, THEREFORE, BE IT RESOLVED, by the Township Council of the Township of Willingboro, assembled in public session this 7th day of August, 2009 that the Mayor and Clerk, are authorized to execute an Agreement entitled "Redevelopment Agreement for a Development on Block 5.01, Lots 5 & 13, Rte. 130 & Pennypacker Drive and Rockland Drive in the Redevelopment Area of the Township of Willingboro, Burlington County, New Jersey by and between the Township of Willingboro and Willingboro Associates, LLC," on behalf of the Council, subject to the review and approval of the legal department; and

BE IT FURTHER RESOLVED, that the Mayor and Clerk, are authorized to execute an Agreement entitled "Declaration of Covenants, Conditions and Restrictions Agreement for a Development on Block 5.01, Lots 5 & 13, Rte. 130 & Pennypacker Drive and Rockland Drive in the Redevelopment Area of the Township of Willingboro, Burlington County, New Jersey by and between the Township of Willingboro and Willingboro Associates, LLC," on behalf of the Council, subject to the review and approval of the legal department; and

BE IT FURTHER RESOLVED, that the Mayor and Clerk, are authorized to execute an Agreement entitled "Retention Basin Access and Maintenance for a Development on Block 5.01, Lots 5 & 13, Rte. 130 & Pennypacker Drive and Rockland Drive in the Redevelopment Area of the Township of Willingboro, Burlington County, New Jersey by and between the Township of Willingboro and Willingboro Associates, LLC," on behalf of the Council, subject to the review and approval of the legal department; and
