





In such circumstances, Jasinski and Williams aggressively attacks the employee's claims through discovery and summary judgment motions to prevent an adversary from presenting its case to a jury. This approach to litigation has been very successful for our

·			

clients.

For instance, in <u>Tisha McKenzie v. Babyland Family Services, Inc.</u>, Ms. McKenzie sued her former employer for discrimination, constructive discharge, breach of contract, false imprisonment, assault, defamation and intentional infliction of emotional distress. All claims were dismissed on summary judgment.

Also, in <u>Casseus v. Harbor View Health Care Center</u>, <u>et al.</u>, we obtained summary judgment in State Court dismissing the complaint for a refusal to hire. The Appellate Division affirmed Summary Judgment.

Likewise, in <u>Bell v. City of Atlantic City</u>, <u>et al.</u>, a current employee sued the City of Atlantic City for allegedly violating CEPA. Mr. Bell claimed that he was retaliated against after he blew the whistle on an internal policy. Summary judgment was obtained dismissing the complaint in its entirety.

Effective Trial Advocacy

Instead of capitulating to the plaintiff's outrageous settlement demands, our firm has a number of well respected, experienced lawyers ready to successfully defend our client's decisions at trial.

For example, this firm won a major trial victory in a whistleblower case in which a 20 year employee challenged the decision to terminate him. In Haffy v. Hackensack University Medical Center, the former director of biomedical engineering tried to conjure up a theory that his termination was somehow related to his disagreement over the use of cellular phones and laptop computers in critical care areas of the hospital and, therefore, entitled to protection under CEPA. After 8 days of trial, the Court granted our motion to dismiss Mr. Haffy's case on directed verdict. (See Exhibit "B". A copy of the reported decision from New Jersey Jury Verdict is attached for your perusal). Mr. Haffy appealed the dismissal, which was affirmed by the Appellate Division. The Supreme Court also denied certification.

Our firm also won a defense verdict in <u>Arnone v. Babyland Family Services</u>, which involved a whistleblower claim brought by Babyland's former comptroller. Notably, the jury flatly rejected Mr. Arnone's claims after deliberating for only fourteen minutes.

Further, this firm won a defense verdict recently in <u>Kabigting v. Hackensack</u> <u>University Medical Center</u>. After deliberating for forty minutes, the jury found that the plaintiff was not discriminated against because of his race or national origin.

Additionally, this firm recently won a major trial victory in a case that alleged violations of the Law Against Discrimination and retaliation in violation of the First Amendment. In Bennett et. al. v. City of Atlantic City, thirteen firefighters alleged that they were subjected to racial discrimination and a racially hostile working environment based on

a number of racial slurs made by co-workers and superiors over the years of their employment with the City. In addition, the plaintiffs had alleged that they were retaliated against for reporting racially discriminatory conduct. After four weeks of trial, the jury returned a verdict overwhelmingly in favor of the City.

Once a resolution is adopted I will make arrangements to remove the existing equipment and cars through the process.



SPECIAL EMERGENCY APPROPRIATION

WHEREAS, the total amount of emergency appropriation created including the appropriation to be created by this resolution is \$874,000.00 and three percent of the total operations in the budget for the year 2008 was \$962,569.00.

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Willingboro, assembled in public session this 14th day of October, 2008, that in accordance with N.J.S.A. 40A:4-48 and 40A:4-53:

- 1. A special emergency appropriation be and the same is hereby made for the preparation and execution of a complete program of revaluation of real property for the use of the local assessor in the amount of \$874,000.00.
- 2. Total amount of the contract per Ordinance No. 2008 8 is for \$874,000.00 and the Township hereby requests that an exclusion from the 5% "CAP" be granted by the Director of the Division of Local Government Services in accordance with P.L. 1981 Chapter 56 in the amount of \$174,800.00 per year in the budget of the next five succeeding years commencing with the budget of 2009 in accordance with 40A:4-55(c).
- 3. That an emergency note or notes be authorized not in excess of \$874,00.00, the amount appropriated by ordinance as stated above.
- 4. That said note or notes shall be dated as of date the notes are issued, may be renewed from time to time and at least 1/5 of all such notes and renewals thereof shall

5.	Any matter involving the purchase, lease or acquisition of real estate with public funds, the setting of banking rates or investment of public funds where it could adversely affect the public interest if discussions of such matters were disclosed.
6.	Any tactics and techniques utilized in protecting the safety and property of the public and any investigations of violations or possible violations of law.
7.	Any pending or anticipated litigation or contract negotiations in which Township Council is or may become a party.
8.	Any matters falling within the attorney/client privilege to the extent that confidentiality is required for the attorney to exercise his/her ethical duties as a lawyer.

9.	Any matter involving the employment, appointment, termination of employment, terms and conditions of employment and other categories set forth in N.J.S.A. 10:4-12b(8).
10.	Any deliberations occurring after a public hearing that may result in the imposition of specific civil penalty or the suspension of loss of a license or permit as set forth in N.J.S.A. 10:9-12b(9).
