**RESOLUTION AUTHORIZING THE TOWNSHIP OF WILLINGBORO TO ENTER INTO AN AGREEMENT WITH DELL INC., A CONTRACTED PARTICIPANT IN THE NJ STATE APPROVED PURCHASING COOPERATIVE CONTRACT M0483, PURCHASE ORDER NUMBER: 19-TELE-00656, FOR MONTHLY SOFTWARE COSTS**

**WHEREAS**, the Township of Willingboro is a member in good standing with the **NJ State Approved Cooperative Purchasing System** per Willingboro Township Resolution 2021-98; and

**WHEREAS**, Dell Inc. of One Dell Way, RR8-MS41 Round Rock TX, 78682 has been awarded in the NJ State Approved Contract M0483, Purchase Order Number: 19-TELE-00656 which expires on July 31, 2022; and

**WHEREAS**, The Township of Willingboro entered into an agreement with Dell Inc, to furnish Microsoft Office 365 Software per Resolution 2020-115; and

**WHEREAS**, The Township of Willingboro wishes to pay Dell Inc, for Microsoft Office 365 Software costs incurred for the final 3 months of 2021; and

**WHEREAS**, the monthly cost is \$6,708.26, for a total payment of 20,124.78 for 3 months of software use; and

**WHEREAS**, the purchase of goods and services by local contracting units is authorized by the Local Public Contracts Law, *N.J.S.A.* 40A: 11-12a; and


