Mayor McIntosh – We can wait until Mr. Harris presentation and then we can discuss it during discussion when we go to that resolution.

Councilwoman Perrone – Okay, everything seems pretty clear so far. Thank you. I do not have any questions at this time.

Mayor McIntosh – Ok, Mr. Harris you can move onto the introduction.

Township Manager – Ok, I am going to go ahead and share my screen.

Township Manager Addresses Public Comment on Agenda Items

- For Ms. Lindsay Harvey question, as I stated I did not cover all of the departments in all of the areas. The library is included in this budget and that will be part of the total information that the governing body has. That was just a cursory overview it was not by any means complete and detailed just an explanation to how we got to where we were and where we were as far as the municipal proposed rate for 2022.
- Mr. Nock did ask a question regarding the exemptions on the report that he looked at on the website, a lot of those exemptions that he may be looking at could be veteran exemptions, I do not know what specifically he was looking at because those are not the numbers I presented. He did ask what the collection rate is in Willingboro, our collection rate is 96.7% which is exceptionally good. We will be having a conversation with our tax collector to see how we can get that up in 2022. Those half of the percent equate to big dollars.
- Someone had asked about the school tax deferral; the school tax deferral has no implication on the school's budget. They get every penny that is taxed, that is more of a benefit to the municipal side because school taxes are not paid until June 30th of the subsequent year. They work on a physical year while the municipality runs on a calendar year, so their year goes from July 1st to June 30th then we take school taxes at the end of the school year. When you are talking about appropriation, we take half of that and appropriating into nearly the taxes that's actually payable instead of putting an appropriation in full on the line item. It does not affect the school.
- Mr. McKenzie the security department is still under IT, so their money is still incorporated with IT figures. The new \$5,000 increase that they did get in their budget has no relation to IT's movement into their department although they are overseeing the functions of the security department that does not mean that they are going to have spending powers over their budgets. It was not a budgetary issue that prompted me to move over that it was more oversight and professionally efficiencies.
- Ms. Holley the trash collection is currently under contract. Once that contract expires then the township has the ability to negotiate a new contract or going to be again for the additional providers. The second cans are available if anyone wants to come in and purchase one.

Mayor McIntosh – There is an additional cost for a second trash can but no additional cost to pick up the trash can. It is \$75 and there is no other payment for collection. Mr. Taylor, am I allowed to address the \$20,000?

Solicitor - I think the question is simply is it in the budget. That is a personal matter that Mr. Harris identifies where it maybe in the budget, probably not a separate line item it is under salaries, but I prefer the end.

Township Manager – It is in the budget under salary and wages for Clerk's Department.

Mayor McIntosh – Can we explain what was done? Also, the comment was under the cloak of darkness, and I just wanted to make sure that is cleared up that it was not done under the cloak of darkness.

Solicitor – Sure Mayor, pursuing to the public means the council did pass the appropriate resolution to go into closing executive session and to discuss matters and personnel at the last council meeting in furtherance of that resolution council did indicate that action would be taken or maybe taken into public session so the action that was taken and the subjects discussed were appropriate under law.

Mayor McIntosh - I also wanted to circle back on Ms. Lindsay – Harvey's question about the library not being in the budget, we are going to breakdown the budget by departments, so we are going to have special meetings throughout this month and starting today we did the introduction to the budget.

Township Manager – Mayor, I am also going to create detailed budget books for council which you will have all of the numbers, department requests and all of their intended spending. They are being prepared.

Council Comment on Public Comment –

Deputy Mayor Whitfield – Mr. Harris can you reiterate the comment about inspections official, you stated it, but a question did come up?

Township Manager – The services that the one gentleman provided is a band-aid service. There was a need that needed to be met. I do not think it is a good idea to have all of those elements sitting with one individual. We are looking for employees who are ready, willing, and able to obtain the additional certifications and we will support them in that process.

Councilwoman Perrone - Based off the presentation and Mr. Harris statement, I will wait for my questions when he finalizes the budget with itemized details.

Discussion –

Councilwoman Worthy – What contributes to individuals not being able to pass the civil service exam versus just waiving the requirement altogether? From what I read, it has been lack of access to study materials, it has been lack of preparation due to not understanding the point of the exam, rigorous nature of the exam.

Deputy Mayor Whitfield – How many times a year are the civil service exams offered?

Township Manager – The civil service is administered by the Civil Service Agency. I do not know that there is a required or specific number of times. Civil Service communities are the ones bound to the list.

Councilwoman Perrone – I think it is important we create and keep standards, I would not like to see that eliminated from the process of becoming a police officer, they are there to protect our people, it just lowers our standards as far as Willingboro's concern.

Councilman Anderson – I would not like to see the civil service portion removed especially when it comes to our own community here, I don't want to settle for less I want us to have the best of the best and I think it's another tool to allow us to see where they ranked and where they fell in place at.

Captain Bucs – The civil service test is given every two year. This amendment is not to get rid of the civil service exam, we would still be a civil service town, we would still use the civil service list to hire our officers. This would just give us another option to hire outside of the civil service list. An example would be where a person works for another municipality, they live in town, and they want to work for Willingboro. One of the processes that has to happen is called an inner governmental transfer so both agencies have to agree to allow... we would have to agree to accept that person from the agency that officer would come from, and we would have to agree to let that officer come to us. This would give us another option if a resident is interested, and they are not on the civil service list.

Deputy Mayor Whitfield – Captain Bucs is there a possibility or opportunity to maintain the requirement for the civil service exam but maybe allow it later in the process so if someone has put themselves through the police academy and maybe they didn't send their scores to Willingboro and they're not on our list, is it possible that they can send it to us at a later date or take the exam and the hiring be contingent upon their passing of the exam?

Captain Bucs – They would not be able to get on our list. They would not be able to take the exam two years from now. We give the test every two years.

Councilwoman Perrone – But everyone takes the exam, everyone has taken the exam at some different place?

Captain Bucs – It depends.

Councilwoman Perrone – If you hire these individuals to be officers here outside of them taking the civil service exam, will they still be employed and paid as a civil service employee?

Captain Bucs – Correct.

Councilman Anderson – Out of the additional municipalities that you just referenced, are any of them accredited such as we?

Captain Bucs – I do not know.

Deputy Mayor Whitfield – I agree with Councilman Anderson, how would this affect our accreditation?

Captain Bucs – It wouldn't affect our accreditation at all.

Councilwoman Perrone - I know it says Police Department, but we do require other civil service exams for other types of positions in the township is this also like the coupled with underneath other positions or is this only for police officers?
