Mayor McIntosh – Mr. Harris, are you aware of any ordinance concerning the golf course?

Township Manager – No I have not seen any ordinance regarding the golf course, the liquor licenses are something that are issued or not, it is not something we just put forward in advance for buildings and facilities then issue them a liquor license, there's an explicit application process, there's a vein that applicants need to go through with the state for police with financial records that goes into play before a liquor license will be issued. A consumption license is being offered in Willingboro.

Solicitor (Mr. Taylor) – I will be happy to look back at historical records to see if there's an Ordinance for this. I will work with Mr. Harris to verify if there was a liquor license if so, is it still in effect.

Councilman Anderson – To the best of my recollection, we did not officially offer a liquor license, we examined the Ordinance to see what we needed to do to expand and create an opportunity. With doing so, I believe the Ordinance stated it needs to be at least 125 seats. The question came up does it have to be a physical brick or mortar, or can it be the temporary tent they put up. If the temporary tent seated 125 then it would allow them to come to us and apply. That was some of the conversations Mike Armstrong (former solicitor) was the solicitor.

Township Clerk – I have those documents, Mayor.

Township Manager addresses public comments

- In regard to Ms. Dilworth question about Bag Up NJ month, she is correct that is a State Legislation and that will go into effect tomorrow. • I would like to address the fact that the clerk no longer wants to do the tally of elections on Election night. We have historically done that for the entire length of Willingboro's existence. Willingboro is the strongest vote block in the county, it's the bell weather, it's the lynchpin of how elections turn in the county whether if they will be Republican or Democrat. It usually depends on Willingboro's vote. If we only rely on the counties tally that's going to be coming in at 2,3,4 in the morning. It's way later than our tally is locally. It's the one

indication for whether or not certain candidates win or not whether at the county level, legislative district seven level, congressional district three level or electoral level. It's a very crucial piece of information. I don't believe it would cost that much overtime. It only takes one or two clerks' members to be working there, it's a part of their duty, it's one of the most important duties that the clerk conducts throughout the entire year. Them realizing that our turn out is low or high or mediocre we only know that when we get the tallies and that we have the most voting districts of any town in the county. - Speaking in my role and chair of Willingboro Advisory Board, regarding a change in board membership Corvena Francis-Denton has been unable to attend the meetings due to her school board obligations. She has made herself available to me in between meetings for when she is not able to attend regular scheduled meetings. That is why she stepped back.
- Thank you, Councilman Anderson, for reappointing Dr. Cleophus Robinson. His tenure on the board gives historical content. He's been there since the beginning, and he asks great questions, and he inspires us with his implications and benedictions so thank you very much for adding him to the board.
- I want to specifically thank the Mayor, Town Clerk, Council Attorney, Town Manager, and all members for the attention you're paying for following proper protocols for the procedure. I want to note an exception in the world of elected officials, you show tremendous humility when something needs to be corrected. I don't hear defensiveness; I don't hear attacks. By you humbly asking questions and by you humbly working through corrections, I'm learning how to be a better board chair. I would also like to thank and acknowledge Vice Chair Carol Ramsey who is coaching me on parliamentary procedures during the meetings. Thank you so much for your leadership.

Martin Nock Windsor Lane

- We lose a lot of historical and institutional knowledge. Willingboro is a dry town and we had to get together, pass a referendum, and get signatures and the first time it failed to allow liquor in the community. We had to wait four years, I went out there and got a referendum passed with the specific language that the golf course would get one. I am for the golf course having liquor license, but you have to follow the referendum. I don't know the new ounces of language whether consumption is a regular license or not. When I was Mayor, I met with the other ownership, and we talked about having enough chairs and seats inside the area and club. We tried using a tent to make a quarter of 150 or 180 seats that you have to have. That is the referendum that was passed. Now the consumption of liquor license beat the fine because I wanted to change it down to 100 or even 75 people because nobody is doing a 150-seat situation as a restaurant. That's the background in it. I was one of the people trying to convince people to petition. I was aware of restaurants and a lot of value that comes in that.
- In regard to elections, Willingboro is always the last to turn in those numbers to see who has won or loss. You can't sit there and wait two hours for numbers to come in, sometimes the numbers come in after 12am. When Andy Kim first won, the numbers in Willingboro were well after 12 o'clock. If you want to keep it locally, their must be some kind of way that we need to be able to keep it locally but make sure those numbers get to the county to be dropped into the totals to see who has won and who has loss. I just wanted to put out there that's why it's done. I appreciate Mr. Montgomery for buying the golf course, putting it together and making the benefit resolve.

We have to follow the way the referendum is. There's a lot more into the election night process than one thing. Evesham is double our size, they have 55,000 residents and they still get their total votes in before us. I am willing to speak with anyone, I am the current Democratic chair.

- I would like to thank the Council, Township Manager, and all of the departments, I've noticed improvement in the paper, the debrief along the main roads in Willingboro. He told me he was fine, I noticed security come outside to help him up the steps. I thought that was very nice. Then I went towards the police department, and I noticed there was a man on his knees with a cane in his hand trying to get up. I did a reroute to turn back around to try to get him help. Public Comment Closed

Township Manager addresses Public Comments

Most of the comments were commentary and about the Clerk's decision to no longer do manual
counting of the votes. I will not fight Ms. Bligen's battle, and I respect her decision which really
came about after the state kind of went to the digital machines where the results cartridges were
computerized, and those results were transmitted to the county who tabulated the votes. Which

are the official counts in a municipality kind of rendering Mrs. Bligen's task tallying locally kind of made it redundant. Since the state has re-transitioned, their equipment the reports and things that the clerk received out of those machines are complicated and difficult to decipher and they're extensive. Now you get reports that say undervotes, mis votes, neglected tallies and retallies. I would encourage everyone to do their due diligence and really understand that elections today are not the same as elections were 50 years ago.

- Regarding Ms. Beuluh Williams and her reference to bonds, I do not know what she is referring to. (*Mayor McIntosh I will have Deputy Mayor speak on that.)
- There was also a reference to the Mill Creek Bridge, I'm unfamiliar with it.
- Mr. Youngkin talked about the consumption license, I would encourage him to read and review his application to apply to the state. There may have been a referendum. As far I understand, the Township has not issued any liquor licenses. Based on the population in Willingboro, you would be eligible to issue ten consumption licenses which is going on for every 3,000 residents and you could probably do four distribution licenses, but I don't know that you have gone ahead and officially taken the steps to do so. I would encourage him again to revisit his application, so he is very clear.
- Ms. Dilworth mentioned trash in front of Acme, yes Acme and that shopping plaza has made some improvement with cleaning up. The Town Center from Rita's Ice down to the Pending Snapback building is under new ownership. They had some difficulty securing their landscaping contracts. Supposedly, that resolution has been resolved. You will start to see a little more diligence and clean up those locations. I believe in giving credit when credit is due. I would like to thank our township as well as residents for all that they do to keep our community clean.
- Ms. Mack, thank you for acknowledging the atmosphere here at the Municipal Complex. There is a new air that is flowing through this building that people experience in here. It's beginning to reflect outside in the service they are providing. I will again look at the doors you have been referring to. If the next time you're in the building and you want to meet with me, I will be more than happy to visit those different locations to see what you're referring to. There are only two parking spots for Handicap in the back of our building. More often than not they are full, which defaults for our needy residents who utilize the spaces in the front and across the street.

Mayor McIntosh – Ms. Mack is referring to the handicap panel. When you push the button, it does not open. Security did indicate that those parts were being ordered and that it was still being addressed. It has been a couple of weeks since the Handicap button has worked for the door. Deputy Mayor did you want to address the bonds?

Deputy Mayor Whitfield – Yes, Ms. Williams thank you for following up on that. This was an idea that I had that was brought up as a possibility in 2020. We were looking for ways to finance some different projects. In exploring that, I will say that it kind of fell to a dead end. We had some challenges in forming the program as well as understanding the administrative workload that would be required to administer the program. We have a bit of a pushback from some of our professionals on the feasibility of that project. It's not off the table but it definitely will take a bit more understanding to how it has worked in other municipalities and working with our professionals that would be supportive. For the Creek Road Bridge, that issue was at the county level, you can ask any questions on future plans for the bridge at the next Board of Commissioners meeting. That will take place on May 11th at 7pm. You can find more information on their meeting schedule on the county website.

Mayor McIntosh – Yes, that's a county bridge. As a council and council administration of township we understand the importance of that bridge to some people when it comes to different stores and services. For Willingboro, we are trying to make sure we do Economic Development here. In the

case that, that bridge does not open we have access in our town to the things that we're trying to drive to, to spend our hard-earned money across the bridge. We don't have control of that bridge. Ms. Bligen can you give insight, someone mentioned we are the last to get votes? Can you give explanation as to why that may be?

Township Clerk – The tallying, we have nothing to do with being the last or the first ones to have those turned in. The Superintendent of Elections Day those poll workers who they send to collect those documents all of that depends on them. Willingboro's Clerk Office has nothing to do with when those votes get to the county. That is one of the reason's I felt like the tally that we were doing it means nothing, because it just goes in our file cabinet. They're not sent to the county, they don't use them for anything, its just the matter of the people sitting in the room they know unofficially who is in the lead or counts they have. What we do here, goes nowhere. Those bags that are brought back here, the county sent two people to get those bags. They take those bags from here, which has the mechanical piece with the votes in it, and that's when the county does the counting. The only thing I get out of that bag is an envelope with a ticket in it already from the machine. Everything else is done by the county. Poll workers come in, they give the bag to the people the county selected, those people bag those items up, they take them to the county and when the county gets them that's when the count starts. So, when they leave here, that's why they are done at 2, 3 o'clock in the morning.

Mayor McIntosh – just for clarification, whether you tally or don't tally it has nothing to do with the time the county would get it or whenever they tally the vote from Willingboro?

Township Clerk – No.

Mayor McIntosh – Ms. Williams thank you for mentioning the WMUA, a representative typically the way the WMUA operates outside of council, independent of council. However, we do have a representative that comes quarterly. Mr. Diggs who was the Acting Director prior to Mr. Mackee. They are about due to make an appearance. The WMUA is working really hard trying to rectify any violations. Our legislators Mr. Singleton, Andy Kim, Senator Booker, we've been reaching out to them collaborating and partnering with them. There's a lot of movement to make sure that our water system is secure and safe. The WMUA does have their monthly meetings the third Wednesday of the month. If you have any further questions, please attend their meetings.
