• Mr. Harris, you indicated there's a maximum of \$5,000, is this moving forward? You guys have the Clerk a \$20,000 stipend, I described it as a raise, and I was corrected by council that it was a stipend. I see \$5,000 indicated is the max but two or three weeks ago it was a \$20,000 stipend given to one employee. I believe one year; the \$10,000 stipend is given and then another year the additional \$10,000 stipend is given. Making that a total of \$20,000 a stipend over a period of two years. At that time, I indicated we have teacher assistance in the school district only making \$18,000 for one whole year. So, \$20,000 stipend is a bit much. Could you explain the discrepancy there? \$5,000 vs \$10,000 for the \$20,000.

Township Manager address Public Comment

- The governing body has a lot of discretion in establishing those salaries based on their will. As the Township Manager, I have a lot of latitude in the salaries that are given to my subordinances, depart directors' employees, and some of my predecessors may not have used that authority discriminatively as far as stipends are concerned, to persons that I have direct control over. This is putting structure in place and controls in place that will be happening in the future.
- **Councilwoman Perrone** With regards to titles, that some of the titles were changed, amended, or adjusted, however those hired there will have that new title? Is that right?
- **Township Manager** Yes.
- Mayor McIntosh Ms. Holley to address your question, majority of council not everyone did vote on applying a stipend to a person that we felt all of their acting they are filling some requirements for that job. They are doing their job. I thought it was acceptable to apply a stipend and I stand behind that decision. Majority of council did vote in that direction, and some did not. I do want to address it was \$10,000 that started this year.

Council Questions or Concerns for Township Clerk –

Councilwoman Worthy – If it's the will of the body, on the professional's slide is it possible to show us the numbers of how much money is remaining in the pool so we can make sure that we're mindful of how we're spending?

Mayor McIntosh – I think that's helpful for us to determine how we move forward or anticipate the end of the year cost. I think it would be helpful if the clerk can provide that data point.

Township Manager – I will provide that information to you in my more comprehensive report in the second meeting. I did submit some of that information in my prior's month report. I will make sure you have that comprehensive information from the CFO moving forward. It will be a monthly thing in my comprehensive report.

Township Clerk – Are you talking about for planning board and zoning board or in general?

Councilwoman Worthy – Council just wants a window into where we are.

Township Manager – You'll get a look into my comprehensive report every month.

UNFINISHED BUSINESS

Mayor McIntosh – Mr. Harris I did want to bring up the realtor conversation per Councilman Anderson. I just want some feedback from that meeting.

Township Manager – Last month, there was a second pile up meeting with the realtors in the Township and our Tax Assessor. It was attended by the Burlington Tax Administrator as well. They did confirm that Willingboro does added assessments like every other municipality in Burlington county. The Tax Administrator of Burlington was impressed with the way we handle added assessments. She has talked about making that the standard for the rest of the municipalities. She has been talking with our Tax Assessor to get what he does to imitate that to their level. The realtors were informed that the assessment request was not mandatory. That was something that was optional on their part. It was revised that once it was requested then the assessor was obligated to perform that review. It was not mandatory it was optional. The tax assessor office that handles those reviews, the submission of all of those documentations is optional with the understanding that the more information you provide, the more accurate the assessment would be. The takeaway was that they offer and brought copies of the abatement application. The meeting was held on May 20, 2022.

NEW BUSINESS

Councilwoman Perrone – I'm asking for your permission, for council to authorize the financial audit that's conducted by the state. I feel we need to do a more detailed audit of our finances and authorize the state to conduct the audit.

Solicitor – I don't know if the state performs or does audits for municipalities upon request. The audit function is left to the authority and discretion of local municipality. I wouldn't imply the term forensic not to imply criminal allegations, but I would use a different term. I don't know perhaps if the state can do that. Councilwoman Perrone you would have to discuss this matter with Mr. Harris and Mayor McIntosh. Mr. Harris do you have anything you want to add?

Township Manager – What you're saying is absolutely correct. Based on my experience, the municipality directs us to hire auditors and we haven't even completed our 2021 audit. We just adopted our budget a few weeks ago. Forensic audits are done if there is relative belief that there is some type of criminal activity going on. They are usually geared toward specific items, to complete a general broad audit would be expensive.

Solicitor – If you're basing your motion off the ladder of what Mr. Harris recommends, I would ask the council to close executive session to further explore and review. You can get some more context if that is what you're asking for.

Councilwoman Perrone – Yes, that's exactly what I'm asking for as far as for any criminal activity. I'm asking for council to vote on it and Mr. Harris can go to the drawing board as far as expenses. That is the nature of my question and concern.

Solicitor – You would need to identify which accounting firm or auditing firm is going to do the audit . You would need to as a council give the administration direction as to what the not to exceed dollar amount would be.

Mayor McIntosh – Councilwoman Perrone this has been voted on by council last year. We did it twice but there was no response back.

Deputy Mayor Whitfield – Yes and we also did appropriate some funds in councils' budget for the 2022 year forensic audit. We just have not decided on those particular areas that we would like for them to look into. I think that's something we can talk about in executive session.

Solicitor – I would recommend any further dialogue be saved for closed executive session.

Mayor McIntosh – I would like to nominate and welcome Titus Welcome to the Municipal Alliance.

- I'm not sure I clearly understood the \$10,000 stipend that was given to the Acting Clerk. Was this a one time \$10,000 or two times \$10,000? Was this done instead of a \$20,000 raise? I'm just trying to separate the difference between the stipend and the raise.
- I'm concerned about the working hours for the Acting Clerk. On May 9th, when I went to pay my taxes, it was after 3 o'clock and I asked to speak to her, I was told that she was gone for the day. On May 18th, I went to the Municipal Office, and I asked to speak to the Acting Clerk, and I was told that she was gone for the day. The young lady proceeded to call her and came back asking what is it that I wanted. On the 19th of May, I emailed the Mayor regarding this issue, and I did not receive a reply. On the 27th of May, I sent a second email to the Mayor and have not received a reply on this issue. So, I'm concerned that on two occasions, when I went to speak to the Acting Clerk she was gone for the day. This is a great concern not just for me but for all of us that pay our taxes. We have these allegedly \$20,000 raises we can't even get our trash collected properly. We can't put out extra, we're going to be charged for a second trash can and it's terrible. I've lived in this town for 50 years and I've seen a lot of things happen that go on in this town that are not acceptable.
- There was a discussion about the street sweeper, still nothing has been done, I travel on Charleston Road and Levitt there's trash all along the side. The drains are covered with debris. There's a lot of things we need to take a look at.

Solicitor – I would just advise the council to be cautious in responding to that answer since it pertains personnel. Everyone is entitled to paid days, personal and sick leave. That question has been asked and answered several times regarding the stipend.

Aaron Mitchell 28 Bradley Place

- Regards to Zoning Ordinance 37 -75, that's driveway specifically section K, the question and concern I have with that particular Ordinance. It says a driveway can't be an 8 by 5 area, it has to be next to the garage side of the house and a fence shall be erected from blocking your neighbors to seeing that driveway path. My main concern about this particular Ordinance says that, "Path cannot over exceed the front or rear residential structure where it is located." My question is, in regard to that, how will a person partake a trailer if it doesn't exceed the front of that residential structure as far as connecting it to a driveway or something like that? The other consideration, for scripting a resident to a foot wide pad, that might be troublesome depending on the size of the trailer.
- Home based businesses, such as in the service industry have vans or display business information. I think it would be a good idea to have permits to have some of these businesses park their

vehicle in their driveway. It doesn't make sense as to why residents who have businesses can't park their cars on the street or in their driveway. This is something to consider that's not detrimental to the township. It would also support the residents.

Mayor McIntosh -

• Ms. Mallory if you check your email on 5/26 and today, I did send two emails to you to follow up and answer your question. I did indicate the acting clerk's hours and I did indicate if you did experience any unsatisfactory service from the Clerk's office. The hours are 9-5, as long as the office is adequately staffed. Township Clerk does have to work after hours, before hours and weekends. If you have trouble or you are not getting all of your needs met, then you can contact us. Our Clerk's office is adequately staffed 9-5 Monday through Friday.

Township Manager continues

- Mr. Mitchell, I do know we have some issues regarding zoning. I can't really speak to them; I
 would advise you go and speak to the zoning officer and answer all of your questions or provide
 clarification.
- I don't know if it is a problem of someone with a home-based business parking in their driving with a decal. As long as it meets specific requirements.
