

**TOWNSHIP OF WILLINGBORO  
RESOLUTION 2022 – 75**

**A RESOLUTION APPROVING THE ISSUANCE OF A SPECIAL PERMIT FOR A  
GOLF FACILITY BY THE DIVISION OF ALCOHOLIC BEVERAGE  
CONTROL TO THE RANCOCAS GOLF CLUB**

WHEREAS the Rancocas Golf Club has applied to the ABC for the issuance of a Special Permit for a Golf Facility to be used on their premise located at 12 Club Ridge Lane in Willingboro Township; and,

WHEREAS under N.J.A.C.-13:2-5.3, The Division of Alcoholic Beverage Control (“ABC”) has adopted a rule which would provide for the issuance of a Special Permit for a Golf Facility; and,

WHEREAS a Special Permit for a Golf Facility authorizes permitted golf facilities to sell open containers of alcoholic beverages for immediate consumption to members, guests of members, and guests of the facility and during a social gathering only if such social gathering is directly related to playing golf on the golf course the same day; and

WHEREAS this permit specifically does not authorize the service of alcoholic beverages at non-golf-related social gatherings, such as holiday parties, weddings, birthday parties, or family religious events; and,

WHEREAS the Rancocas Golf Club has completed the application process for a special permit as outlined under N.J.A.C.-13:2-5.3, and all applicants have met the qualifications to hold an alcoholic beverage license as provided in the Alcoholic Beverage Control Act, 33:1-1 et seq.

NOW, THEREFORE, BE IT RESOLVED, by the Governing Body of the Township of Willingboro, County of Burlington, New Jersey that Governing Body has no objection to the Director of the Division of Alcoholic Beverage Control issuing a Special Permit for a Golf Facility to the Rancocas Golf Club to be used on their premise located at 12 Club Ridge Lane in Willingboro Township.

BE IT FURTHER RESOLVED the Clerk of the Township of Willingboro, County of Burlington is hereby directed to forward a certified copy of this Resolution to the Director of the Division of Alcoholic Beverage Control.
