

**TOWNSHIP OF WILLINGBORO
RESOLUTION 2022 – 101**

**AWARDING CONTRACT TO THINK PAVERS HARDSCAPING LLC FOR
PENNYPACKER DRIVE, PHASE II**

WHEREAS Willingboro Township undertook the construction of a public improvement within the Municipality, commonly referred to as the Penny Packer Drive, Phase I; and,

WHEREAS Willingboro Township desires to continue with the construction of a public improvement within the Municipality, commonly referred to as the Penny Packer Drive, Phase II; and,

WHEREAS the anticipated term of this contract is for one year but may be extended upon the approval of the governing body; and,

WHEREAS the aggregate costs are anticipated to exceed the Township’s bid threshold, which requires the contract, as outlined in N.J.S.A. 40A: 11-4a, to be awarded by resolution of the Governing Body to the lowest responsible bidder after public advertising for bids and bidding, therefore; and,

WHEREAS bids were advertised and later opened on June 10, 2022, for the Penny Packer Drive, Phase II; and,

WHEREAS four bids were received and opened, with the lowest three bids being.


WHEREAS the Qualified Purchasing Agent, Township Manager, Township Engineer, and Township Attorney have reviewed the bids and find that the three lowest bidders meet the specifications, that the bidder[s] are responsible and responsive, and recommend the contract be awarded to Think Pavers Hardscaping, L.L.C.; and,

WHEREAS, Eusebia Diggs, Chief Financial Officer for Willingboro Township, has certified that free and unencumbered funds in the amount of \$179,164.00 are available for this purpose in accordance with N.J.A.C. 5:34-5.1 et seq. as is indicated by the attached certification for the availability of 2022 funds for this contract.


NOW, THEREFORE, BE IT RESOLVED, by the Township Council of Willingboro Township, in the County of Burlington, State of New Jersey, that the Mayor and Acting Township Clerk are authorized and directed to enter into an agreement with Think Pavers Hardscaping, L.L.C. for the Penny Packer Drive, Phase II Project, in an amount not to exceed \$179,164.00.
