**RESOLUTION AUTHORIZING CONTRACT WITH CERTAIN APPROVED STATE
CONTRACT VENDOR FOR FENCING AT COUNTRY CLUB AND PENNYPACKER POOLS
PURSUANT TO N.J.S.A. 40A:11-12a**

WHEREAS, Willingboro Township, pursuant to N.J.S.A. N.J.A.C. 40A:11-12a and 5:34-7.29(c), may by resolution and without advertising for bids, purchase any goods or services under the State of New Jersey Cooperative Purchasing Program for any State contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury; and

WHEREAS, Willingboro Township has the need to purchase goods or services utilizing State contracts for the installation of chain link fencing at the Country Club and Pennypacker pools; and

WHEREAS, Willingboro Township intends to enter into a contract with State contract vendor Consolidated Steel & Aluminum Fence CO., Inc. under State Contract number A88680/T0640 through this resolution and properly executed/issued purchase order contracts, which shall be subject to all the conditions applicable to the current State contracts;

WHEREAS it is in the best interest of the Township to award a contract to Consolidated Steel & Aluminum Fence CO., Inc. to provide the services delineated in the proposal dated April 1, 2022, and wishes to give its approval to the award of the contract; and

WHEREAS the amount for Consolidated Steel & Aluminum Fence CO., Inc. will not exceed \$52,560.00; and,

WHEREAS, Eusebia Diggs, Chief Financial Officer for Willingboro Township, has certified that free and unencumbered funds in the amount of \$52,560.00 are available for this purpose in accordance with N.J.A.C. 5:34-5.1 et seq. as is indicated by the attached certification for the availability of 2022 funds for this contract.

WHEREAS the duration of the contracts between Willingboro Township and the Referenced State Contract Vendor shall be through December 31, 2022.
