

**TOWNSHIP OF WILLINGBORO
RESOLUTION 2022 – 142**

RESOLUTION AMENDING RESOLUTION 2022-103 AUTHORIZING THE TOWNSHIP OF WILLINGBORO TO ENTER A CONTRACT WITH NEW JERSEY ANIMAL CONTROL, LLC FOR THE PROVISION OF ANIMAL CONTROL SERVICES TO THE TOWNSHIP OF WILLINGBORO.

WHEREAS the Township of Willingboro approved Resolution 2022-103 for the provision of Animal Control Services as a non-fair and open contract which neglected to include specific Pay-to Play language pursuant to N.J.S.A. 19:44A-20.4 or 20.5; and,

WHEREAS The Township of Willingboro wishes to enter into a contract with New Jersey Animal Control, L.L.C., 617 Stokes Road, Suite 4 - Box #302, Medford, NJ 08055, with a maximum contract value of \$25,000 for the provision of Animal Control Services; and

WHEREAS the purchase of goods and services by local contracting units is authorized by the Local Public Contracts Law, N.J.S.A.40A: 11-6.1a; and


WHEREAS the purchasing agent recommends award of this contract because after the solicitation of quotes by the Public Safety Director for Animal Control Services, New Jersey Animal Control is best suited to meet the Township’s needs; and


WHEREAS New Jersey Animal Control, L.L.C. has completed and submitted a Business Entity Disclosure Certification which certifies that New Jersey Animal Control, L.L.C. has not made any reportable contributions to a political or candidate committee in the Township of Willingboro in the previous year and that the contract will prohibit the New Jersey Animal Control, L.L.C. from making any reportable contributions through the term of the contract, and

WHEREAS funds are available for this purpose in the 2022 General Budget account: Staff services contractual line #2-01-25-240-240-132 as indicated by the attached Treasurer’s Certification

NOW, THEREFORE, BE IT RESOLVED by the Township Council of the Township of Willingboro, County of Burlington, State of New Jersey, on this 6th day of September 2022, in an open public session that the Township Council authorizes Resolution 2022-103 to be amended to include the required Pay-to-Play language consistent with this resolution.
