**A RESOLUTION AWARDING BID FOR REPAIR OF THE BUCKINGHAM DRIVE CULVERT  
FAILURE REPAIR PROJECT**

**WHEREAS** Willingboro Township has the need to undertake public improvement within the Municipality, commonly referred to as the Buckingham Culvert Repair Project; and,

**WHEREAS** the aggregate costs are anticipated to exceed the Township’s bid threshold, which requires the contract, as outlined in N.J.S.A. 40A: 11-4a, to be awarded by resolution of the Governing Body to the lowest responsible bidder after public advertising for bids and bidding, therefore; and,

**WHEREAS** bids were advertised and later opened on August 9, 2022, for the Buckingham Culvert Repair Project; and

**WHEREAS** eight (8) bids were received and opened, with the lowest bid being.

Think Pavers Hardscaping, L.L.C.            \$120,796.00

; and

**WHEREAS**, the Township Engineer and Director of Public Works have recommended acceptance of the bid received from Think Pavers Hardscaping, L.L.C. in the amount of \$120,796.00 to perform work as specified; and

**WHEREAS** Think Pavers Hardscaping L.L.C. is qualified to perform the required services, to execute the project, and the award of the contract to Think Pavers Hardscaping L.L.C. is advantageous to the Township and has been recommended by the Township Engineer; and

**WHEREAS**, Eusebia Diggs, Chief Financial Officer for Willingboro Township, has certified that free and unencumbered funds in the amount of \$120,796.00 are available for this purpose in accordance with N.J.A.C. 5:34-5.1 et seq. as is indicated by the attached certification for the availability of 2022 funds for this contract.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Willingboro assembled in public session on this 6th day of September 2022 that a contract is awarded to Think Pavers Hardscaping L.L.C. for the repair to the Buckingham Lane Culvert, and the Mayor and Municipal Clerk are authorized to execute and deliver this contract on behalf of the Township of Willingboro.
