PLEASE TAKE NOTICE that the Township Council of the Township of Willingboro has determined by Resolution No. 2023 - 210 to issue one (1) new Plenary Retail Consumption Liquor License. This license may only be issued under to an Applicant for the operation of a full-service restaurant located in the Township's B-1 Zoning District located in the Town Center. Any plenary retail consumption liquor license, upon issuance, shall only be valid for use in a full-service restaurant and shall not be transferred to any other use other than within the Township's B-1 Zoning District located in the Town Center. Any liquor license issued shall contain a condition that it may not be utilized for the sale of package goods anywhere in the Township of Willingboro. Minimum bid price shall be set at \$15,000.00. Proposals may be submitted after final publication on September 25, 2023. Applicants for such license shall submit a fully-completed Application/Proposal and Response to the Request for Proposals (available from the Township Purchasing Agent) in triplicate, plus one copy, which may be obtained from the Township Clerk, together with checks in the amount of \$200.00 made payable to the Division of Alcoholic Beverage Control; \$2,500.00 made payable to the Township of Willingboro; and a good faith deposit check in the amount \$5,000.00 made payable to Township of Willingboro as required in accordance with the Proposal, and shall thereafter also deliver any and all information as may be requested by the Township Council and/or the Township Police Department. Applicants shall also comply with all other requirements of N.J.A.C. 13:2-2.1, et seq., including publication of notice of application. Applications/Proposal forms and fees shall be submitted to the Township Clerk, Willingboro Township, 1 Rev. Martin Luther, Jr. Drive, Willingboro, NJ 08046 on or before 3:00 P.M. on Wednesday, November 1, 2023. Any new license will be awarded not later than six (6) months from the date of proposals were received. The full text of the determining Resolution may be viewed in the office of the Township Clerk.
