Bid Name: pre-season prep and seasonal maintenance of our (6) baseball fields.

Bids shall be delivered in sealed envelopes and addressed to the Township of Willingboro, Purchasing Dept., 1 Rev. Dr. Martin Luther King Jr. Drive, Willingboro, NJ 08046.

Express and overnight mail shall be delivered to the Purchasing Dept., 1 Rev. Dr. Martin Luther King Jr. Drive, Willingboro, NJ 08046, no later than the time of bid opening.

**NOTE:** It is the bidder's responsibility to ensure that the bid package is delivered by the bid opening date and time. Any bid document received after the deadline will not be opened. The original paper bid will not be accepted, regardless of the method of delivery.

**Submission of Bid:** All bids must be submitted on the bid proposal forms approved and provided for by the bid specifications in order to be considered. Please have each item on checklist color tabbed and numbered in your bid packet for a more time efficient packet review.

If indicated, bid proposals must be accompanied by a check or money order, cash check, or bid bond in the amount of ten per centum (10%) of the total amount of the bid, but not in excess of twenty thousand (\$20,000) dollars and made payable to the Township of Willingboro.

Bid documents may be obtained only in person at the Office of the Township Clerk, 1 Willingboro Township, NJ (willingboronj.gov) and the Township Clerk's Office.

The Township of Willingboro does not release the project estimates or bidders' lists.
